AN ACT in relation to authorizing the commissioner of education to conduct a survey regarding instruction on the Holocaust within the state

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The commissioner of education is authorized and directed to 2 conduct a survey regarding instruction on the Holocaust within the state. Such survey shall focus on identifying which school districts subject to section eight hundred one of the education law provide instruction on the Holocaust. Such survey shall include as appropriate, 6 questions on how the district is meeting the learning standards for instruction requirements on the Holocaust pursuant to section eight 8 hundred one of the education law. Such survey shall also require an 9 attestation from each public school district superintendent that indi-10 cates instruction related to the Holocaust is provided at all appropri-

1 ate grade levels in compliance with section eight hundred one of the 2 education law.

§ 2. Findings shall include detailed results of the survey, the extent the survey data submitted was compliant with section eight hundred one of the education law, and if needed, recommendations to strengthen provisions of law if not compliant. A report of the findings of such survey shall be delivered to the governor, the temporary president of the senate, the speaker of the assembly, the minority leader of the senate and the minority leader of the assembly no later than the first of January one year following the effective date of this act.

§ 3. This act shall take effect immediately.
