AN ACT to amend the real property tax law, in relation to requiring mortgage investing institutions or their contracted vendors to be financially responsible for any interest or penalties charged as a result of an erroneous mortgage registration filed by such institution or vendor

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 953 of the real property tax law is amended by adding a new subdivision 8-b to read as follows:

8-b. Any mortgage investing institution or its contracted vendor which does not comply with the provisions of subdivision eight of this section when a mortgage investing institution or its contracted vendor files a registration of mortgage with the collecting officer for an escrow amount relative to a taxable parcel and that registration proves to be 8 erroneous, the mortgage investing institution or its contracted vendor shall be financially responsible for interest or penalties charged a 10 property owner by a taxing municipality, county, and/or delinquent tax 11 enforcement agency for non-payment or late payment of real property 12 taxes due to the erroneous registration.

13 § 2. This act shall take effect immediately.
