AN ACT to amend the election law, in relation to recurring contributions solicited by a person, political campaign, political committee, party committee, constituted committee or other entity

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

| 9  | 2. No solicitation of a contribution, whether electronically or by       |
| 10 | paper, may have as its default, a recurring contribution.                |
| 11 | 3. All solicitations for contributions as described in subdivision one   |
| 12 | of this section must state that the contribution may be cancelled by the |
| 13 | contributor at any time and the contributor will receive a full refund   |
| 14 | of the recurring contributions made which refund shall be equal to all   |
| 15 | contributions made less the initial installment of the contribution.     |
| 16 | 4. An entity as described in subdivision one of this section accepting   |
| 17 | a recurring contribution shall:  |
| 18 | a. provide the contributor with a receipt for an initial contribution    |
| 19 | and each recurrence that clearly and conspicuously discloses all materi- |
| 20 | al terms of the contribution made and recurring commitment made;         |
| 21 | b. provide the contributor with all information needed to cancel         |
| 22 | recurring contributions in each communication with the contributor with  |
| 23 | respect to the recurring contribution and any solicitation for addi-     |
