AN ACT to amend chapter 53 of the laws of 2021, enacting the aid to localities budget, in relation to repaying our Afghan allies

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. This act shall be known and may be cited as the "repaying 2 our Afghan allies act".

 3 § 2. As a result of the United States' withdrawal from Afghanistan,
 4 thousands of Afghans who bravely assisted our service members in a vari-
- 5 ety of roles, including as interpreters and guides, are now at risk of 6 death at the hands of the Taliban. This bill is intended to be a small
- 7 repayment from the people of New York of the debt our nation owes to our
- 8 Afghan allies who now need to leave their homeland and make a new home 9 in the United States.
- 10 § 3. Section 1 of chapter 53 of the laws of 2021, enacting the aid to
- 11 localities budget, is amended by repealing the items herein below set
- 12 forth in brackets and by adding to such section the other items under-
- 13 scored in this section:
- 14 SPECIALIZED SERVICES PROGRAM [2,785,196,000] 2,861,796,000
- 16 General Fund
- 17 Local Assistance Account 10000
- 18 Special Revenue Funds Federal
- 19 Federal Health and Human Services Fund
- 20 Refugee Resettlement Account 25160

For services related to refugee programs 2 including but not limited to the Cuban-Haitian and refugee resettlement program 3 4 and the Cuban-Haitian and refugee targeted 5 assistance program provided pursuant to the federal refugee assistance act of 1980 6 7 as amended.

Funds appropriated herein shall be available for aid to municipalities and for payments to the federal government for expenditures made pursuant to the social services law and the state plan for individual and family grant program under the disaster relief act of 1974.

Such funds are to be available for payment of aid heretofore accrued or hereafter to accrue to municipalities. Subject to the approval of the director of the budget, such funds shall be available to the office of temporary and disability assistance net of disallowances, refunds, reimbursements, and credits.

Notwithstanding any inconsistent provision of law, funds appropriated herein, subject to the approval of the director of the budget and in accordance with a memorandum of understanding between the office of temporary and disability assistance and any other state agency, may be transferred or suballocated to any other state agency for expenses related to refugee programs.

Notwithstanding any inconsistent provision of law, and subject to the approval of the director of the budget, the amount appropriated herein may be increased decreased through transfer or interchange with any other federal appropriation within the office of temporary and disability
