- AN ACT to amend the highway law, in relation to designating portions of the state highway system as "The Disabled American Veterans - Medal of Honor Memorial Highway", "The Medal of Honor Memorial Highway"and the "Sergeant Jonathan Gollnitz - Medal of Honor Memorial Highway"

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 343-a of the highway law, as added by chapter 293 of the laws of 1996, is amended to read as follows:

3 § 343-a. Portion of state highway system to be designated as ["The 4 Disabled American Veterans Memorial Highway."] "The Disabled American Veterans - Medal of Honor Memorial Highway". All that portion of United 5 б States route twenty beginning at the community of Irving, where route 7 five and route twenty merge with Old Lake Shore road, and continuing 8 northeasterly until approximately one mile south of the town of Depew, Erie county, then continuing easterly across New York state to its 9 terminus at the New York-Massachusetts border approximately two miles 10 11 east of the town of New Lebanon, Columbia county shall be designated and known as ["The Disabled American Veterans Memorial Highway."] "The Disa-12 13 bled American Veterans - Medal of Honor Memorial Highway".

14 § 2. The highway law is amended by adding a new section 344-n to read 15 as follows:

Section 344-h of the highway law, as added by chapter 285 of the 7 laws of 2018, is amended to read as follows: 8 § 344-h. Portion of the state highway system to be designated as the 9 "Sergeant Jonathan Gollnitz - Medal of Honor Memorial Highway". All that 10 portion of the state highway system constituting state route twenty in 11 the village of Fredonia, county of Chautauqua, shall be designated and 12 known as the "Sergeant Jonathan Gollnitz - Medal of Honor Memorial High-13 way". 14 § 4. The commissioner of transportation shall provide for the instal-15 lation and maintenance of adequate signing of the state highway system as designated pursuant to sections one, two and three of this act. 16 17 However, to avoid confusion and to limit any possible disruption of commerce, the designation called for pursuant to sections one, two and 18 three of this act shall be one of ceremonial nature and the official 19 20 name of such highway shall not be changed as a result of this act. 21 § 5. This act shall take effect on the sixtieth day after it shall 22 have become a law.
