AN ACT to amend the mental hygiene law, in relation to establishing a peer support program for veterans

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The mental hygiene law is amended by adding a new section 7.42 to read as follows:

§ 7.42 Peer support program for veterans.

(a) For the purpose of this section the term "peer support services" shall mean any service designated by the office used in the treatment and recovery of mental illness, alcohol abuse, substance abuse, and/or chemical dependence that is delivered by a certified peer counselor or a veteran recognized pursuant to the provisions of this section; and the term "certified or recognized veteran peer counselor" shall mean an individual who has served in the active military or naval service of the United States and has been released from such service otherwise than by dishonorable discharge as documented by his or her discharge papers or who has been furloughed to the reserve components of the armed forces of the United States who has training, credentials or experience recognized by the office.

(b) Notwithstanding any other provision of law to the contrary, the commissioner, in conjunction with the commissioner of addiction services and supports, and the state director of the division of veterans' affairs shall develop and establish regional or county based peer support services programs for women veterans. Services provided by the recognized or certified woman veteran peer support services program shall include, but not be limited to, peer counseling techniques for mental illness including post-traumatic stress disorder, alcohol and substance abuse counseling, family support services, domestic violence, mental health, child care, physical health and legal issues.

(c) The commissioner, in conjunction with the commissioner of the office of addiction services and supports and the state director of the division of veterans' affairs shall foster programs for the training and

1 development of persons capable of providing the services set forth in
2 this section, including, but not limited to, a process of issuing,
3 either directly or through contract, credentials for recognized or
4 certified veteran peer counselors in accordance with the following:

5 1. The office shall establish minimum qualifications for recognized or
6 certified veteran peer counselors in all phases of delivery of services
7 to veterans who are evaluated and certified or recognized by the office
8 on factors including, but not be limited to, completion of approved
9 courses of study or equivalent on-the-job experience in mental health
10 counseling and/or alcoholism and substance abuse counseling or other
11 credentials established or recognized by the office; and

12 2. The office shall establish procedures for issuing, directly or
13 through contract, credentials to certified peer counselors who meet
14 minimum qualifications, and shall further establish procedures to
15 suspend, revoke, or annul such credentials for good cause.

16 § 2. This act shall take effect one year after it shall have become a
17 law. Effective immediately the addition, amendment and/or repeal of any
18 rule or regulation necessary for the implementation of this act on its
19 effective date are authorized to be made and completed on or before such
20 date.
