AN ACT to amend the executive law, in relation to the activation of 2-1-1 New York state upon declaration of a state disaster emergency

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision 1 of section 21 of the executive law, as 2 amended by chapter 116 of the laws of 2020, is amended to read as 3 follows:

1. There is hereby created in the executive department a disaster 4 5 preparedness commission consisting of the commissioners of transportation, health, division of criminal justice services, education, economic б 7 development, agriculture and markets, housing and community renewal, 8 general services, labor, environmental conservation, mental health, 9 addiction services and supports, parks, recreation and historic preser-10 vation, corrections and community supervision, children and family 11 services, homeland security and emergency services, and people with 12 developmental disabilities, the president of the New York state energy 13 research and development authority, the superintendents of state police 14 and financial services, the secretary of state, the state fire adminis-15 trator, the chair of the public service commission, the adjutant gener-16 al, the office of information technology services, and the office of 17 victim services, the chairs of the thruway authority, the office for the aging, the metropolitan transportation authority, the port authority of 18 New York and New Jersey, the chief professional officer of the state 19 20 coordinating chapter of the American Red Cross, the chief professional officer of 2-1-1 New York state and three additional members, to be 21 22 appointed by the governor, two of whom shall be chief executives. Each 23 member agency may designate an executive level officer of that agency, 24 with responsibility for disaster preparedness matters, who may represent that agency on the commission. The commissioner of the division of 25 26 homeland security and emergency services shall serve as chair of the 27 commission, and the governor shall designate the vice chair of the 28 commission. The members of the commission, except those who serve ex

1 officio, shall be allowed their actual and necessary expenses incurred 2 in the performance of their duties under this article but shall receive 3 no additional compensation for services rendered pursuant to this arti-4 cle.

5 § 2. The executive law is amended by adding a new section 28-b to 6 read as follows:

7 <u>§ 28-b. Activation of 2-1-1 New York state; state disaster emergency.</u> 8 1. Whenever a state disaster emergency has been declared in any county, 9 city, town, or village by the governor, the declaration shall activate 10 2-1-1 New York state to respond to non-emergency requests for assist-11 ance. The disaster preparedness commission, in carrying out the disas-12 ter declaration, shall coordinate with 2-1-1 New York state and local emergency management offices. 2-1-1 New York state shall act as a public 13 14 information point for information, in coordination with emergency 15 management professionals. 2. The governor may also activate 2-1-1 New York state upon the threat 16

- 18 § 3. This act shall take effect immediately.
