AN ACT to amend the labor law, in relation to raising the minimum wage annually by a percentage which is based on inflation; and to repeal subdivision 6 of section 652 of the labor law relating thereto

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 1 of section 652 of the labor law, as amended 1 2 by section 1 of part K of chapter 54 of the laws of 2016, is amended to 3 read as follows: 4 1. Statutory. Every employer shall pay to each of its employees for 5 each hour worked a wage of not less than: б \$4.25 on and after April 1, 1991, 7 \$5.15 on and after March 31, 2000, \$6.00 on and after January 1, 2005, 8 \$6.75 on and after January 1, 2006, 9 \$7.15 on and after January 1, 2007, 10 \$8.00 on and after December 31, 2013, 11 12 \$8.75 on and after December 31, 2014, 13 \$9.00 on and after December 31, 2015, and until December 31, 2016, or, if greater, such other wage as may be 14 established by federal law pursuant to 29 U.S.C. section 206 or its 15 successors or such other wage as may be established in accordance with 16 the provisions of this article. 17 18 (a) New York City. (i) Large employers. Every employer of eleven or 19 more employees shall pay to each of its employees for each hour worked in the city of New York a wage of not less than: 20 21 \$11.00 per hour on and after December 31, 2016, 2.2 \$13.00 per hour on and after December 31, 2017,

\$14.16 on and after December 31, 2022, 1 \$15.00 on and after December 31, 2023, 2 3 and on each following December thirty-first, a wage published by the commissioner on or before October first, based on the then current mini-4 5 mum wage increased by the rate of inflation, if greater than zero, for the most recent twelve month period ending June of that year based on б the consumer price index for all urban consumers on a national and 7 8 seasonally unadjusted basis (CPI-U), or a successor index as calculated 9 by the United States department of labor, or, if greater, such other wage as may be established by federal law pursuant to 29 U.S.C. section 10 206 or its successors or such other wage as may be established in 11 accordance with the provisions of this article. 12 (d) The rates and schedules established in paragraphs (a) and (b) of 13 this subdivision shall not be deemed to be the minimum wage under this 14 subdivision for purposes of the calculations specified in subdivisions 15 16 one and two of section five hundred twenty-seven of this chapter. 17 § 2. Subdivision 6 of section 652 of the labor law is REPEALED.
