AN ACT to amend chapter 698 of the laws of 1991 amending the public authorities law and the education law, relating to the construction and financing of facilities by the dormitory authority for private schools approved pursuant to article 89 of the education law, in relation to including NYSARC, Inc., Erie County Chapter

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- Section 1. Section 6 of chapter 698 of the laws of 1991 amending the public authorities law and the education law, relating to the construction and financing of facilities by the dormitory authority for private schools approved pursuant to article 89 of the education law, as amended by chapter 294 of the laws of 1998, is amended to read as follows:
