AN ACT to amend the education law, in relation to establishing a career and technical education diploma

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The education law is amended by adding a new section 817 to read as follows:

§ 817. Career and technical education pathway to a high school diploma. 1. a. A career and technical education (CTE) pathway to a high school diploma is hereby established. A CTE pathway to a diploma, if made available by a school district shall:

(i) result in a regents or local diploma;

(ii) differ from the traditional requirements to a regents or local diploma with respect to required assessments, except as otherwise required by federal law;

(iii) be made available to all students, including, but not limited to students with disabilities and English language learners.

b. A CTE pathway to a diploma shall be based on a course of study designed to provide students with technical knowledge and skills and shall demonstrate that the student is ready for a career as determined by regulations of the commissioner. A CTE pathway to a diploma shall include, but not be limited to:

(i) completion of a CTE course of study;

(ii) completion of a three-part technical assessment;

(iii) completion of work-based learning experiences as provided by the state approved program; and

1 (iv) completion of a work-skills employability profile.

2 c. For purposes of this section, a career and technical education
3 shall include, but not be limited to, a course of study in the following
4 career fields: agriculture education, business and marketing education,
5 family and consumer sciences education, health occupations education,
6 technical education, technology education, and trade and industrial
7 education.

8 2. The board of regents shall promulgate such regulations of the
9 commissioner as may be necessary to establish the curriculum, assess-
10 ments and any other criteria that students must achieve to earn a
11 regents or local diploma via a CTE pathway.

12 3. Students first entering ninth grade in the two thousand nineteen--
13 two thousand twenty school year and thereafter shall be eligible to earn
14 a diploma via a CTE pathway if made available by a school district.

15 § 2. This act shall take effect immediately. Effective immediately,
16 the addition, amendment and/or repeal of any rule or regulation neces-
17 sary for the implementation of this act on its effective date are
18 authorized to be made and completed on or before such date.
