AN ACT to amend the executive law, in relation to including Doodletown Brook in the list of inland waterways eligible for the local waterfront revitalization program

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph (c) of subdivision 4 of section 911 of the executive law, as separately amended by chapters 382 and 397 of the laws of 2 2023, is amended to read as follows:

3 (c) the state's major creeks and brooks comprised of the 18 Mile Creek 4 located in Erie county, Chittenango Creek, Bash Bish and Kinderhook 5 Creek located in Columbia county, Kinderhook Creek located in Rensselaer 6 county, Basher Kill, Bushkill, Cattaraugus, Cayadutta, North Chuctanunda, 7 Cincinnati, East Kill, Esopus (including upper and lower branches), 8 Ferguson, Fish (including east and west branches), Gooseberry, Great 9 Valley, Kenneyetto, Little Sandy, Moyer, Mud Creek located in Oneida 10 county, Ninemile Creek, Onondaga, Oriskany, Peekskill Hollow, Reall, 11 Roeliff Jansen Kill, Rondout, Sandy, Sauquoit, Schoharie, Shawangunk 12 Kill, Six Mile Creek, South Sandy, Oatka, Tonawanda, West Kill, Scajagada, 13 Wappinger, Webatuck, Wassaic, Willsey in the village of Wurtsboro, 14 Wood Creek located in Herkimer county, Wood Creek located in Oneida 15 county, Black Creek located in Monroe county, Black Creek located in 16 Genesee and Wyoming counties, Ellicott Creek located in Erie county, 17 Wynantskill, Claverack, Taghkanic, Agawamuck, Wyomanock, and Ley Creek 18 and Butternut Creek located in Onondaga county, Nanticoke and Sawkill 19
