AN ACT to amend the executive law, in relation to clarifying the standard for disparate treatment claims

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Section 292 of the executive law is amended by adding a new  
2 subdivision 42 to read as follows:

3 42. The terms "because of", "because", and "by reason of" in disparate  
4 treatment cases, including retaliation cases, mean the unlawful motive  
5 was a motivating factor. Nothing in this definition is intended to  
6 preclude or limit use of the disparate impact method of proving liabil-  
7 ity.

8 § 2. This act shall take effect immediately.
