AN ACT to amend chapter 639 of the laws of 1970 incorporating the Oriskany Volunteer Exempt Firemen's Association of Oriskany, county of Oneida, and providing for its powers and duties, in relation to the name and purposes of such association

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. Sections 1, 2, 3 and 7 of chapter 639 of the laws of 1970
2 incorporating the Oriskany Volunteer Exempt Firemen's Association of
3 Oriskany, county of Oneida, and providing for its powers and duties is
4 amended to read as follows:
5 Section 1. Incorporation; membership. A membership corporation by the
6 name of "Oriskany Volunteer Exempt [~~Firemen's~~ Firefighters' Benevolent
7 Association of Oriskany, county of Oneida" is hereby created. It shall
8 be composed of such persons eligible to membership therein as hereinaft-
9 er provided as shall: (a) notify the secretary of the Oriskany Independ-
10 ent Fire and Hose Company, also known as Oriskany Volunteer Fire Depart-
11 ment, in writing prior to the organization meeting of such corporation
12 hereinafter provided of their desire to become members, or (b) shall
13 attend such meeting or an adjournment thereof, and also such persons so
14 eligible as may become members of such corporation pursuant to its
15 by-laws.
16 § 2. Persons eligible to membership. All persons who are now or have
17 been, or who hereafter shall be active volunteer members of the Oriskany

1 Independent Fire and Hose Company, also known as Oriskany Volunteer
2 Fire Department, and who have heretofore acquired or shall hereafter
3 acquire the status of exempt volunteer ~~[firemen]~~ firefighters as defined
4 in section two hundred of the general municipal law or any other appli-
5 cable law by virtue of having rendered service in said fire department,
6 and all persons who are now or hereafter shall be active volunteer
7 members of said fire department shall be eligible for membership in the
8 corporation hereby created; provided that any person who has been
9 expelled or removed for cause from membership in any fire department or
10 company shall not be eligible to membership in such corporation. The
11 membership of any person in such corporation shall terminate when ~~[his]~~
12 their membership as an active volunteer member of the Oriskany Independ-
13 ent Fire and Hose Company, also known as Oriskany Volunteer Fire Depart-
14 ment shall terminate before such persons shall have acquired the status
15 of exempt volunteer ~~[firemen]~~ firefighters as defined in section two
16 hundred of the general municipal law by virtue of having rendered
17 services to such fire department.

18 § 3. Purposes. The purposes of such corporation shall be the mainte-
19 nance of suitable headquarters for, and the promotion of fraternal
20 intercourse among the members of such corporation, the relief, aid and
21 assistance of such members and their families who are injured, disabled
22 or indigent and to promote and safeguard the welfare of the volunteer
23 members of the corporation and their families, to provide for the health
24 and safety of the volunteer members of the corporation, and to enhance
25 the morale of the volunteer members of the corporation by providing
26 social and recreational activities for the volunteer members of the
27 corporation and the promotion of the welfare of the volunteer fire
28 service within the village of Oriskany and also within the territory
29 provided with fire protection by the Oriskany Independent Fire and Hose
30 Company, also known as Oriskany Volunteer Fire Department.

31 § 7. Precept for payment of foreign fire insurance premium taxes.
32 Notwithstanding any contrary provisions of any general, special or local
33 law, or of any city charter or ordinance, heretofore or hereafter
34 enacted, such corporation shall collect and there shall be paid to it
35 all taxes imposed by section ~~[five hundred fifty-three]~~ nine thousand
36 one hundred four of the insurance law for fire department use and bene-
37 fit, upon premises for insurance against loss or damage by fire covering
38 property situated within the village of Oriskany, New York, located in
39 the town of Whitestown, county of Oneida and state of New York, and/or
40 within any duly organized territory in which the Oriskany Independent
41 Fire and Hose Company, also known as Oriskany Volunteer Fire Department,
42 is or may be obligated to render fire protection. The officer of said
43 corporation designated by its by-laws to collect and receive the afore-
44 said tax shall have all the powers and be subject to all the provisions
45 of the insurance law, relating to the treasurer of fire departments.
46 Such corporation shall also be entitled to receive a share of the tax
47 imposed by section ~~[five hundred fifty-four]~~ nine thousand one hundred
48 five of the insurance law, based upon the business written in the terri-
49 tory with respect to which it is entitled to collect and receive the tax
50 under section ~~[five hundred fifty-three]~~ nine thousand one hundred four
51 of the insurance law. ~~[Such taxes shall only be used for the care and~~
52 ~~relief of disabled or indigent volunteer and exempt volunteer firemen~~
53 ~~and their families.]~~

54 § 2. This act shall take effect immediately.
