AN ACT in relation to authorizing the town of Eden to alienate and discontinue the use of certain parklands

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subject to the provisions of this act, the town of Eden, located in the county of Erie, acting by and through its governing body and upon such terms and conditions as determined by such body, is hereby authorized to discontinue as parklands and alienate the lands more particularly described in section three of this act, and to sell and convey such lands at fair market value, for the purpose of providing needed resources to enhance the existing parks within the town.

§ 2. The authorization provided in section one of this act shall be effective only upon the condition that the town of Eden, county of Erie, dedicate an amount equal to or greater than the fair market value of the parklands being discontinued toward the acquisition of new parklands and/or capital improvements to existing park and recreational facilities.

§ 3. The parklands authorized by section one of this act to be alienated are described as follows:

PARCEL 1:

All That Tract or Parcel of Land, Town of Eden, County of Erie, State of New York, being part of Lot No. 29, Township 8, Range 8 of the Holland Land Company's Survey, bounded and described as follows:

Beginning at a point in the east line of map cover number 2553 at the northeast corner of East Pleasant Avenue, a 70 foot wide right of way; thence S 89°-59'-29" E, a distance of 23.01 feet to a point of curvature;

21 All that tract or Parcel of Land, Town of Eden, County of Erie, State
22 of New York, being part of Lot No. 29, Township 8, Range 8 of the
23 Holland Land Company's Survey, bounded and described as follows:
24 Beginning at a point in the southeast corner of map cover number 2591;
25 thence N 01°-26'-47" E, a distance of 77.07 feet;
26 thence S 89°-59'-29" E, a distance of 148.74 feet;
27 thence N 67°-30'-55" E, a distance of 438.02 feet;
28 thence N 89°-46'-49" E, a distance of 225.00 feet;
29 thence S 01°-28'-52" W, a distance of 218.15 feet;

34 § 4. In the event that the town of Eden received any funding support
35 or assistance from the federal government for the purchase, maintenance
36 or improvement of the parklands set forth in section three of this act,
37 the discontinuance and alienation of such parkland authorized by the
38 provisions of this act shall not occur until the town of Eden has
39 complied with any federal requirements pertaining to the alienation or
40 conversion of parklands, including satisfying the secretary of the inte-
41 rior that the alienation or conversion complies with all conditions
42 which the secretary of the interior deems necessary to ensure the
43 substitution of other lands shall be equivalent in fair market value and
44 usefulness to the lands being alienated or converted.

45 § 5. This act shall take effect immediately.
