AN ACT to amend the education law, in relation to the criteria for determining tuition assistance program awards

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision 3 of section 667 of the education law, as added
2 by chapter 83 of the laws of 1995, paragraph a as amended by section 1
3 and subparagraph (iv) of paragraph b as amended by section 3 of part B
4 of chapter 60 of the laws of 2000, clause (A) of subparagraph (i) of
5 paragraph a as amended by section 1 and subparagraphs (i) and (ii) of
6 paragraph b as amended by section 2 of part DD of chapter 56 of the laws
7 of 2021, subparagraphs (ii), (iii) and (vi) of paragraph a as amended
8 and paragraph (vii) as added by section 1 of part X of chapter 56 of the
9 laws of 2024, and paragraph c as relettered by section 2 of part J of
10 chapter 58 of the laws of 2011 and paragraph b as amended by chapter 309
11 of the laws of 1996, is amended to read as follows:

12 3. Tuition assistance program awards.
13 a. Amount. The president shall make awards to students enrolled in
14 degree-granting institutions or registered not-for-profit business
15 schools qualified for tax exemption under § 501(c)(3) of the internal
16 revenue code for federal income tax purposes in the following amounts:
17 (i) For each year of undergraduate study, assistance shall be provided
18 as computed on the basis of the amount which is the lesser of the
19 following:

20 (A) [~~1) In the case of students who have not been granted an exclu-~~
21 ~~sion of parental income, who have qualified as an orphan, foster child,~~
22 ~~or ward of the court for the purposes of federal student financial aid~~
23 ~~programs authorized by Title IV of the Higher Education Act of 1965, as~~
24 ~~amended, or had a dependent for income tax purposes during the tax year~~
25 ~~next preceding the academic year for which application is made, except~~

~~(a)]~~ Five thousand dollars, except starting in two thousand fourteen-two thousand fifteen such students shall receive five thousand one hundred sixty-five dollars, and except starting in two thousand twenty-one--two thousand twenty-two and thereafter such students shall receive five thousand six hundred sixty-five dollars, provided however that nothing herein shall be construed as increasing any award made pursuant to this section for an academic year prior to two thousand twenty-one--two thousand twenty-two; or

19 (i) For each year of study, assistance shall be provided as computed
20 on the basis of the amount which is the lesser of the following:

13 amount of income allowable under subparagraph (ii) [~~or (iii)~~] of this
14 paragraph, no award shall be made.

15 c. Restrictions. In no [~~even shall~~] event shall any award:

16 (i) be made unless the annual tuition (exclusive of educational fees)
17 and, if applicable, the college fee levied by the state university of
18 New York pursuant to the April first, nineteen hundred sixty-four
19 financing agreement with the New York state dormitory authority charged
20 for the program in which the student is enrolled total at least two
21 hundred dollars; or

22 (ii) exceed the amount by which such annual tuition (exclusive of
23 educational fees) and, if applicable, the college fee levied by the
24 state university of New York pursuant to the April first, nineteen
25 hundred sixty-four financing agreement with the New York state dormitory
26 authority exceed the total of all other state, federal, or other educa-
27 tional aid that is received or receivable by such student during the
28 school year for which such award is applicable and that, in the judgment
29 of the commissioner, would duplicate the purposes of the award; or

30 (iii) be made when income exceeds the maximum income set forth in this
31 subdivision. The commissioner shall list in his regulations all major
32 state and federal financial aid available to New York state students and
33 identify any forms of aid that are duplicative of the purposes of the
34 tuition assistance program. For the purposes of this subdivision,
35 neither United States war orphan educational benefits nor benefits under
36 the veterans' readjustment act of nineteen hundred sixty-six shall be
37 considered as federal or other educational aid.

38 § 2. This act shall take effect on the one hundred eightieth day after
39 it shall have become a law.
