CONCURRENT RESOLUTION OF THE SENATE AND ASSEMBLY

proposing an amendment to section 1 of article 5 of the constitution, in relation to providing for the governor to fill a vacancy of the office of the comptroller and attorney-general

1 Section 1. Resolved (if the Assembly concur), That section 1 of arti-
2 cle 5 of the constitution be amended to read as follows:

3 Section 1. The comptroller and attorney-general shall be chosen at the
4 same general election as the governor and hold office for the same term,
5 and shall possess the qualifications provided in section 2 of article
6 IV. ~~[The legislature shall provide for filling vacancies in the office~~
7 ~~of comptroller and of attorney general. No election of a comptroller or~~
8 ~~an attorney general shall be had except at the time of electing a gover-~~
9 ~~nor.]~~ If a vacancy shall occur during a term of such offices, otherwise
10 than by expiration of term, the governor shall appoint a person to
11 execute the duties of the office of the comptroller or attorney-general,
12 as the case may be, and such person shall serve until the next general
13 election. If such next general election is at a time other than the time
14 of electing a governor, an election shall be held at such time and shall
15 be to fill the residue of the term until the next general election where
16 a governor shall be elected. The comptroller shall be required: (1) to
17 audit all vouchers before payment and all official accounts; (2) to
18 audit the accrual and collection of all revenues and receipts; and (3)
19 to prescribe such methods of accounting as are necessary for the
20 performance of the foregoing duties. The payment of any money of the
21 state, or of any money under its control, or the refund of any money
22 paid to the state, except upon audit by the comptroller, shall be void,
23 and may be restrained upon the suit of any taxpayer with the consent of
24 the supreme court in appellate division on notice to the attorney-gener-
25 al. In such respect the legislature shall define the powers and duties
26 and may also assign to ~~[him or her]~~ the comptroller: (1) supervision of

1 the accounts of any political subdivision of the state; and (2) powers
2 and duties pertaining to or connected with the assessment and taxation
3 of real estate, including determination of ratios which the assessed
4 valuation of taxable real property bears to the full valuation thereof,
5 but not including any of those powers and duties reserved to officers of
6 a county, city, town or village by virtue of [~~sections seven and eight~~
7 ~~of~~] article nine of this constitution. The legislature shall assign to
8 [~~him or her~~] the comptroller no administrative duties, excepting such as
9 may be incidental to the performance of these functions, any other
10 provision of this constitution to the contrary notwithstanding.
11 § 2. Resolved (if the Assembly concur), That the foregoing amendment
12 be referred to the first regular legislative session convening after the
13 next succeeding general election of members of the assembly, and, in
14 conformity with section 1 of article 19 of the constitution, be
15 published for 3 months previous to the time of such election.
