AN ACT to amend the environmental conservation law, in relation to authorizing and directing the commissioner of environmental conservation to establish rules and regulations for in-home reverse vending machines; and directing such commissioner to determine the best design for such in-home machines and providing for the payment of a grant to the designer or inventor thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 27-1003 of the environmental conservation law is  
2 amended by adding a new subdivision 12-a to read as follows:  
3 12-A. "IN-HOME REVERSE VENDING MACHINE" MEANS A REVERSE VENDING  
4 MACHINE PLACED IN THE RESIDENCE OR BUSINESS OF A CONSUMER WHICH ISSUES A  
5 SCRIP OR RECEIPT TO SUCH CONSUMER FOR THE REFUND VALUE OF ALL BEVERAGE  
6 CONTAINERS TO BE PAID BY A REDEMPTION CENTER.  
7 S 2. Section 27-1013 of the environmental conservation law, as amended  
8 by section 9 of part SS of chapter 59 of the laws of 2009, is amended to  
9 read as follows:  
10 S 27-1013. Redemption centers AND IN-HOME REVERSE VENDING MACHINES.  
11 1. The commissioner is hereby empowered to promulgate rules and regu-  
12 lations governing [(1)] (A) the circumstances in which dealers and  
13 distributors, individually or collectively, are required to accept the  
14 return of empty beverage containers, and make payment therefor; [(2)]  
15 (B) the sorting of the containers which a deposit initiator or distribu-  
16 tor may require of dealers and redemption centers; [(3)] (C) the  
17 collection of returned beverage containers by deposit initiators or  
18 distributors, including the party to whom such expense is to be charged,  
19 the frequency of such pick ups and the payment for refunds and handling  
20 fees thereon; [(4)] (D) the right of dealers to restrict or limit the  
21 number of containers redeemed, the rules for redemption at the dealers'  
22 place of business, and the redemption of containers from a beverage for

1 which sales have been discontinued, and to issue permits to persons,  
2 firms or corporations which establish redemption centers, subject to  
3 applicable provisions of local and state laws, at which redeemers and  
4 dealers may return empty beverage containers and receive payment of the  
5 refund value of such beverage containers; AND (E) TERMS OF CONTRACTS  
6 PROVIDING FOR THE PAYMENT BY REDEMPTION CENTERS OF THE REFUND VALUE OF  
7 BEVERAGE CONTAINERS DEPOSITED IN IN-HOME REVERSE VENDING MACHINES AND  
8 THE COLLECTION OF SUCH DEPOSITED CONTAINERS BY REDEMPTION CENTERS. No  
9 dealer or distributor, as defined in section 27-1003 of this title,  
10 shall be required to obtain a permit to operate a redemption center at  
11 the same location as the dealer's or distributor's place of business.  
12 Operators of such redemption centers shall receive payment of the refund  
13 value of each beverage container from the appropriate deposit initiator  
14 or distributor as provided under section 27-1007 of this title.

15 2. THE COMMISSIONER SHALL PROMULGATE RULES AND REGULATIONS GOVERNING  
16 THE DESIGN, OPERATION AND AVAILABILITY OF IN-HOME REVERSE VENDING  
17 MACHINES. FURTHERMORE, THE COMMISSIONER SHALL SUBMIT TO THE LEGISLATURE  
18 SUCH LEGISLATIVE PROPOSALS AS HE OR SHE SHALL DEEM NECESSARY FOR THE  
19 REGULATION AND USE OF IN-HOME REVERSE VENDING MACHINES.

20 S 3. (a) The commissioner of environmental conservation shall solicit  
21 and any person may submit to such commissioner a design for an effi-  
22 cient, accurate, reliable and easy to use in-home reverse vending  
23 machine, as defined in subdivision 12-a of section 27-1003 of the envi-  
24 ronmental conservation law. The commissioner shall establish and publish  
25 standards for the design of reverse vending machines to be used in this  
26 state.

27 (b) On or before January 1, 2012, the commissioner shall from the  
28 designs and prototype in-home reverse vending machines submitted to him  
29 or her, determine which design or prototype thereof is the best design  
30 and most closely meets the standards therefor. The designer or inventor  
31 of the best design or prototype shall be awarded a grant of one hundred  
32 twenty thousand dollars. Notwithstanding any other provision of law to  
33 the contrary, such grant shall be paid from the solid waste account of  
34 the environmental protection fund.

35 S 4. This act shall take effect immediately.
