Introduced by M. of A. BENJAMIN -- read once and referred to the Committee on Aging

AN ACT to amend the elder law and the social services law, in relation to provision of services at community centers for senior citizens in cities of one million or more persons

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 214 of the elder law is amended by adding a new  
2 subdivision 8 to read as follows:

3 8. WHENEVER COMMUNITY SERVICES ARE FURNISHED TO ELDERLY PERSONS IN  
4 COMMUNITY SETTINGS IN CITIES OF ONE MILLION OR MORE PERSONS, SUCH AS  
5 SENIOR CITIZENS CENTERS, OR COMMUNITY CENTERS SUCH CENTERS SHALL PROVIDE  
6 A PERSON OR PERSONS CERTIFIED IN ADULT CARDIOPULMONARY RESUSCITATION IN  
7 SUCH NUMBERS AS SHALL BE DETERMINED BY THE DIRECTOR AS SUFFICIENT TO  
8 COVER THE AREA WITHIN THE SENIOR CENTER AND THOSE SENIORS PARTICIPATING  
9 IN SAID AREA. FOR THE PURPOSES OF THIS SUBDIVISION, A PERSON IS CERTI-  
10 FIED IN ADULT CARDIOPULMONARY RESUSCITATION IF HE OR SHE HAS SUCCESSFUL-  
11 LY COMPLETED SUCH COURSE CONDUCTED BY THE AMERICAN RED CROSS OR THE  
12 AMERICAN HEART ASSOCIATION AND OTHERWISE MEETS SUCH REQUIREMENTS AS MAY  
13 BE ESTABLISHED BY THE DIRECTOR, WHICH MAY INCLUDE, BUT NOT BE LIMITED  
14 TO, CONTINUING EDUCATION OR TRAINING TO MAINTAIN CERTIFICATION IN ADULT  
15 CARDIOPULMONARY RESUSCITATION.

16 S 2. Section 370 of the social services law is amended by adding a new  
17 subdivision 4 to read as follows:

18 4. COMMUNITY CENTERS FURNISHING SERVICES FOR SENIOR CITIZENS UNDER  
19 THIS TITLE IN CITIES OF ONE MILLION OR MORE PERSONS, SHALL PROVIDE A  
20 PERSON OR PERSONS CERTIFIED IN ADULT CARDIOPULMONARY RESUSCITATION IN  
21 SUCH NUMBERS AS SHALL BE DETERMINED BY THE COMMISSIONER OF THE OFFICE OF  
22 CHILDREN AND FAMILY SERVICES AS SUFFICIENT TO COVER THE AREA WITHIN THE  
23 SENIOR CENTER AND THOSE SENIORS PARTICIPATING IN SAID AREA. FOR THE  
24 PURPOSES OF THIS SUBDIVISION, A PERSON IS CERTIFIED IN ADULT CARDIOPUL-  
25 MONARY RESUSCITATION IF HE OR SHE HAS SUCCESSFULLY COMPLETED SUCH COURSE  
26 CONDUCTED BY THE AMERICAN RED CROSS OR THE AMERICAN HEART ASSOCIATION  
27 AND OTHERWISE MEETS SUCH REQUIREMENTS AS MAY BE ESTABLISHED BY SUCH
