AN ACT to amend the vehicle and traffic law, in relation to authorizing distinctive license plates for members of the Air Medal Society

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The vehicle and traffic law is amended by adding a new  
2 section 404-x to read as follows:  
3 S 404-X. DISTINCTIVE PLATES FOR MEMBERS OF THE AIR MEDAL SOCIETY. 1.  
4 ANY MEMBER OF THE AIR MEDAL SOCIETY RESIDING IN THIS STATE SHALL, UPON  
5 REQUEST, BE ISSUED A DISTINCTIVE LICENSE PLATE BEARING THE WORDS "AIR  
6 MEDAL SOCIETY" OR SUCH OTHER PHRASE AS THE COMMISSIONER SHALL DESIGNATE  
7 SHOWING THE REGISTRANT IS A MEMBER OF THE AIR MEDAL SOCIETY.  
8 2. APPLICATION FOR SUCH LICENSE PLATE SHALL BE FILED WITH THE COMMIS-  
9 SIONER IN SUCH FORM AND DETAIL AS THE COMMISSIONER SHALL PRESCRIBE.  
10 3. THE DISTINCTIVE PLATE AUTHORIZED IN THIS SECTION SHALL BE ISSUED  
11 UPON PROOF, SATISFACTORY TO THE COMMISSIONER, THAT THE APPLICANT IS A  
12 MEMBER OF THE AIR MEDAL SOCIETY.  
13 4. A DISTINCTIVE PLATE ISSUED PURSUANT TO THIS SECTION SHALL BE ISSUED  
14 IN THE SAME MANNER AS OTHER NUMBER PLATES UPON PAYMENT OF THE REGULAR  
15 REGISTRATION FEE PRESCRIBED BY SECTION FOUR HUNDRED ONE OF THIS ARTICLE,  
16 PROVIDED, HOWEVER, THAT AN ADDITIONAL ANNUAL SERVICE CHARGE OF  
17 TWENTY-FIVE DOLLARS SHALL BE CHARGED FOR SUCH PLATE. SUCH ANNUAL SERVICE  
18 CHARGE SHALL BE DEPOSITED PURSUANT TO THE PROVISIONS OF SECTION FOUR  
19 HUNDRED FOUR-00 OF THIS ARTICLE, TO THE CREDIT OF THE DEPARTMENT OF  
20 MOTOR VEHICLES DISTINCTIVE PLATE DEVELOPMENT FUND ESTABLISHED BY SECTION  
21 NINETY-FIVE-G OF THE STATE FINANCE LAW, AND SHALL BE USED FOR THE  
22 PRODUCTION, DESIGN, ADVERTISING AND MARKETING OF DISTINCTIVE LICENSE  
23 PLATES PURSUANT TO SUCH SECTION NINETY-FIVE-G.  
24 S 2. This act shall take effect on the one hundred eightieth day after  
25 it shall have become a law.
