AN ACT to amend the mental hygiene law, in relation to mandatory reporting of allegations of physical or sexual abuse of a child with mental or physical disabilities

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The mental hygiene law is amended by adding a new section
2 16.30 to read as follows:
3 S 16.30 MANDATORY REPORTING OF PHYSICAL OR SEXUAL ABUSE.
4 (A) ANY AND ALL ALLEGATIONS OF PHYSICAL OR SEXUAL ABUSE OF A PERSON
5 WITH MENTAL DISABILITIES RESIDING IN A FACILITY OPERATED, CERTIFIED,
6 LICENSED, FUNDED OR OTHERWISE BY THE DEPARTMENT REPORTED TO ANY ABUSE
7 HOTLINE SHALL BE FORWARDED TO LOCAL LAW ENFORCEMENT AND THE LOCAL
8 DISTRICT ATTORNEY'S OFFICE.
9 (B) ALL MANDATORY REPORTERS AND ANY OTHER INDIVIDUAL REPORTING AN
10 ALLEGATION OF PHYSICAL OR SEXUAL ABUSE OF A PERSON WITH MENTAL DISABILI-
11 TIES OR PHYSICAL DISABILITIES RESIDING IN A FACILITY OPERATED, CERTI-
12 FIED, LICENSED, FUNDED OR OTHERWISE AUTHORIZED BY THE DEPARTMENT SHALL
13 REPORT THE ALLEGATION TO LOCAL LAW ENFORCEMENT, LOCAL DISTRICT ATTOR-
14 NEY'S OFFICE, CHILD ABUSE HOTLINE, IF APPLICABLE, ADULT PROTECTIVE
15 SERVICES, IF APPLICABLE, AND TO THE STATEWIDE CENTRAL REGISTER OF CHILD
16 ABUSE AND MALTREATMENT.
17 (C)(I) ANY ALLEGATION OF AN ABUSED CHILD IN RESIDENTIAL CARE AS
18 DEFINED IN SUBDIVISION ONE OF SECTION FOUR HUNDRED TWELVE-A OF THE
19 SOCIAL SERVICES LAW TO ANY ABUSE HOTLINE, STATEWIDE, SHALL BE IMMEDIATE-
20 LY FORWARDED TO LOCAL LAW ENFORCEMENT AND THE LOCAL DISTRICT ATTORNEY'S
21 OFFICE.
22 (II) ANY ALLEGATION OF AN ABUSE TO A YOUTH RESIDING IN RESIDENTIAL
23 CARE AS THE TERM IS DEFINED IN PARAGRAPH (A) OR (B) OF SUBDIVISION FOUR
24 OF SECTION FOUR HUNDRED TWELVE-A OF THE SOCIAL SERVICES LAW TO ANY ABUSE
25 HOTLINE SHALL BE IMMEDIATELY FORWARDED TO LOCAL LAW ENFORCEMENT, LOCAL
26 DISTRICT ATTORNEY'S OFFICE AND THE STATEWIDE CENTRAL REGISTER OF CHILD
27 ABUSE AND MALTREATMENT.
