AN ACT to amend the public health law, in relation to providing for the creation and dissemination of information pertaining to bone marrow and peripheral blood stem cell donation; to amend the public health law, the election law and the vehicle and traffic law, in relation to bone marrow and peripheral blood stem cell donation registration

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. This act shall be known and may be cited as "Jaden's law".
2 S 2. The public health law is amended by adding a new section 4369 to
3 read as follows:
4 S 4369. BONE MARROW AND PERIPHERAL BLOOD STEM CELL DONATION INFORMA-
5 TION. 1. (A) THE COMMISSIONER SHALL PREPARE AN ONLINE BROCHURE FOR
6 DISPLAY ON THE INTERNET WEBSITE OF THE DEPARTMENT, BASED UPON INFORMA-
7 TION DERIVED FROM THE NATIONAL MARROW DONOR PROGRAM ("NMDP"), WHICH MAY
8 BE DOWNLOADED BY PHYSICIANS FOR THE PURPOSES OF BEING PROVIDED TO
9 PATIENTS, AND SHALL BE DESIGNED TO INFORM PATIENTS OF THE OPTION TO
10 BECOME A BONE MARROW OR PERIPHERAL BLOOD STEM CELL ("PBSC") DONOR BY
11 REGISTERING WITH THE NMDP AND TO ANSWER COMMON QUESTIONS ABOUT BONE
12 MARROW AND PERIPHERAL BLOOD STEM CELL, OR PBSC, DONATION.
13 (B) THE BROCHURE SHALL DESCRIBE:
14 (1) THE HEALTH BENEFITS TO THE COMMUNITY FROM MAKING A BONE MARROW OR
15 PBSC DONATION THROUGH THE NMDP;
16 (2) HOW TO REGISTER WITH THE NMDP;
17 (3) THE PROCEDURES FOR MAKING A BONE MARROW OR PBSC DONATION THROUGH
18 THE NMDP, INCLUDING NOTICE THAT THERE IS NO CHARGE TO THE DONOR OR THE
19 DONOR'S FAMILY FOR MAKING THE DONATION;
20 (4) THE CIRCUMSTANCES AND PROCEDURES BY WHICH A PATIENT MAY RECEIVE A
21 TRANSFUSION OF THE PATIENT'S PREVIOUSLY DONATED BLOOD; AND
22 (5) ANY OTHER ASPECTS OF BONE MARROW OR PBSC DONATION THAT THE COMMIS-
23 SIONER DEEMS APPROPRIATE FOR THE PURPOSES OF THIS SECTION.
24 2. (A) A PHYSICIAN, AS EARLY AS PRACTICABLE IN THE PHYSICIAN'S THERA-
25 PEUTIC RELATIONSHIP WITH A PATIENT, AND UNLESS THE PHYSICIAN REASONABLY

1 BELIEVES THAT BONE MARROW OR PBSC DONATION WOULD THREATEN THE HEALTH OF
2 THE PATIENT, SHALL PROVIDE A COPY OF THE BROCHURE PREPARED BY THE
3 COMMISSIONER TO EVERY PATIENT:

4 (1) WHO IS KNOWN BY THE PHYSICIAN TO BE AT LEAST EIGHTEEN YEARS OF AGE
5 BUT NO OLDER THAN SIXTY YEARS OF AGE; AND

6 (2) WHO THE PHYSICIAN ANTICIPATES WILL BE ADMITTED TO A HOSPITAL FOR
7 AN ELECTIVE ORTHOPEDIC PROCEDURE OR TREATMENT OR OTHERWISE BELIEVES IS
8 AN APPROPRIATE CANDIDATE FOR BONE MARROW OR PBSC DONATION; OR FOR WHOM
9 THE PHYSICIAN OTHERWISE BELIEVES BONE MARROW OR PBSC DONATION IS APPRO-
10 PRIATE TO THE PATIENT'S MEDICAL CIRCUMSTANCES OR IS DESIRED BY THE
11 PATIENT.

12 (B) THE PHYSICIAN SHALL OFFER TO DISCUSS THE INFORMATION CONTAINED IN
13 THE BROCHURE WITH THE PATIENT OR THE PATIENT'S REPRESENTATIVE.

14 (C) THE PROVISIONS OF PARAGRAPH (A) OF THIS SUBDIVISION SHALL NOT BE
15 CONSTRUED TO APPLY TO A PHYSICIAN WHO IS DIRECTLY AFFILIATED WITH A
16 RELIGIOUS DENOMINATION THAT ADHERES TO THE TENET THAT BONE MARROW OR
17 PBSC TRANSFER IS CONTRARY TO THE MORAL PRINCIPLES WHICH THE DENOMINATION
18 CONSIDERS TO BE AN ESSENTIAL PART OF ITS BELIEFS AND PRACTICES.

19 S 3. Section 4310 of the public health law, as amended by chapter 639
20 of the laws of 2006, the section heading and subdivision 1 as separately
21 amended by chapter 640 of the laws of 2006 and subdivision 2 as amended
22 by chapter 362 of the laws of 2008, is amended to read as follows:

23 S 4310. New York state donate life registry for organ [and], tissue,
24 BONE MARROW OR PERIPHERAL BLOOD STEM CELL donations. 1. The department
25 shall establish an organ and tissue donor registry, which shall be
26 called and be referred to as the "donate life registry", which shall
27 contain a listing of all donors who have declared their consent to make
28 an anatomical gift OR TO DONATE BONE MARROW OR PERIPHERAL BLOOD STEM
29 CELLS.

30 2. Such registration of consent to make an anatomical gift OR TO
31 DONATE BONE MARROW OR PERIPHERAL BLOOD STEM CELLS can be made through
32 (a) indication made on the application or renewal form of a license, (b)
33 indication made on a non-driver identification card application or
34 renewal form, (c) enrolling in the registry website maintained by the
35 department, (d) indication made on a voter registration form pursuant to
36 subdivision five of section 5-210 of the election law, or (e) through
37 any other method identified by the commissioner. The registration shall
38 take effect upon the department sending written notice of the registra-
39 tion to the person enrolling in the registry.

40 3. (a) Information contained in the registry shall be accessible to
41 (i) federally regulated organ, BONE MARROW OR PERIPHERAL BLOOD STEM CELL
42 procurement agencies, (ii) eye and tissue banks licensed by the depart-
43 ment pursuant to article forty-three-B of this chapter, (iii) any other
44 entity formally approved by the commissioner.

45 (b) The information contained in the registry shall not be released to
46 any person except as expressly authorized by this section solely for the
47 purpose of:

48 (I) identifying potential organ and tissue donors at or near the time
49 of death; OR

50 (II) IDENTIFYING POTENTIAL BONE MARROW OR PERIPHERAL BLOOD STEM CELL
51 DONORS.

52 4. If the department had an established registry prior to the effec-
53 tive date of this section, it shall be deemed to meet the requirements
54 of this section.

55 5. The registry shall provide persons enrolled the opportunity to
56 specify which organs and tissues they want to donate, INCLUDING WHETHER

1 THEY WANT TO DONATE BONE MARROW OR PERIPHERAL BLOOD STEM CELLS, and if
2 the donation can be used for transplantation, research, or both.

3 6. A person registered in the organ and tissue registry before the
4 effective date of this subdivision shall be deemed to have expressed
5 intent to donate ORGANS AND TISSUES OTHER THAN BONE MARROW OR PERIPHERAL
6 BLOOD STEM CELLS, until and unless he or she files an amendment to his
7 or her registration or a new registration expressing consent to donate.

8 7. The commissioner shall contact each person registered before the
9 effective date of this subdivision in the organ and tissue registry in
10 writing to inform him or her that at the time he or she registered, the
11 registry was that of intent and that the registry is now one of consent,
12 to explain in clear and understandable terms the difference between
13 intent and consent, and to provide opportunity for the person to change
14 his or her registration to provide consent by amending his or her
15 current registration or executing a new registration.

16 8. The commissioner is authorized to promulgate rules and regulations
17 necessary to implement the provisions of this section.

18 S 4. Subparagraph (xii) of paragraph (k) of subdivision 5 of section
19 5-210 of the election law, as added by chapter 362 of the laws of 2008,
20 is amended to read as follows:

21 (xii) A space for the applicant to register in the New York state
22 donate life registry for organ [and], tissue, BONE MARROW OR PERIPHERAL
23 BLOOD STEM CELL donations established pursuant to section forty-three
24 hundred ten of the public health law.

25 S 5. Subdivision 1 of section 502 of the vehicle and traffic law, as
26 amended by chapter 639 of the laws of 2006, is amended to read as
27 follows:

28 1. Application for license. Application for a driver's license shall
29 be made to the commissioner. The fee prescribed by law may be submitted
30 with such application. The applicant shall furnish such proof of identi-
31 ty, age, and fitness as may be required by the commissioner. The commis-
32 sioner may also provide that the application procedure shall include the
33 taking of a photo image or images of the applicant in accordance with
34 rules and regulations prescribed by the commissioner. In addition, the
35 commissioner also shall require that the applicant provide his or her
36 social security number and provide space on the application so that the
37 applicant may register in the New York state organ [and], tissue, BONE
38 MARROW OR PERIPHERAL BLOOD STEM CELL donor registry under section
39 forty-three hundred ten of the public health law. In addition, an appli-
40 cant for a commercial driver's license who will operate a commercial
41 motor vehicle in interstate commerce shall certify that such applicant
42 meets the requirements to operate a commercial motor vehicle, as set
43 forth in public law 99-570, title XII, and title 49 of the code of
44 federal regulations, and all regulations promulgated by the United
45 States secretary of transportation under the hazardous materials trans-
46 portation act. Upon a determination that the holder of a commercial
47 driver's license has made any false statement, with respect to the
48 application for such license, the commissioner shall revoke such
49 license.

50 S 6. This act shall take effect on the ninetieth day after it shall
51 have become a law.
