- AN ACT to amend the general municipal law and the state finance law, in relation to granting preferences to New York state domiciliaries in the awarding of contracts for public work

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 1 of section 103 of the general municipal law, 2 as amended by chapter 741 of the laws of 2005, is amended to read as 3 follows:

4 1. Except as otherwise expressly provided by an act of the legislature 5 or by a local law adopted prior to September first, nineteen hundred fifty-three, all contracts for public work involving an expenditure of 6 7 more than twenty thousand dollars and all purchase contracts involving 8 an expenditure of more than ten thousand dollars, shall be awarded by the appropriate officer, board or agency of a political subdivision or of any district therein including but not limited to a soil conservation 9 10 district, to the lowest responsible bidder furnishing the required secu-11 12 rity after advertisement for sealed bids in the manner provided by this section. In any case where a responsible bidder's gross price is reduci-13 14 ble by an allowance for the value of used machinery, equipment, apparatus or tools to be traded in by a political subdivision, the gross price 15 shall be reduced by the amount of such allowance, for the purpose of 16 NOTWITHSTANDING THE FOREGOING, IN ANY CASE 17 the low bid. determining WHERE A RESPONSIBLE BIDDER WHO IS A NEW YORK STATE 18 RESIDENT, FIRM OR 19 CORPORATION AND WHO IS FURNISHING THE REQUIRED SECURITY IS FOUND BY SUCH 20 BOARD OR AGENCY TO BE WITHIN TWO PERCENT OF THE BID OF THE OFFICER, LOWEST RESPONSIBLE BIDDER, SUCH OFFICER, BOARD OR AGENCY MAY PREFER SUCH 21

RESPONSIBLE BIDDER OVER THE LOWEST RESPONSIBLE BIDDER AND AWARD 1 THE CONTRACT TO SUCH RESPONSIBLE BIDDER; PROVIDED, HOWEVER, WHERE MORE THAN 2 3 ONE RESPONSIBLE BIDDER QUALIFIES HEREUNDER, SUCH OFFICER, BOARD OR AGEN-4 CY SHALL AWARD THE CONTRACT TO SUCH QUALIFIED RESPONSIBLE BIDDER SUBMIT-5 TING THE LOWEST BID. In cases where two or more responsible bidders furnishing the required security submit identical bids as to price, such 6 7 officer, board or agency may award the contract to any of such bidders. Such officer, board or agency may, in his or its discretion, reject all 8 bids and readvertise for new bids in the manner provided by this 9 10 section. For purposes of this section, "sealed bids", as that term 11 applies to purchase contracts, shall include bids submitted in an elec-12 tronic format, provided that the governing board of the political subdivision or district, by resolution, has authorized the receipt of bids in 13 14 such format. Submission in electronic format may not, however, be 15 required as the sole method for the submission of bids. Bids submitted 16 in an electronic format shall be transmitted by bidders to the receiving 17 device designated by the political subdivision or district. Any method 18 used to receive electronic bids shall comply with article three of the state technology law, and any rules and regulations promulgated and 19 20 guidelines developed thereunder and, at a minimum, must (a) document the 21 time and date of receipt of each bid received electronically; (b) authenticate the identity of the sender; (c) ensure the security of the 22 information transmitted; and (d) ensure the confidentiality of the bid 23 until the time and date established for the opening of bids. The timely 24 25 submission of an electronic bid in compliance with instructions provided 26 for such submission in the advertisement for bids and/or the specifications shall be the responsibility solely of each bidder or prospective bidder. No political subdivision or district therein shall incur any 27 28 29 liability from delays of or interruptions in the receiving device desig-30 nated for the submission and receipt of electronic bids.

31 S 2. Subdivision 1 of section 103 of the general municipal law, as 32 amended by chapter 413 of the laws of 1991, is amended to read as 33 follows:

34 1. Except as otherwise expressly provided by an act of the legislature 35 or by a local law adopted prior to September first, nineteen hundred fifty-three, all contracts for public work involving an expenditure of 36 37 more than twenty thousand dollars and all purchase contracts involving 38 an expenditure of more than ten thousand dollars, shall be awarded by appropriate officer, board or agency of a political subdivision or 39 the 40 of any district therein including but not limited to a soil conservation district, to the lowest responsible bidder furnishing the required secu-41 rity after advertisement for sealed bids in the manner provided by this 42 43 section. In any case where a responsible bidder's gross price is reduci-44 ble by an allowance for the value of used machinery, equipment, appara-45 tus or tools to be traded in by a political subdivision, the gross price shall be reduced by the amount of such allowance, for the purpose of 46 47 NOTWITHSTANDING THE FOREGOING, IN ANY CASE the low bid. determining 48 WHERE A RESPONSIBLE BIDDER WHO IS A NEW YORK STATE RESIDENT, FIRM OR 49 CORPORATION AND WHO IS FURNISHING THE REQUIRED SECURITY IS FOUND BY SUCH 50 AGENCY TO BE WITHIN TWO PERCENT OF THE BID OF THE OFFICER, BOARD OR 51 LOWEST RESPONSIBLE BIDDER, SUCH OFFICER, BOARD OR AGENCY MAY PREFER SUCH RESPONSIBLE BIDDER OVER THE LOWEST RESPONSIBLE BIDDER AND 52 AWARD THE CONTRACT TO SUCH RESPONSIBLE BIDDER; PROVIDED, HOWEVER, WHERE MORE THAN 53 ONE RESPONSIBLE BIDDER QUALIFIES HEREUNDER, SUCH OFFICER, BOARD OR AGEN-54 55 CY SHALL AWARD THE CONTRACT TO SUCH QUALIFIED RESPONSIBLE BIDDER SUBMIT-56 TING THE LOWEST BID. In cases where two or more responsible bidders 1 furnishing the required security submit identical bids as to price, such 2 officer, board or agency may award the contract to any of such bidders. 3 Such officer, board or agency may, in his or its discretion, reject all 4 bids and readvertise for new bids in the manner provided by this 5 section.

6 S 3. Section 135 of the state finance law is amended by adding a new 7 closing paragraph to read as follows:

8 NOTWITHSTANDING ANY OTHER PROVISION OF LAW, WHENEVER THE LOWEST RESPONSIBLE BIDDER IS A FOREIGN OR OUT-OF-STATE 9 INDIVIDUAL, FIRM OR 10 CORPORATION AND AT LEAST ONE NEW YORK STATE RESIDENT, FIRM OR CORPO-RATION HAS SUBMITTED A RESPONSIBLE BID WHICH IS WITHIN TWO 11 PERCENT OF 12 LOWEST RESPONSIBLE BID, THE CONTRACT MAY BE AWARDED TO THE LOWEST THE RESPONSIBLE BIDDER WHO IS A NEW YORK STATE RESIDENT, FIRM OR CORPO-13 14 RATION; PROVIDED, HOWEVER, WHERE MORE THAN ONE RESPONSIBLE BIDDER QUALI-15 FIES HEREUNDER, SUCH OFFICER, BOARD OR AGENCY SHALL AWARD THE CONTRACT TO SUCH QUALIFIED RESPONSIBLE BIDDER SUBMITTING THE LOWEST BID. 16

17 S 4. This act shall take effect on the first of September next succeeding the date on which shall have become a law; provided, 18 it 19 however, that the amendments to subdivision 1 of section 103 of the general municipal law made by section one of this act shall not affect the expiration and reversion of such subdivision as provided in subdivi-20 21 22 sion (a) of section 41 of part X of chapter 62 of the laws of 2003, as amended, when upon such date the provisions of section two of this act 23 24 shall take effect.
