AN ACT to amend the public health law, in relation to data collection and assessment program concerning minority health

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivisions 3 and 4 of section 241 of the public health 2 law, as added by chapter 757 of the laws of 1992, such section as renum-3 bered by chapter 443 of the laws of 1993, are amended to read as 4 follows:

5 3. Together with the minority health council, serve as liaison and б advocate for the department on minority health matters. This function shall include the provision of staff support to the minority health 7 8 council and the establishment of appropriate program linkages with 9 related federal, state, and local agencies and programs such as the office of minority health of the public health service, the agricultural 10 extension service and migrant health services. SUCH PROGRAM LINKAGES 11 WITH STATE AGENCIES SHALL INCLUDE THE ESTABLISHMENT OF A PROGRAM FOR THE 12 13 COLLECTION OF DATA REGARDING RACE, ETHNICITY AND PRIMARY LANGUAGE OF ALL PARTICIPANTS BY EACH STATE PROGRAM DIRECTLY INVOLVED IN FURNISHING OF 14 15 INFORMATION OR THE RENDERING OF SERVICES TO THE PUBLIC WHEREBY DEMO-GRAPHIC INFORMATION OF ANY KIND IS COLLECTED REGARDING ALL 16 PARTICIPANTS 17 IN SUCH PROGRAMS. AGENCIES AND DEPARTMENTS MAY USE EXISTING DATA COLLECTION METHODS TO AVOID DUPLICATIVE METHODOLOGIES. 18 DATA COLLECTED SHALL BE AGGREGATED AT LEAST ANNUALLY IN A MANNER THAT PERMITS UTILIZA-19 20 TION RATES BY RACE, ETHNICITY, AND LANGUAGE AND COMPILED INTO A REPORT. UPON COMPLETION, SUCH REPORT SHALL BE AVAILABLE TO THE PUBLIC AND ANNU-21 ALLY DISTRIBUTED TO ALL MEMBERS OF THE NEW YORK STATE LEGISLATURE. 22

Assist medical schools and state agencies to develop comprehensive 1 2 programs to improve minority health personnel supply by promoting minor-3 training and curriculum improvement, and disseminating ity clinical 4 minority health career information to high school [and], college students AND DIFFERENT STATE AGENCIES. SUCH DEVELOPMENT OF COMPREHEN-SIVE PROGRAMS SHALL INCLUDE RESEARCH INTO THE CAUSES AND MAINTENANCE OF 5 6 7 HEALTH DISPARITIES AND PROPOSALS FOR THE REDUCTION AND/OR ELIMINATION OF 8 SUCH DISPARITIES.

9 S 2. Subdivisions 3 and 4 of section 242 of the public health law, as 10 added by chapter 757 of the laws of 1992, such section as renumbered by 11 chapter 443 of the laws of 1993, are amended to read as follows:

3. An analysis of the health status of minority citizens and the status of minority health delivery systems. Such analysis shall be 12 13 14 conducted in cooperation with the minority health council and other 15 interested agencies. SUCH ANALYSIS SHALL ALSO INCLUDE AN ANNUAL ANALYSIS 16 OF DATA COLLECTED PURSUANT TO SUBDIVISION THREE OF SECTION TWO HUNDRED TITLE TO DETERMINE WHETHER THERE ARE DISPARITIES BY 17 FORTY-ONE OF THIS RACE, ETHNICITY OR LANGUAGE IN THE UTILIZATION OF STATE SERVICES OR THE 18 FUNDS. 19 RECEIPT OF SUCH ANALYSIS SHALL ALSO BE COMPILED, ANALYZED AND 20 MADE PUBLIC BY THE OFFICE OF MINORITY HEALTH.

21 4. Any recommended improvements to programs and/or regulations that 22 would enhance the cost effectiveness of the office, POLICY OPTIONS and programs intended to meet the health care needs of minority citizens AND 23 TO ELIMINATE IDENTIFIED HEALTH DISPARITIES, INCLUDING BUT NOT LIMITED 24 25 COST AND LOW COST OPTIONS AND OTHER SUBSTANTIVE PROPOSALS. ZERO ТΟ, 26 RECOMMENDATIONS FOR IMPROVEMENTS TO ENHANCE THE COST EFFECTIVENESS OF OFFICE SHALL INCLUDE AN ASSESSMENT OF THE CAPACITY OF THE OFFICE TO 27 THE ADDRESS THE DETERMINANTS OF HEALTH, THE ROOT CAUSES OF 28 HEALTH DISPARI-29 TIES IN MINORITY POPULATIONS THROUGHOUT NEW YORK STATE, IN ORDER TO DECREASE THE BURDEN OF DISEASE AND INJURY, INCLUDING PROGRAMS AND INITI-30 ATIVES THAT ARE ALREADY BEING UNDERTAKEN AND AN ANALYSIS OF THEIR EFFEC-31 32 TIVENESS.

33 S 3. This act shall take effect on the first of January next succeed-34 ing the date on which it shall have become a law; provided, however, 35 that effective immediately, the addition, amendment and/or repeal of any 36 rule or regulation necessary for the implementation of this act on its 37 effective date are authorized and directed to be made and completed on 38 or before such effective date.
