AN ACT to amend the election law, the criminal procedure law, the
correction law and the executive law, in relation to enacting the
"voting rights notification and registration act"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. Short title. This act shall be known and may be cited as
2 the "voting rights notification and registration act".
3 S 2. The opening paragraph and subdivisions 2, 4, 5, 8, 12, 13 and 14
4 of section 5-211 of the election law, the opening paragraph and subdivi-
5 sion 14 as amended by chapter 200 of the laws of 1996, subdivisions 2
6 and 8 as amended and subdivisions 4, 5, 12 and 13 as added by chapter
7 659 of the laws of 1994, are amended to read as follows:
8 Each agency designated as a participating agency under the provisions
9 of this section shall implement and administer a program of distribution
10 of voter registration forms pursuant to the provisions of this section.
11 The following offices which provide public assistance and/or provide
12 state funded programs primarily engaged in providing services to persons
13 with disabilities are hereby designated as voter registration agencies:
14 designated as the state agencies which provide public assistance are the
15 department of social services and the department of health. Also desig-
16 nated as public assistance agencies are all agencies of local government
17 that provide such assistance AND COUNTY PROBATION DEPARTMENTS. Desig-
18 nated as state agencies that provide programs primarily engaged in
19 providing services to people with disabilities are the department of
20 labor, office for the aging, division of veterans' affairs, office of
21 mental health, office of vocational and educational services for indi-

viduals with disabilities, commission on quality of care for the mentally disabled, office of mental retardation and developmental disabilities, commission for the blind and visually handicapped, office of alcoholism and substance abuse services, the office of the advocate for the disabled and all offices which administer programs established or funded by such agencies. Additional state agencies designated as voter registration offices are the department of state [and], the [division of] workers' compensation BOARD, THE DIVISION OF PROBATION AND CORRECTIONAL ALTERNATIVES WHEN PROVIDING DIRECT PROBATION SUPERVISION SERVICES UNDER SECTION TWO HUNDRED FORTY-SEVEN OF THE EXECUTIVE LAW. Such agencies shall be required to offer voter registration forms to persons upon initial application for services, renewal or recertification for services [and], change of address relating to such services, AND ORIENTATION OR INITIAL INTAKE FOR THE DIVISION OF PROBATION AND CORRECTIONAL ALTERNATIVES AND COUNTY PROBATION DEPARTMENTS. Such agencies shall also be responsible for providing assistance to [applicants] SUCH PERSONS in completing voter registration forms, receiving and transmitting the completed [application] REGISTRATION form from all [applicants] PERSONS who wish to have such form transmitted to the appropriate board of elections. The state board of elections shall, together with representatives of the department of defense, develop and implement procedures for including recruitment offices of the armed forces of the United States as voter registration offices when such offices are so designated by federal law. The state board shall also make request of the United States Immigration and Naturalization Service to include applications for registration by mail with any materials which are given to new citizens. All institutions of the state university of New York and the city university of New York, shall, at the beginning of the school year, and again in January of a year in which the president of the United States is to be elected, provide an application for registration to each student in each such institution. The state board of elections may, by regulation, grant a waiver from any or all of the requirements of this section to any office or program of an agency, if it determines that it is not feasible for such office or program to administer such requirement.

2. Strict neutrality with respect to a person's party enrollment shall be maintained and all persons seeking voter registration forms and information shall be advised that government services are not conditioned on being registered to vote. No statement shall be made nor any action taken to discourage the [applicant] PERSON from registering to vote.

4. Each participating agency shall provide to each [applicant] PERSON who does not decline to register to vote the same degree of assistance with regard to the completion of the VOTER registration [application] form as is provided by the agency with regard to the completion of its own form unless the [applicant] PERSON refuses such assistance.

5. Employees of a voter registration agency who provide voter registration assistance shall not:

(a) seek to influence [an applicant's] A PERSON'S political preference or party designation;

(b) display any political preference or party allegiance;

(c) make any statement [to an applicant] or take any action the purpose or effect of which is to discourage [the applicant] A PERSON from registering to vote; or

(d) make any statement [to an applicant] or take any action the purpose or effect of which is to lead [the applicant] A PERSON to

1 believe that a decision to register or not to register has any bearing
2 on the availability of services or benefits.

3 8. Each participating agency, department, division or office that
4 makes available voter registration forms pursuant to this section shall
5 offer with each application for the services or assistance of such agen-
6 cy, department, division or office, OR, IN THE CASE OF THE COUNTY
7 PROBATION DEPARTMENTS AND THE DIVISION OF PROBATION AND CORRECTIONAL
8 ALTERNATIVES, UPON ORIENTATION OR INITIAL INTAKE, and with each recer-
9 tification, renewal or change of address form relating to such service
10 or assistance, a VOTER registration form together with instructions
11 relating to eligibility to register and for completing the form except
12 that forms used by the department of social services for the initial
13 application for services, renewal or recertification for services and
14 change of address relating to such services shall physically incorporate
15 a voter registration [application] FORM in a fashion that permits the
16 voter registration portion of the agency form to be detached therefrom.
17 Such voter registration [application] FORM shall be designed so as to
18 ensure the confidentiality of the source of the application. Included
19 on each participating agency's application for services or assistance or
20 on a separate form shall be:

21 (a) the question, "If you are not registered to vote where you live
22 now, would you like to apply to register here today?"

23 (b) [The] THE statement, "applying to register or declining to regis-
24 ter to vote will not affect the amount of assistance that you will be
25 provided by this agency."

26 (c) boxes for the applicant to check to indicate whether the applicant
27 would like to register or decline to register to vote.

28 (d) the statement in prominent type, "IF YOU DO NOT CHECK EITHER BOX,
29 YOU WILL BE CONSIDERED TO HAVE DECIDED NOT TO REGISTER TO VOTE AT THIS
30 TIME."

31 (e) the statement, "If you would like help in filling out the voter
32 registration [application] form, we will help you. The decision whether
33 to seek or accept help is yours. You may fill out the [application]
34 VOTER REGISTRATION form in private."

35 (f) the statement, "If you believe that someone has interfered with
36 your right to register or decline to register to vote, your right to
37 privacy in deciding whether to register or in applying to register to
38 vote, or your right to choose your own political party or other politi-
39 cal preference, you may file a complaint with the state board of
40 elections (address and toll free telephone number)."

41 (g) a toll free number at the state board of elections that can be
42 called for answers to registration questions.

43 12. Completed [application] VOTER REGISTRATION forms, when received by
44 a participating agency not later than the twenty-fifth day before the
45 next ensuing primary, general or special election and transmitted by
46 such agency to the appropriate board of elections so that they are
47 received by such board not later than the twentieth day before such
48 election shall entitle the [applicant] PERSON to vote in such election
49 provided the board determines that the [applicant] PERSON is otherwise
50 qualified.

51 13. The state board of elections shall provide [application] VOTER
52 REGISTRATION forms for use pursuant to this section except that any
53 agency which uses a form other than such registration form shall be
54 responsible for providing such form. Forms which vary in design [and or]
55 AND/OR content from the form approved by the state board of elections
56 may only be used with the approval of such board.

1 14. [Applications] VOTER REGISTRATION FORMS shall be processed by the
2 board of elections in the manner prescribed by section 5-210 of this
3 title or, if the [applicant] PERSON is already registered to vote from
4 another address in the county or city, in the manner prescribed by
5 section 5-208 of this title. The board shall send the appropriate
6 notice of approval or rejection as required by either subdivision nine
7 of such section 5-210 or subdivision five of such section 5-208.

8 S 3. Section 220.50 of the criminal procedure law is amended by
9 adding a new subdivision 8 to read as follows:

10 8. PRIOR TO ACCEPTING A DEFENDANT'S PLEA OF GUILTY TO A COUNT OR
11 COUNTS OF AN INDICTMENT OR A SUPERIOR COURT INFORMATION CHARGING A FELONY
12 OFFENSE FOR WHICH THE COURT WILL IMPOSE A SENTENCE OF INCARCERATION,
13 THE COURT MUST ADVISE THE DEFENDANT ON THE RECORD THAT CONVICTION WILL
14 RESULT IN LOSS OF THE RIGHT TO VOTE UNTIL THE INDIVIDUAL HAS SERVED HIS
15 MAXIMUM SENTENCE OF INCARCERATION AND PAROLE. THE FAILURE TO ADVISE THE
16 DEFENDANT PURSUANT TO THIS SUBDIVISION SHALL NOT BE DEEMED TO AFFECT THE
17 VOLUNTARINESS OF A PLEA OF GUILTY OR THE VALIDITY OF A CONVICTION.

18 S 4. The criminal procedure law is amended by adding a new section
19 380.51 to read as follows:

20 S 380.51 STATEMENTS REGARDING VOTING RIGHTS.

21 BEFORE IMPOSING A SENTENCE OF INCARCERATION FOR A FELONY CONVICTION,
22 THE COURT MUST ADVISE THE DEFENDANT ON THE RECORD THAT THE CONVICTION
23 WILL RESULT IN THE LOSS OF THE RIGHT TO VOTE UNTIL THE INDIVIDUAL HAS
24 SERVED HIS MAXIMUM SENTENCE OF INCARCERATION AND PAROLE. THE FAILURE TO
25 ADVISE THE DEFENDANT PURSUANT TO THIS SECTION SHALL NOT BE DEEMED TO
26 AFFECT THE VOLUNTARINESS OF A PLEA OF GUILTY OR THE VALIDITY OF A
27 CONVICTION.

28 S 5. The correction law is amended by adding a new section 510 to read
29 as follows:

30 S 510. VOTING BY QUALIFIED INMATES. 1. AT THE TIME OF THE INITIAL
31 ORIENTATION OR INTAKE OF AN INMATE AT A LOCAL CORRECTIONAL FACILITY, THE
32 CHIEF ADMINISTRATIVE OFFICER OF SUCH LOCAL CORRECTIONAL FACILITY, OR HIS
33 OR HER DESIGNEE, SHALL INFORM THE INMATE IN WRITING OF HIS OR HER RIGHT
34 TO APPLY TO REGISTER TO VOTE. IN ADDITION, SUCH NOTICE SHALL BE PRINTED
35 IN BLOCK LETTERS AND POSTED IN A PROMINENT PLACE WHERE INMATES CONGREGATE.
36 SUCH POSTED NOTICE SHALL INCLUDE QUALIFICATIONS REQUIRED TO EXERCISE
37 THE RIGHT TO VOTE, AND THE AVAILABILITY AT THE CORRECTIONAL FACILITY
38 OF ASSISTANCE TO APPLY TO REGISTER TO VOTE, TO REQUEST AN ABSENTEE
39 BALLOT APPLICATION, AND TO VOTE BY ABSENTEE BALLOT. SUCH CHIEF ADMINISTRATIVE
40 OFFICER, OR HIS OR HER DESIGNEE, SHALL ASSIST INMATES IN APPLYING
41 TO REGISTER TO VOTE IN THE SAME MANNER AND TO THE SAME EXTENT AS THE
42 AGENCIES LISTED IN SECTION 5-211 OF THE ELECTION LAW.

43 2. ON AN ANNUAL BASIS, THIRTY DAYS BEFORE EACH PRIMARY AND GENERAL
44 ELECTION, THE CHIEF ADMINISTRATIVE OFFICER, OR HIS OR HER DESIGNEE,
45 SHALL PROVIDE EACH INMATE WITH WRITTEN INFORMATION ABOUT QUALIFICATIONS
46 AND PROCEDURES FOR VOTING BY ABSENTEE BALLOT AND SHALL MAKE ABSENTEE
47 BALLOT APPLICATIONS AVAILABLE TO ALL INMATES.

48 IN THE EVENT THAT AN INMATE OF A LOCAL CORRECTIONAL FACILITY IS TEMPORARILY
49 ABSENT FROM SUCH FACILITY, INCLUDING, BUT NOT LIMITED TO, INMATES
50 RECEIVING MEDICAL CARE AT A LOCAL HEALTH CARE FACILITY, THE INFORMATION
51 REQUIRED UNDER THIS SECTION SHALL BE MAILED TO SUCH INMATE.

52 S 6. Section 8-406 of the election law, as amended by chapter 296 of
53 the laws of 1988, is amended to read as follows:

54 S 8-406. Absentee ballots, delivery of. If the board shall find that
55 the applicant is a qualified voter of the election district containing
56 his residence as stated in his statement and that his statement is

1 sufficient, it shall, as soon as practicable after it shall have deter-
2 mined his right thereto, mail to him at an address designated by him, or
3 deliver to him, or to any person designated for such purpose in writing
4 by him, at the office of the board, such an absentee voter's ballot or
5 set of ballots and an envelope therefor. If the ballot or ballots are to
6 be sent outside of the United States to a country other than Canada or
7 Mexico, such ballot or ballots shall be sent by air mail. However, if an
8 applicant who is eligible for an absentee ballot is a resident of a
9 facility operated or licensed by, or under the jurisdiction of, the
10 department of mental hygiene, or a resident of a facility defined as a
11 nursing home or residential health care facility pursuant to subdivi-
12 sions two and three of section two thousand eight hundred one of the
13 public health law, or a resident of a hospital or other facility oper-
14 ated by the Veteran's Administration of the United States, OR AN INMATE
15 OF A LOCAL CORRECTIONAL FACILITY AS DEFINED BY SUBDIVISION SIXTEEN OF
16 SECTION TWO OF THE CORRECTION LAW, such absentee ballot need not be so
17 mailed or delivered to any such applicant but, may be delivered to the
18 voter in the manner prescribed by section 8-407 of this [chapter] TITLE
19 if such facility is located in the county or city in which such voter is
20 eligible to vote.

21 S 7. The section heading and subdivisions 1 and 3 of section 8-407 of
22 the election law, the section heading as added by chapter 296 of the
23 laws of 1988 and subdivisions 1 and 3 as amended by chapter 195 of the
24 laws of 2001, are amended to read as follows:

25 Voting by residents of nursing homes, residential health care facili-
26 ties, facilities operated or licensed, or under the jurisdiction of, the
27 department of mental hygiene or hospitals or facilities operated by the
28 Veteran's Administration of the United States, OR BY INMATES OF LOCAL
29 CORRECTIONAL FACILITIES.

30 1. The board of elections of a county or city in which there is
31 located at least one facility operated or licensed, or under the juris-
32 diction of, the department of mental hygiene, or a facility defined as a
33 nursing home or residential health care facility pursuant to subdivi-
34 sions two and three of section two thousand eight hundred one of the
35 public health law or an adult care facility subject to the provisions of
36 title two of article seven of the social services law, or a hospital or
37 other facility operated by the Veteran's Administration of the United
38 States, OR A LOCAL CORRECTIONAL FACILITY AS DEFINED BY SUBDIVISION
39 SIXTEEN OF SECTION TWO OF THE CORRECTION LAW, shall provide that resi-
40 dents OR INMATES of each such facility for which such board has received
41 [twenty-five] FIFTEEN or more applications for absentee ballots from
42 voters who are eligible to vote by absentee ballot in such city or coun-
43 ty at such election, may vote by absentee ballot only in the manner
44 provided for in this section. Such board may, in its discretion, provide
45 that the procedure described in this subdivision shall be applicable to
46 all such facilities in such county or city without regard to the number
47 of absentee ballot applications received from the residents of any such
48 facility.

49 3. Not earlier than thirteen days before or later than the day before
50 such an election such a board of inspectors shall, between the hours of
51 nine o'clock in the morning and five o'clock in the evening, attend at
52 each such facility for the residents OR INMATES of which the board of
53 elections has custody of [twenty-five] FIFTEEN or more absentee ballots
54 or, if the board of elections has so provided, each such facility for
55 which the board has custody of one or more such absentee ballots, pursu-
56 ant to the provisions of this chapter.

1 S 8. The correction law is amended by adding a new section 75 to read
2 as follows:

3 S 75. VOTING RIGHTS UPON COMPLETION OF SENTENCE. 1. UPON THE DISCHARGE
4 FROM A CORRECTIONAL FACILITY OF ANY PERSON WHO HAS REACHED HIS OR HER
5 MAXIMUM SENTENCE OF IMPRISONMENT FOR THE CONVICTION OF A FELONY, THE
6 DEPARTMENT, AND, SUBJECT TO THEIR AGREEMENT, FEDERAL CORRECTIONAL INSTI-
7 TUTIONS IN NEW YORK, SHALL NOTIFY SUCH PERSON OF HIS OR HER RIGHT TO
8 VOTE, PROVIDE SUCH PERSON WITH A FORM OF APPLICATION FOR VOTER REGISTRA-
9 TION TOGETHER WITH WRITTEN INFORMATION DISTRIBUTED BY THE BOARD OF
10 ELECTIONS ON THE IMPORTANCE AND THE MECHANICS OF VOTING AND SHALL ASSIST
11 SUCH PERSON IN REGISTERING TO VOTE IN THE SAME MANNER AND TO THE SAME
12 EXTENT AS THE AGENCIES LISTED IN SECTION 5-211 OF THE ELECTION LAW.

13 2. THE DEPARTMENT AND, SUBJECT TO THEIR AGREEMENT, FEDERAL CORRECTION-
14 AL INSTITUTIONS IN NEW YORK, SHALL, ON OR BEFORE THE FIFTEENTH DAY OF
15 EACH MONTH, TRANSMIT TO THE STATE BOARD OF ELECTIONS A LIST CONTAINING
16 THE FOLLOWING INFORMATION ABOUT PERSONS AGE EIGHTEEN OR OLDER WHO,
17 DURING THE PRECEDING PERIOD, HAVE BECOME ELIGIBLE TO VOTE BECAUSE OF
18 THEIR DISCHARGE FROM INCARCERATION: (A) NAME; (B) DATE OF BIRTH; (C)
19 LAST KNOWN ADDRESS WITH COUNTY OF RESIDENCE; AND (D) DRIVER'S LICENSE
20 NUMBER (IF KNOWN) OR LAST FOUR DIGITS OF SOCIAL SECURITY NUMBER (IF
21 KNOWN).

22 S 9. The executive law is amended by adding a new section 259-jj to
23 read as follows:

24 S 259-JJ. VOTING RIGHTS UPON DISCHARGE. 1. UPON DISCHARGE OF A PERSON
25 FROM PRESUMPTIVE RELEASE, PAROLE, OR CONDITIONAL RELEASE, OR UPON THE
26 EXPIRATION OF A PERSON'S MAXIMUM SENTENCE OF IMPRISONMENT WHILE UNDER
27 THE SUPERVISION OF THE DIVISION OF PAROLE, THE DIVISION OF PAROLE SHALL
28 NOTIFY SUCH PERSON OF HIS OR HER RIGHT TO VOTE, PROVIDE SUCH PERSON WITH
29 A FORM OF APPLICATION FOR VOTER REGISTRATION TOGETHER WITH WRITTEN
30 INFORMATION DISTRIBUTED BY THE BOARD OF ELECTIONS ON THE IMPORTANCE AND
31 THE MECHANICS OF VOTING AND SHALL ASSIST SUCH PERSON IN REGISTERING TO
32 VOTE IN THE SAME MANNER AND TO THE SAME EXTENT AS THE AGENCIES LISTED IN
33 SECTION 5-211 OF THE ELECTION LAW.

34 2. THE DIVISION OF PAROLE SHALL, ON OR BEFORE THE FIFTEENTH DAY OF
35 EACH MONTH, TRANSMIT TO THE STATE BOARD OF ELECTIONS A LIST CONTAINING
36 THE FOLLOWING INFORMATION ABOUT PERSONS AGE EIGHTEEN OR OLDER WHO,
37 DURING THE PRECEDING PERIOD, HAVE BECOME ELIGIBLE TO VOTE BECAUSE OF
38 THEIR DISCHARGE FROM PRESUMPTIVE RELEASE, PAROLE OR CONDITIONAL RELEASE,
39 OR UPON THE EXPIRATION OF THEIR MAXIMUM SENTENCE OF IMPRISONMENT WHILE
40 UNDER THE SUPERVISION OF THE DIVISION OF PAROLE: (A) NAME; (B) DATE OF
41 BIRTH; (C) LAST KNOWN ADDRESS WITH COUNTY OF RESIDENCE; AND (D) DRIVER'S
42 LICENSE NUMBER (IF KNOWN) OR LAST FOUR DIGITS OF SOCIAL SECURITY NUMBER
43 (IF KNOWN).

44 S 10. Section 5-614 of the election law is amended by adding three new
45 subdivisions 6-a, 6-b and 6-c to read as follows:

46 6-A. ONCE EVERY MONTH, AND WITHIN FIVE DAYS OF RECEIPT, THE STATE
47 BOARD OF ELECTIONS SHALL OBTAIN AND TRANSMIT TO LOCAL BOARDS OF
48 ELECTIONS THE INFORMATION PROVIDED BY THE DEPARTMENT OF CORRECTIONAL
49 SERVICES PURSUANT TO SUBDIVISION TWO OF SECTION SEVENTY-FIVE OF THE
50 CORRECTION LAW, AND BY THE DIVISION OF PAROLE PURSUANT TO SUBDIVISION
51 TWO OF SECTION TWO HUNDRED FIFTY-NINE-JJ OF THE EXECUTIVE LAW.

52 6-B. EACH LOCAL BOARD OF ELECTIONS SHALL USE SUCH LIST, WITHIN TEN
53 DAYS AFTER RECEIPT, TO ENSURE THAT THERE ARE NO REMAINING BARRIERS TO
54 REGISTRATION, INCLUDING THE USE OF ELECTRONIC CODES OR OTHER FORMS OF
55 ELIGIBILITY DEMARCATION, RESULTING FROM PAST CONVICTIONS OF THE PEOPLE
56 SO LISTED.

6-C. ANY VOTER REGISTRATION APPLICATION THAT WAS REJECTED AFTER THE EFFECTIVE DATE OF THIS SUBDIVISION AND PRIOR TO THE LOCAL BOARD'S RECEIPT AND PROCESSING OF THE INFORMATION DESCRIBED IN SUBDIVISIONS SIX-A AND SIX-B OF THIS SECTION SHALL BE REVIEWED UPON RECEIPT AND PROCESSING OF SUCH INFORMATION. ANY APPLICANT THAT IS FOUND TO BE ELIGIBLE, SHALL BE APPROVED AND THE VOTER SHALL BE REGISTERED AND SO NOTIFIED.

S 11. The election law is amended by adding a new section 3-102-a to read as follows:

S 3-102-A. STATE BOARD OF ELECTIONS; DUTIES UNDER THE VOTING RIGHTS NOTIFICATION AND REGISTRATION ACT. 1. THE STATE BOARD OF ELECTIONS SHALL DEVELOP AND IMPLEMENT A PROGRAM TO EDUCATE ATTORNEYS; JUDGES; ELECTION OFFICIALS; CORRECTIONS OFFICIALS, INCLUDING PAROLE AND PROBATION OFFICERS; AND MEMBERS OF THE PUBLIC ABOUT THE REQUIREMENTS OF THE VOTING RIGHTS NOTIFICATION AND REGISTRATION ACT, ENSURING THAT:

(A) JUDGES ARE INFORMED OF THEIR OBLIGATION TO NOTIFY CRIMINAL DEFENDANTS OF THE POTENTIAL LOSS AND RESTORATION OF THEIR VOTING RIGHTS, IN ACCORDANCE WITH SUBDIVISION EIGHT OF SECTION 220.50 AND SECTION 380.51 OF THE CRIMINAL PROCEDURE LAW;

(B) THE DEPARTMENT OF CORRECTIONAL SERVICES AND, SUBJECT TO THEIR AGREEMENT, FEDERAL CORRECTIONAL INSTITUTIONS IN NEW YORK, ARE PREPARED TO ASSIST PEOPLE TO REGISTER TO VOTE IN ANTICIPATION OF THEIR DISCHARGE FROM INCARCERATION, INCLUDING BY FORWARDING THEIR COMPLETED VOTER REGISTRATION FORMS TO THE LOCAL ELECTION BOARDS;

(C) THE DEPARTMENT OF CORRECTIONAL SERVICES AND, SUBJECT TO THEIR AGREEMENT, FEDERAL CORRECTIONAL INSTITUTIONS IN NEW YORK, AND THE DIVISION OF PAROLE, ARE PREPARED TO TRANSMIT TO THE STATE BOARD OF ELECTIONS THE INFORMATION SPECIFIED IN SUBDIVISION TWO OF SECTION SEVENTY-FIVE OF THE CORRECTION LAW AND SUBDIVISION TWO OF SECTION TWO HUNDRED FIFTY-NINE-JJ OF THE EXECUTIVE LAW;

(D) LOCAL CORRECTIONAL FACILITIES ARE PREPARED TO ASSIST PEOPLE TO REGISTER TO VOTE INCLUDING BY FORWARDING THEIR COMPLETED VOTER REGISTRATION FORMS, ABSENTEE BALLOT APPLICATIONS AND COMPLETED ABSENTEE BALLOTS TO THE LOCAL ELECTION BOARDS;

(E) PROBATION AND PAROLE OFFICERS ARE INFORMED OF THE CHANGES IN THE LAW AND ARE PREPARED TO NOTIFY PROBATIONERS AND PAROLEES OF THEIR VOTING RIGHTS;

(F) THE LANGUAGE ON VOTER REGISTRATION FORMS MAKES CLEAR THAT PEOPLE ARE DISQUALIFIED FROM VOTING ONLY WHILE THEY ARE SERVING SENTENCES OF INCARCERATION OR PAROLE ON FELONY CONVICTIONS AND THAT THEY REGAIN THE RIGHT TO REGISTER TO VOTE UPON COMPLETION OF THEIR MAXIMUM SENTENCE;

(G) ALL LOCAL BOARDS OF ELECTIONS ARE PREPARED TO RESTORE NAMES TO THE COMPUTERIZED STATEWIDE VOTER REGISTRATION LIST IN ACCORDANCE WITH SECTION 5-614 OF THE ELECTION LAW; AND

(H) ACCURATE AND COMPLETE INFORMATION ABOUT THE VOTING RIGHTS OF PEOPLE WHO HAVE BEEN CHARGED WITH OR CONVICTED OF CRIMES IS MADE AVAILABLE THROUGH A SINGLE PUBLICATION TO GOVERNMENT OFFICIALS AND THE PUBLIC.

2. THE STATE BOARD OF ELECTIONS SHALL AMEND OR PROMULGATE PERTINENT RULES AND REGULATIONS AS NECESSARY TO IMPLEMENT THIS SECTION.

S 12. This act shall take effect on the ninetieth day after it shall have become a law.
