AN ACT to amend the vehicle and traffic law, in relation to the right-  
of-way of vehicles participating in a funeral procession

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-  
BLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The vehicle and traffic law is amended by adding a new  
2 section 1144-a to read as follows:  
3 S 1144-A. OPERATION OF VEHICLES ON APPROACH OF VEHICLES IN A FUNERAL  
4 PROCESSION. (A) UPON THE IMMEDIATE APPROACH OF A VEHICLE WHICH (I) HAS  
5 A BLACK FLAG WITH THE WORD "FUNERAL" AFFIXED TO IT IN THE MANNER  
6 PROVIDED FOR IN PARAGRAPH (FF) OF SUBDIVISION TWELVE-A OF SECTION THREE  
7 HUNDRED SEVENTY-FIVE OF THIS CHAPTER, AND (II) HAS THOSE LIGHTS COMMONLY  
8 REFERRED TO AS "HAZARD" OR "FLASHING" LIGHTS TURNED ON AND OPERATING,  
9 THE DRIVER OF EVERY OTHER VEHICLE SHALL YIELD THE RIGHT-OF-WAY AND SHALL  
10 IMMEDIATELY DRIVE TO A POSITION PARALLEL TO, AND AS CLOSE AS POSSIBLE  
11 TO, THE RIGHT-HAND EDGE OR CURB OF THE ROADWAY, OR TO EITHER EDGE OF A  
12 ONE-WAY ROADWAY THREE OR MORE LANES IN WIDTH, CLEAR OF ANY INTERSECTION,  
13 AND SHALL STOP AND REMAIN IN SUCH POSITION UNTIL THE VEHICLE DISPLAYING  
14 SUCH FLAG HAS PASSED, UNLESS OTHERWISE DIRECTED BY A POLICE OFFICER.  
15 (B) THIS SECTION SHALL NOT OPERATE TO RELIEVE THE DRIVER OF A VEHICLE  
16 DISPLAYING SUCH A FLAG FROM THE DUTY TO DRIVE WITH REASONABLE CARE FOR  
17 ALL PERSONS USING THE HIGHWAY.  
18 (C) ANY PERSON OPERATING A VEHICLE IN ACCORDANCE WITH THE PROVISIONS  
19 OF THIS SECTION SHALL NEVERTHELESS YIELD THE RIGHT-OF-WAY TO AN AUTHOR-  
20 IZED EMERGENCY VEHICLE ENGAGED IN EMERGENCY OPERATION WITH ITS SIREN OR  
21 LIGHTS ACTIVATED.  
22 S 2. This act shall take effect immediately.
