AN ACT to amend the social services law, in relation to offering applicants and recipients of public assistance information regarding sexual assault

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Legislative findings and purposes. The legislature finds
2 that a disproportionately large number of public assistance recipients
3 have been victims of sexual assault. Studies have estimated that as many
4 as 40 percent of all individuals receiving public assistance were sexu-
5 ally abused as children. These victims frequently face significant
6 barriers to self-sufficiency due to their history of sexual abuse. These
7 barriers may include mental illness, substance abuse problems and domes-
8 tic violence issues. It is therefore the intent and purpose of this act
9 to increase outreach to this population and expand access to essential
10 services necessary for victims of sexual assault to overcome the phys-
11 ical, mental and emotional trauma associated with such forms of abuse.
12 S 2. Section 131 of the social services law is amended by adding a new
13 subdivision 20 to read as follows:
14 20. IN ACCORDANCE WITH THE PROVISIONS OF THIS SUBDIVISION AND THE
15 REGULATIONS OF THE OFFICE OF TEMPORARY AND DISABILITY ASSISTANCE, SOCIAL
16 SERVICES DISTRICTS SHALL MAKE ALL APPLICANTS FOR AND RECIPIENTS OF
17 PUBLIC ASSISTANCE AWARE OF THEIR OPTION TO RECEIVE AN INFORMATION PACKET
18 APPROPRIATE FOR VICTIMS OF SEXUAL ASSAULT. SUCH INFORMATION PACKET
19 SHALL BE MADE AVAILABLE TO ALL INDIVIDUALS WHO DEMONSTRATE A NEED FOR OR
20 WHO ARE INTERESTED IN RECEIVING SERVICES APPROPRIATE FOR VICTIMS OF
21 SEXUAL ASSAULT, AND SHALL INCLUDE REFERRAL AND CONTACT INFORMATION FOR

4 HOSPITALS OFFERING SEXUAL ASSAULT FORENSIC EXAMINER SERVICES CERTIFIED
5 BY THE DEPARTMENT OF HEALTH;
6 (B) RAPE CRISIS CENTERS; AND
7 (C) OTHER ADVOCACY, COUNSELING, AND HOTLINE SERVICES APPROPRIATE FOR
8 VICTIMS OF SEXUAL ASSAULT.
9 S 3. This act shall take effect on the one hundred eightieth day after
10 it shall have become a law.
