- (c) Include [recommendation] RECOMMENDATIONS for expanding or replicating service programs that have been determined effective in helping needy elderly remain in the community and to avoid institutional care[.], INCLUDING RECOMMENDATIONS FOR TRADITIONALLY UNDERSERVED AGED POPULATIONS, INCLUDING, BUT NOT LIMITED TO, POPULATIONS BASED ON RACE, CREED, COLOR, NATIONAL ORIGIN, SEXUAL ORIENTATION, GENDER IDENTITY OR EXPRESSION, MILITARY STATUS, SEX, MARITAL STATUS, DISABILITY, FAMILIAL STATUS, AND LANGUAGE; AND
