

1 1. "COMMERCIAL PURPOSES" MEANS EITHER:

2 (A) A DISPLAY FOR WHICH THE PUBLIC IS CHARGED A FEE OR OTHER CONSIDER-
3 ATION AS A CONDITION OF VIEWING; OR

4 (B) A DISPLAY FOR WHICH AN EXHIBITOR ACCEPTS PAYMENT OR OTHER CONSID-
5 ERATION.

6 2. "EXHIBITOR" MEANS A PERSON OR ENTITY WHO SHOWS OR PUTS ON, OR
7 CONTRACTS TO SHOW OR PUT ON, A TEMPORARY PUBLIC DISPLAY OF HUMAN
8 REMAINS.

9 3. "MUSEUM FACILITY" MEANS A PUBLIC OR PRIVATE NONPROFIT INSTITUTION
10 THAT IS ACCREDITED THE AMERICAN ASSOCIATION OF MUSEUMS OR IS A PART OF
11 AN ACCREDITED COLLEGE OR UNIVERSITY, AND THAT IS ORGANIZED ON A PERMA-
12 NENT BASIS FOR ESSENTIALLY EDUCATIONAL OR AESTHETIC PURPOSES AND THAT
13 OWNS OR USES TANGIBLE OBJECTS, CARES FOR THOSE OBJECTS, AND EXHIBITS
14 THEM TO THE GENERAL PUBLIC ON A REGULAR BASIS.

15 S 4381. COMMERCIAL DISPLAY OF HUMAN REMAINS. 1. EXCEPT AS PROVIDED IN
16 SUBDIVISION TWO OF THIS SECTION, A PERSON SHALL NOT DISPLAY HUMAN
17 REMAINS TO THE PUBLIC FOR COMMERCIAL PURPOSES WITHOUT FIRST OBTAINING A
18 PERMIT ISSUED BY THE DEPARTMENT AS REQUIRED BY SECTION FORTY-THREE
19 HUNDRED EIGHTY-TWO OF THIS ARTICLE.

20 2. SUBDIVISION ONE OF THIS SECTION SHALL NOT APPLY TO A DISPLAY OF
21 HUMAN REMAINS THAT IS ANY OF THE FOLLOWING:

22 (A) MORE THAN ONE HUNDRED YEARS OLD;

23 (B) CONSISTING SOLELY OF HUMAN TEETH OR HAIR;

24 (C) PART OF THE ORDINARY DISPLAY OR VIEWING OF THE DECEASED AT A
25 FUNERAL ESTABLISHMENT OR PART OF A SIMILAR FUNERAL OR MEMORIAL SERVICE;

26 (D) AN OBJECT OF RELIGIOUS VENERATION;

27 (E) CONSISTING SOLELY OF BODIES TRANSPORTED INTO AND REMAINING IN THE
28 STATE FOR DISPLAY PRIOR TO THE EFFECTIVE DATE OF THIS SECTION; OR

29 (F) IN THE POSSESSION OF A MUSEUM FACILITY.

30 HOWEVER, IF THE MUSEUM FACILITY PAID OR OFFERED OTHER CONSIDERATION TO
31 AN EXHIBITOR TO DISPLAY THE REMAINS, AND THE REMAINS ARE NOT EXEMPT FROM
32 THIS SECTION PURSUANT TO PARAGRAPHS (A) THROUGH (D) OF THIS SUBDIVISION,
33 THE EXHIBITOR SHALL BE REQUIRED TO OBTAIN A PERMIT PURSUANT TO SECTION
34 FORTY-THREE HUNDRED EIGHTY-TWO OF THIS ARTICLE.

35 3. ANY PERSON WHO VIOLATES THIS SECTION SHALL BE SUBJECT TO A CIVIL
36 PENALTY OF AN AMOUNT THAT DOES NOT EXCEED TEN THOUSAND DOLLARS FOR EACH
37 VIOLATION.

38 S 4382. PERMIT. THE DEPARTMENT SHALL ESTABLISH A PERMIT PROGRAM UNDER
39 THIS ARTICLE. A PERMIT MAY BE ISSUED TO ANY PERSON FOR THE PURPOSE
40 DESCRIBED IN SECTION FORTY-THREE HUNDRED EIGHTY-ONE OF THIS ARTICLE ONLY
41 UPON A DETERMINATION BY THE DEPARTMENT THAT THE PERSON HAS PROVIDED
42 VALID WRITTEN AUTHORIZATION TO DISPLAY HUMAN REMAINS FOR CONSIDERATION
43 FROM ANY OF THE FOLLOWING INDIVIDUALS:

44 1. THE DECEDENT, INCLUDING, BUT NOT LIMITED TO, AUTHORIZATION GIVEN BY
45 WILL;

46 2. ANY PERSON AUTHORIZED TO MAKE AN ANATOMICAL GIFT UNDER ARTICLE
47 FORTY-THREE OF THIS CHAPTER.

48 S 4383. APPLICATION. NOTHING IN THIS ARTICLE SHALL BE CONSTRUED TO
49 APPLY TO THE UTILIZATION OF HUMAN REMAINS IN A MANNER THAT MEETS THE
50 PURPOSES SET FORTH IN ARTICLE FORTY-THREE OF THIS CHAPTER RELATING TO
51 ANATOMICAL GIFTS.

52 S 3. This act shall take effect on the ninetieth day after it shall
53 have become a law. Effective immediately the commissioner of the depart-
54 ment of health is authorized to promulgate any and all rules and regu-
55 lations and take any other measures necessary to implement this act on
56 its effective date, on or before such date.
