AN ACT to amend the vehicle and traffic law, in relation to certain requirements for obtaining a driver's license

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 1 of section 502 of the vehicle and traffic 2 law, as amended by chapter 639 of the laws of 2006, is amended to read 3 as follows:

4 1. Application for license. Application for a driver's license shall be made to the commissioner. The fee prescribed by law may be submitted 5 with such application. The applicant shall furnish such proof of identi-6 7 ty, age, and fitness as may be required by the commissioner. The commissioner may also provide that the application procedure shall include the 8 taking of a photo image or images of the applicant in accordance with 9 10 rules and regulations prescribed by the commissioner. In addition, the commissioner also shall require that the applicant provide his or her 11 12 social security number OR THE INDIVIDUAL TAX IDENTIFICATION NUMBER WHERE 13 SUCH APPLICANT IS A LEGAL IMMIGRANT and provide space on the application the applicant may register in the New York state organ and 14 SO that 15 tissue donor registry under section forty-three hundred ten of the public health law. In addition, an applicant for a commercial driver's 16 17 license who will operate a commercial motor vehicle in interstate 18 commerce shall certify that such applicant meets the requirements to 19 operate a commercial motor vehicle, as set forth in public law 99-570, title XII, and title 49 of the code of federal regulations, and all 20 21 regulations promulgated by the United States secretary of transportation 22 under the hazardous materials transportation act. Upon a determination 23 the holder of a commercial driver's license has made any false that

1 statement, with respect to the application for such license, the commis-2 sioner shall revoke such license.

3 S 2. Paragraph (a) of subdivision 6 of section 502 of the vehicle and 4 traffic law, as amended by chapter 81 of the laws of 1995, is amended to 5 read as follows:

6 (a) A license issued pursuant to subdivision five of this section 7 shall be valid until the expiration date contained thereon, unless such license is suspended, revoked or cancelled. Such license may be renewed 8 submission of an application for renewal, the fee prescribed by law, 9 by 10 proofs of prior licensing, fitness and acceptable vision prescribed by the commissioner, the applicant's social security number OR THE INDIVID-11 UAL TAX IDENTIFICATION NUMBER WHERE SUCH APPLICANT IS A LEGAL IMMIGRANT, 12 13 required by the commissioner a photo image of the applicant in and if 14 such numbers and form as the commissioner shall prescribe. In addition, 15 an applicant for renewal of a license containing a hazardous material 16 endorsement shall pass an examination to retain such endorsement. A 17 renewal of such license shall be issued by the commissioner upon approval of such application, 18 except that no such license shall be issued if its issuance would be inconsistent with the provisions of 19 section five hundred sixteen of this [chapter] TITLE, and except that 20 21 the commissioner may refuse to renew such license if the applicant is 22 holder of a currently valid or renewable license to drive issued by the 23 another state or foreign country unless the applicant surrenders such 24 license.

25 S 3. This act shall take effect on the ninetieth day after it shall 26 have become a law.
