AN ACT to amend the state finance law, in relation to establishing the
witness protection fund and making an appropriation therefor

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. The state finance law is amended by adding a new section
2 89-h to read as follows:

3 S 89-H. WITNESS PROTECTION FUND. 1. THERE IS HEREBY ESTABLISHED IN
4 THE JOINT CUSTODY OF THE STATE COMPTROLLER AND THE COMMISSIONER OF THE
5 DEPARTMENT OF TAXATION AND FINANCE A SPECIAL REVENUE FUND TO BE KNOWN AS
6 THE "WITNESS PROTECTION FUND".

7 2. THE WITNESS PROTECTION FUND SHALL CONSIST OF: (A) FIVE PERCENT OF
8 ALL THE MONEYS RECEIVED BY THE STATE PURSUANT TO SECTION 60.35 OF THE
9 PENAL LAW AND FIVE PERCENT OF ALL THE MONEYS RECEIVED BY THE STATE
10 PURSUANT TO SECTION EIGHTEEN HUNDRED NINE OF THE VEHICLE AND TRAFFIC LAW
11 FROM ANY COURT OF THE UNIFIED COURT SYSTEM OTHER THAN TOWN OR VILLAGE
12 COURTS;

13 (B) TEN PERCENT OF ALL THE MONEYS DEPOSITED TO THE CREDIT OF THE STATE
14 POLICE SEIZED ASSETS ACCOUNT IN EACH CALENDAR YEAR; AND

15 (C) ALL OTHER FEES, FINES, GRANTS, BEQUESTS OR OTHER MONIES CREDITED,
16 APPROPRIATED OR TRANSFERRED THERETO FROM ANY OTHER FUND OR SOURCE PURSU-
17 ANT TO LAW OR ANY OTHER MONEYS MADE AVAILABLE FOR THE PURPOSES OF THE
18 FUND.

19 3. MONEYS OF THE WITNESS PROTECTION FUND, FOLLOWING APPROPRIATION BY
20 THE LEGISLATURE AND ALLOCATION BY THE DIRECTOR OF THE BUDGET, SHALL BE
21 MADE AVAILABLE TO THE DIVISION OF CRIMINAL JUSTICE SERVICES FOR LOCAL
22 ASSISTANCE SERVICES AND EXPENSES OF PROGRAMS TO PROVIDE WITNESS
23 PROTECTION SERVICES TO WITNESSES OF CRIMES.

1 4. THE MONEYS OF THE FUND SHALL BE PAID OUT ON THE AUDIT AND WARRANT
2 OF THE STATE COMPTROLLER ON VOUCHERS CERTIFIED OR APPROVED BY THE
3 COMMISSIONER OF THE DIVISION OF CRIMINAL JUSTICE SERVICES. AT THE END OF
4 EACH YEAR, ANY MONEYS REMAINING IN THE FUND SHALL BE RETURNED TO THE
5 FUND AND SHALL NOT REVERT TO THE GENERAL FUND. THE INTEREST AND INCOME
6 EARNED ON MONEY IN THE FUND, AFTER DEDUCTING ANY APPLICABLE CHARGES,
7 SHALL BE CREDITED TO THE FUND.

8 S 2. The sum of five million dollars (\$5,000,000), or so much thereof
9 as may be necessary, is hereby appropriated to the witness protection
10 fund, established pursuant to section 89-h of the state finance law as
11 added by section one of this act, out of any moneys in the state treas-
12 ury in the general fund to the credit of the local assistance account
13 not otherwise appropriated, for local assistance services and expenses
14 of programs to provide witness protection services to witnesses of
15 crimes.

16 S 3. This act shall take effect immediately.
