- AN ACT to amend the penal law, in relation to criminal street gang recruitment on school grounds; and to amend the highway law, in relation to authorizing the placement of gang free school zone signs

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 460.10 of the penal law is amended by adding four 2 new subdivisions 5, 6, 7 and 8 to read as follows:

5. "CRIMINAL STREET GANG" MEANS ANY ONGOING ORGANIZATION, ASSOCIATION, OR GROUP OF THREE OR MORE PERSONS, WHETHER FORMAL OR INFORMAL, HAVING AS ONE OF ITS PRIMARY ACTIVITIES THE COMMISSION OF ONE OR MORE CRIMINAL ACTS, WHICH HAS AN IDENTIFIABLE NAME OR IDENTIFYING SIGN OR SYMBOL, AND WHOSE MEMBERS INDIVIDUALLY OR COLLECTIVELY ENGAGE IN OR HAVE ENGAGED IN CRIMINAL STREET GANG ACTIVITY.

9 6. "CRIMINAL STREET GANG MEMBER" MEANS A PERSON TO WHOM TWO OR MORE OF 10 THE FOLLOWING CRITERIA APPLY:

11 (A) ADMITS TO CRIMINAL STREET GANG MEMBERSHIP;

12 (B) IS IDENTIFIED AS A CRIMINAL STREET GANG MEMBER BY A DOCUMENTED 13 RELIABLE INFORMANT;

(C) RESIDES IN OR FREOUENTS A PARTICULAR CRIMINAL STREET GANG'S AREA 1 2 AND ADOPTS ITS STYLE OF DRESS, ITS USE OF HAND SIGNALS OR ITS TATTOOS 3 AND ASSOCIATES WITH KNOWN CRIMINAL STREET GANG MEMBERS; 4 (D) HAS BEEN ARRESTED MORE THAN ONCE IN THE COMPANY OF KNOWN CRIMINAL 5 STREET GANG MEMBERS FOR OFFENSES WHICH ARE CONSISTENT WITH USUAL CRIMI-6 NAL STREET GANG ACTIVITY; 7 IS IDENTIFIED AS A CRIMINAL STREET GANG MEMBER BY PHYSICAL (E) 8 EVIDENCE, SUCH AS PHOTOGRAPHS OR OTHER DOCUMENTATION; 9 (F) HAS BEEN STOPPED IN THE COMPANY OF KNOWN CRIMINAL STREET GANG 10 MEMBERS FOUR OR MORE TIMES; HAS BEEN IDENTIFIED AS A CRIMINAL STREET GANG MEMBER BY OTHER LAW 11 (G) 12 ENFORCEMENT AGENCIES; OR 13 (H) IS IDENTIFIED AS A CRIMINAL STREET GANG MEMBER BY A FAMILY MEMBER. 14 7. "CRIMINAL STREET GANG ACTIVITY" MEANS THE COMMISSION OR ATTEMPTED 15 COMMISSION OF, OR SOLICITATION OR CONSPIRACY TO COMMIT, TWO OR MORE CRIMINAL ACTS THAT: 16 17 (A) WERE COMMITTED ON SEPARATE OCCASIONS WITHIN A FIVE YEAR PERIOD; (B) ARE NEITHER ISOLATED INCIDENTS, NOR SO CLOSELY RELATED AND 18 19 CONNECTED IN POINT OF TIME OR CIRCUMSTANCE OF COMMISSION AS TO CONSTI-TUTE A CRIMINAL OFFENSE OR CRIMINAL TRANSACTION, AS SUCH TERMS ARE 20 21 DEFINED IN SECTION 40.10 OF THE CRIMINAL PROCEDURE LAW; AND 22 FURTHER A CRIMINAL STREET GANG BY: (I) BEING RELATED TO ONE (C) 23 ANOTHER THROUGH A COMMON SCHEME OR PLAN; OR (II) WERE COMMITTED, SOLIC-24 ITED, REQUESTED, IMPORTUNED OR INTENTIONALLY AIDED BY PERSONS ACTING 25 WITH THE MENTAL CULPABILITY REQUIRED FOR THE COMMISSION OF SUCH CRIMINAL 26 ACTS AND SUCH PERSON IS A MEMBER OF SUCH CRIMINAL STREET GANG. 27 8. "SCHOOL GROUNDS" MEANS (A) IN OR ON OR WITHIN ANY BUILDING, STRUC-28 TURE, ATHLETIC PLAYING FIELD, PLAYGROUND OR LAND CONTAINED WITHIN THE REAL PROPERTY BOUNDARY LINE OF A PUBLIC OR PRIVATE ELEMENTARY, PAROCHI-29 INTERMEDIATE, JUNIOR HIGH, VOCATIONAL, OR HIGH SCHOOL, OR (B) ANY 30 AL, AREA ACCESSIBLE TO THE PUBLIC LOCATED WITHIN ONE THOUSAND FEET OF THE 31 32 REAL PROPERTY BOUNDARY LINE COMPRISING ANY SUCH SCHOOL OR ANY PARKED 33 AUTOMOBILE OR OTHER PARKED VEHICLE LOCATED WITHIN ONE THOUSAND FEET OF 34 THE REAL PROPERTY BOUNDARY LINE COMPRISING ANY SUCH SCHOOL. FOR THE PURPOSE OF THIS SUBDIVISION, AN "ACCESSIBLE AREA TO THE PUBLIC" 35 SHALL MEAN SIDEWALKS, STREETS, PARKING LOTS, PARKS, PLAYGROUNDS, STORES AND 36 37 RESTAURANTS. 38 S 2. The penal law is amended by adding a new section 460.65 to read 39 as follows: 40 S 460.65 CRIMINAL STREET GANG RECRUITMENT ON SCHOOL GROUNDS. 41 A PERSON IS GUILTY OF CRIMINAL STREET GANG RECRUITMENT ON SCHOOL GROUNDS WHEN, ON SCHOOL GROUNDS, HE OR SHE COERCES, SOLICITS, RECRUITS 42 43 INDUCES ANOTHER PERSON TO JOIN OR REMAIN A MEMBER OF A CRIMINAL OR 44 STREET GANG, OR CONSPIRES TO DO SO. 45 CRIMINAL STREET GANG RECRUITMENT ON SCHOOL GROUNDS IS A CLASS D FELO-46 NY. 47 S 3. The highway law is amended by adding a new section 318 to read as follows: 48 49 S 318. GANG FREE SCHOOL ZONE SIGNS. ANY POLITICAL SUBDIVISION OF THE 50 STATE HAVING JURISDICTION OVER ANY HIGHWAY WITHIN SCHOOL GROUNDS, AS DEFINED IN SUBDIVISION EIGHT OF SECTION 460.10 OF THE PENAL LAW, MAY, 51 UPON THE REQUEST OF THE APPROPRIATE SCHOOL AUTHORITY, PLACE, CAUSE TO BE 52 PLACED OR PERMIT TO BE PLACED WITHIN THE RIGHT-OF-WAY OF SUCH HIGHWAY 53 54 SUCH SIGNS INDICATING A GANG FREE SCHOOL ZONE. 55 S 4. This act shall take effect on the sixtieth day after it shall 56 have become a law.
