AN ACT to amend the public authorities law, in relation to the manner in
which the members of the New York job development authority shall be
appointed

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivisions 1 and 2 of section 1802 of the public authori-
2 ties law, subdivision 1 as amended by chapter 118 of the laws of 1990
3 and subdivision 2 as separately amended by chapters 355 and 829 of the
4 laws of 1966, are amended to read as follows:

5 1. There is hereby created the "New York job development authority."
6 The authority shall be a body corporate and politic constituting a
7 public benefit corporation. Its members shall consist of the commission-
8 er of economic development, the commissioner of labor, the commissioner
9 of agriculture and markets, and the superintendent of banks, serving ex
10 officio, [and seven] FOUR members to be appointed by the governor with
11 the advice and consent of the senate, ONE MEMBER APPOINTED BY THE COMP-
12 TROLLER, ONE MEMBER APPOINTED BY THE TEMPORARY PRESIDENT OF THE SENATE,
13 AND ONE MEMBER APPOINTED BY THE SPEAKER OF THE ASSEMBLY. Each member
14 [appointed by the governor] shall be a citizen of the United States and
15 a resident of the state. THE MEMBERS APPOINTED BY THE COMPROLLER, THE
16 TEMPORARY PRESIDENT OF THE SENATE AND THE SPEAKER OF THE ASSEMBLY SHALL
17 NOT BE EMPLOYEES OF THE STATE.

18 2. Members shall continue in office until the expiration of their
19 terms and until their successors have been appointed and confirmed.
20 Persons appointed for full terms as their successors shall serve for
21 four years each commencing as of January first. In the event of a vacan-
22 cy occurring in the office of a member by death, resignation or other-

1 wise, the [governor] ORIGINAL APPOINTING AUTHORITY shall appoint a
2 successor [with the advice and consent of the senate] to serve for the
3 balance of the unexpired term.
4 S 2. This act shall take effect immediately.
