AN ACT to amend the vehicle and traffic law, in relation to requiring dates of manufacture on tires

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Legislative intent. The legislature hereby finds and 1 declares that tires have a limited service life regardless of 2 tread 3 depth and use. Aged tires are often unsuspectingly put into service after having served as a spare, stored in garages or warehouses, or 4 simply used on a vehicle that is infrequently driven. In many instances 5 these tires show no visible signs of deterioration. Research has shown 6 7 that tread belt separations in aged tires have caused nearly 50 acci-8 dents, with at least 37 fatalities and 35 serious injuries. The legisla-9 ture also finds that the tire age can be determined through decoding of 10 the required department of transportation number molded into the side of 11 a tire; however, the department of transportation date coding is difficult to read and can be confusing to the consumer. The National Highway 12 Traffic Safety Administration is currently conducting research on tire 13 14 aging and is studying consumer advisories. Therefore, the legislature 15 finds and declares that in absence of any federal regulations, it is in 16 the best interest of the state to require manufacturers to display the 17 date of manufacture on both sides of any tires sold in this state, as well as to implement a public outreach campaign to inform consumers of 18 19 the dangers of operating a motor vehicle with aged tires.

20 S 2. Subdivision 35 of section 375 of the vehicle and traffic law is 21 amended by adding a new paragraph (d) to read as follows:

(D)(I) NO TIRE SHALL BE MANUFACTURED, DISTRIBUTED, OFFERED FOR SALE OR 1 2 SOLD IN THIS STATE FOR USE ON A PASSENGER VEHICLE, MULTI-PURPOSE PASSEN-3 GER VEHICLE OR LIGHT TRUCK UNLESS A DATE OF MANUFACTURE IS CLEARLY MOLD-4 ED ON BOTH SIDES OF THE TIRE IN A NON-CODED FASHION. FOR THE PURPOSES 5 PARAGRAPH, THE FOLLOWING TERMS SHALL HAVE THE FOLLOWING MEAN-OF THIS 6 INGS: (A) "LIGHT TRUCK" SHALL MEAN A MOTOR VEHICLE WITH A GROSS VEHICLE 7 RATING OF LESS THAN TWENTY-SIX THOUSAND POUNDS WHICH IS EITHER WEIGHT 8 DESIGNED FOR OFF-HIGHWAY OPERATION OR DESIGNED TO PERFORM AT LEAST ONE 9 FOLLOWING FUNCTIONS: TRANSPORT MORE THAN TEN PERSONS, PROVIDE OF THE10 TEMPORARY LIVING QUARTERS, TRANSPORT PROPERTY IN AN OPEN BED, PROVIDE 11 THAN PASSENGER-CARRYING GREATER CARGO-CARRYING VOLUME, OR PERMIT 12 EXPANDED USE OF A PASSENGER VEHICLE FOR CARGO-CARRYING PURPOSES OR OTHER 13 NONPASSENGER-CARRYING PURPOSES THROUGH THE REMOVAL OF SEATS; (B) 14 "MULTI-PURPOSE PASSENGER VEHICLE" SHALL MEAN A MOTOR VEHICLE DESIGNED TO 15 CARRY TEN PERSONS OR LESS WHICH IS CONSTRUCTED EITHER ON A TRUCK CHASSIS 16 WITH SPECIAL FEATURES FOR OCCASIONAL OFF-ROAD OPERATION; AND (C) OR 17 "PASSENGER VEHICLE" SHALL MEAN ANY MOTOR VEHICLE DESIGNED FOR CARRYING 18 TEN PERSONS OR LESS.

19 (II)WHENEVER THERE SHALL BE A VIOLATION OF THIS SECTION, APPLICATION 20 MAY BE MADE BY THE ATTORNEY GENERAL IN THE NAME OF THEPEOPLE OF THE 21 STATE OF NEW YORK TO A COURT OR JUSTICE HAVING JURISDICTION BY A SPECIAL 22 TO ISSUE AN INJUNCTION AND UPON NOTICE TO THE DEFENDANT OF PROCEEDING 23 NOT LESS THAN FIVE DAYS, TO ENJOIN AND RESTRAIN THE CONTINUANCE OF SUCH VIOLATION OR TO ENFORCE THE PROVISIONS OF THIS SECTION; AND IF IT SHALL 24 25 APPEAR TO THE SATISFACTION OF THE COURT OR JUSTICE THAT THE DEFENDANT 26 HAS, IN FACT, VIOLATED THIS SECTION, AN INJUNCTION MAY BE ISSUED BY SUCH 27 COURT OR JUSTICE, ENJOINING AND RESTRAINING ANY FURTHER VIOLATION, WITH-28 REQUIRING PROOF ANY PERSON HAS, IN FACT, BEEN INJURED OR OUT THAT 29 DAMAGED THEREBY. WHENEVER THE COURT SHALL DETERMINE THAT A VIOLATION OF OCCURRED THE COURT MAY IMPOSE A CIVIL PENALTY OF NOT 30 THIS SECTION HAS MORE THAN FIVE HUNDRED DOLLARS FOR EACH VIOLATION. IN CONNECTION WITH 31 32 SUCH PROPOSED APPLICATION, THE ATTORNEY GENERAL IS AUTHORIZED TO ANY 33 TAKE PROOF AND MAKE A DETERMINATION OF THE RELEVANT FACTS AND ISSUE 34 SUBPOENAS IN ACCORDANCE WITH THE CIVIL PRACTICE LAW AND RULES.

S 3. 1. The governor's traffic safety committee, with the cooperation of the department of motor vehicles, the department of transportation, the division of state police, and any other department, division, board, bureau, commission, agency or public authority of the state or any political subdivision thereof deemed necessary by the committee, shall develop and implement a public outreach campaign to inform the general public of the dangers of operating a motor vehicle with aged tires.

42 Such campaign shall include, but not be limited to:

43 (a) The development of radio and television public service announce-44 ments informing the general public of the dangers of operating a motor 45 vehicle with aged tires;

(b) Developing printed informational materials informing the general public of the dangers of operating a motor vehicle with aged tires, and including a warning to the general public stating that:

Such informa1 tional material shall be available in both English and Spanish language 2 versions;

3 (c) Distributing informational materials with each driver's license 4 application and renewal, and with each motor vehicle registration and 5 renewal;

6 (d) Making such informational materials available to the general 7 public at all department of motor vehicle offices, all county offices 8 that provide department of motor vehicle services;

9 (e) Making such informational materials available to motorists at all 10 New York state automobile dealerships or any other office or agency that 11 the governor's traffic safety committee deems appropriate;

12 (f) Coordinating educational efforts with other states and local agen-13 cies and not-for-profit organizations to warn of the dangers of operat-14 ing a motor vehicle with aged tires; and

(g) Encouraging existing traffic safety and driver education programs to include in their curricula information on avoiding operating a motor vehicle with aged tires, the need to reduce speed and the importance of driving cautiously if you must use an old tire in an emergency, and that all tires should be replaced ten years after the date of their manufacture.

The department of motor vehicles, the department of transportation 22 and the division of state police, and any department, division, board, 23 bureau, commission, agency, or public authority of the state or any 24 political subdivision thereof deemed necessary by the governor's traffic 25 safety committee, shall cooperate to the furthest extent possible in the 26 development and implementation of this campaign.

27 S 4. This act shall take effect on the one hundred eightieth day after 28 it shall have become a law and shall only apply to tires manufactured on 29 or after such effective date.
