AN ACT to amend the education law, in relation to regulatory mandates

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The education law is amended by adding a new section 308-a
2 to read as follows:

3 S 308-A. REGULATORY MANDATES. 1. AS USED IN THIS SECTION, "REGULATORY
4 MANDATE" MEANS ANY RULE, REGULATION, ORDER, OR ADMINISTRATIVE GUIDANCE
5 BY THE BOARD OF REGENTS, COMMISSIONER, OR AN EMPLOYEE OF THE DEPARTMENT
6 THAT REQUIRES A SCHOOL DISTRICT TO CREATE A NEW PROGRAM, REQUIRES A
7 HIGHER LEVEL OF SERVICE FOR AN EXISTING PROGRAM, OR ALTERS A PROGRAM OR
8 A SERVICE IN A MANNER THAT INCREASES THE OPERATIONAL COST TO A SCHOOL
9 DISTRICT.

10 2. IN THE EVENT THAT A REGULATORY MANDATE THAT IMPOSES A COST UPON A
11 SCHOOL DISTRICT AND IS ACTED UPON OR PROMULGATED BY THE REGENTS, COMMIS-
12 SIONER, OR AN EMPLOYEE OF THE DEPARTMENT AFTER THE ADOPTION OF A SCHOOL
13 BUDGET, SUCH REGULATORY MANDATE SHALL NOT TAKE EFFECT UNTIL THE SUBSE-
14 QUENT SCHOOL YEAR FOR WHICH SUCH SCHOOL BUDGET WAS ADOPTED.

15 3. NOTWITHSTANDING SUBDIVISION TWO OF THIS SECTION, A REGULATORY
16 MANDATE MAY BE IMPOSED IF:

17 (A) THE REGULATORY MANDATE IS PROVIDED AT THE OPTION OF THE SCHOOL
18 DISTRICT UNDER A REGULATION, RULE, ORDER, OR ADMINISTRATIVE GUIDANCE
19 THAT IS PERMISSIVE RATHER THAN MANDATORY;

20 (B) THE REGULATORY MANDATE IS REQUIRED BY, OR ARISES FROM, AN EXECU-
21 TIVE ORDER OF THE GOVERNOR EXERCISING HIS OR HER EMERGENCY POWERS; OR

22 (C) THE REGULATORY MANDATE IS REQUIRED BY STATUTE OR EXECUTIVE ORDER
23 THAT IMPLEMENTS A FEDERAL LAW OR REGULATION AND RESULTS FROM COSTS
