AN ACT to amend the general municipal law, in relation to extending the time to file a claim against a public corporation for injuries sustained by persons who participated in the World Trade Center rescue, recovery or cleanup operations

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Short title. This act shall be known and may be cited as  
2     "Jimmy Nolan's law".  
3     S 2. Section 50-i of the general municipal law is amended by adding a  
4     new subdivision 4 to read as follows:  
5     4. (A) NOTWITHSTANDING ANY OTHER PROVISION OF LAW TO THE CONTRARY,  
6     INCLUDING ANY OTHER SUBDIVISION OF THIS SECTION, SECTION FIFTY-E OF THIS  
7     ARTICLE, SECTION THIRTY-EIGHT HUNDRED THIRTEEN OF THE EDUCATION LAW, AND  
8     THE PROVISIONS OF ANY GENERAL, SPECIAL OR LOCAL LAW OR CHARTER REQUIRING  
9     AS A CONDITION PRECEDENT TO COMMENCEMENT OF AN ACTION OR SPECIAL  
10    PROCEEDING THAT A NOTICE OF CLAIM BE FILED OR PRESENTED, ANY CAUSE OF  
11    ACTION AGAINST A PUBLIC CORPORATION FOR PERSONAL INJURIES SUFFERED BY A  
12    PARTICIPANT IN WORLD TRADE CENTER RESCUE, RECOVERY OR CLEANUP OPERATIONS  
13    AS A RESULT OF SUCH PARTICIPATION WHICH IS BARRED AS OF THE EFFECTIVE  
14    DATE OF THIS SUBDIVISION BECAUSE THE APPLICABLE PERIOD OF LIMITATION HAS

2 AND PROSECUTED PROVIDED SUCH CLAIM IS FILED AND SERVED WITHIN ONE YEAR  
3 OF THE EFFECTIVE DATE OF THIS SUBDIVISION.

4 (B) FOR THE PURPOSES OF THIS SUBDIVISION:

5 (1) "PARTICIPANT IN WORLD TRADE CENTER RESCUE, RECOVERY OR CLEANUP  
6 OPERATIONS" MEANS ANY EMPLOYEE OR VOLUNTEER THAT:

7 (I) PARTICIPATED IN THE RESCUE, RECOVERY OR CLEANUP OPERATIONS AT THE  
8 WORLD TRADE CENTER SITE; OR

9 (II) WORKED AT THE FRESH KILLS LAND FILL IN THE CITY OF NEW YORK AFTER  
10 SEPTEMBER ELEVENTH, TWO THOUSAND ONE; OR

11 (III) WORKED AT THE NEW YORK CITY MORGUE OR THE TEMPORARY MORGUE ON  
12 PIER LOCATIONS ON THE WEST SIDE OF MANHATTAN AFTER SEPTEMBER ELEVENTH,  
13 TWO THOUSAND ONE; OR

14 (IV) WORKED ON THE BARGES BETWEEN THE WEST SIDE OF MANHATTAN AND THE  
15 FRESH KILLS LAND FILL IN THE CITY OF NEW YORK AFTER SEPTEMBER ELEVENTH,  
16 TWO THOUSAND ONE.

17 (2) "WORLD TRADE CENTER SITE" MEANS ANYWHERE BELOW A LINE STARTING  
18 FROM THE HUDSON RIVER AND CANAL STREET; EAST ON CANAL STREET TO PIKE  
19 STREET; SOUTH ON PIKE STREET TO THE EAST RIVER; AND EXTENDING TO THE  
20 LOWER TIP OF MANHATTAN.

21 S 3. This act shall take effect immediately.
