AN ACT to amend the public authorities law, in relation to the continua-
tion of the village of Suffern parking authority

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 1600-b of the public authorities law, as amended by
2 chapter 276 of the laws of 2004, is amended to read as follows:
3 S 1600-b. Village of Suffern parking authority. A board to be known as
4 "Village of Suffern parking authority" is hereby created. Such board
5 shall be a body corporate, constituting a public benefit corporation,
6 and its existence shall commence upon the appointment of the members as
7 herein provided. It shall consist of a chairman and four other members,
8 who shall be appointed by the mayor with the approval of the board of
9 trustees of the village. Of the members first appointed, one shall be
10 appointed for a period of one year, one for a period of two years, one
11 for a period of three years, one for a period of four years, and one for
12 a period of five years. At the expiration of such terms, the terms of
13 office of their successors shall be five years. Each member shall
14 continue to serve until the appointment and qualification of his succes-
15 sor. Vacancies in such board occurring otherwise than by the expiration
16 of term shall be filled for the unexpired term. The members of the board
17 shall choose from their number a vice-chairman. The board of trustees
18 may remove any member of the board for inefficiency, neglect of duty or
19 misconduct in office, giving him a copy of the charges against him and
20 an opportunity of being heard in person, or by counsel, in his defense
21 upon not less than ten days' notice. The members of the board shall be
22 entitled to no compensation for their services but shall be entitled to
23 reimbursement for their actual and necessary expenses incurred in the
24 performance of their official duties. The powers of the authority shall
25 be vested in and exercised by a majority of the members of the board

1 then in office. Such board may delegate to one or more of its members or
2 to its officers, agents and employees such powers and duties as it may
3 deem proper. Such board and its corporate existence shall continue only
4 to the thirty-first day of December, two thousand [nine] FOURTEEN, and
5 thereafter until all its liabilities have been met and its bonds have
6 been paid in full or such liabilities or bonds have otherwise been
7 discharged. Upon its ceasing to exist, all its rights and properties
8 shall pass to the Village.

9 S 2. This act shall take effect immediately.
