Introduced by M. of A. KAVANAGH -- read once and referred to the Committee on Election Law

AN ACT to amend the election law, in relation to the treatment of corporate subsidiaries for purposes of the application of contribution limits and reporting requirements

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

- Section 1. Section 14-102 of the election law is amended by adding a new subdivision 6 to read as follows:
- 6. AS TO RECEIPTS FROM CORPORATIONS, THE STATEMENTS SHALL INCLUDE ADDRESS OF (A) EACH CORPORATION FROM WHICH IT HAS RECEIVED NAME AND ANYTHING OF VALUE, (B) THE NAME OF EACH CORPORATION THAT PERCENT OR MORE OF THE SHARES OF THAT CORPORATION, CONTROLS FIFTY (C) 7 THE NAMES AND ADDRESSES OF EACH INDIVIDUAL WHO IS PART OF A INDIVIDUALS THAT OWNS OR CONTROLS FIFTY PERCENT OR MORE OF THE SHARES OF 9 EITHER CORPORATION.
- Section 14-116 of the election law is amended by adding a new 10 2. subdivision 3 to read as follows: 11
- 12 3. FOR PURPOSES OF THIS SECTION, THE TERM "CORPORATION" MEANS A PARENT 13 CORPORATION AND ALL OF ITS SUBSIDIARIES OF WHICH THE PARENT CORPORATION 14 FIFTYPERCENT OR MORE OF THE OUTSTANDING SHARES AND ANY OTHER CORPORATION OF WHICH A COMBINATION OF INDIVIDUALS THAT OWNS OR 15 CONTROLS 16 FIFTY PERCENT OR MORE OF THE OUTSTANDING SHARES OF THE PARENT CORPO-RATION ALSO OWNS OR CONTROLS FIFTY PERCENT OR MORE OF 17 THE OUTSTANDING
- 18 SHARES.
