AN ACT to amend the public officers law, in relation to requiring the posting of the amounts of the fees imposed by state and municipal agencies

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. The public officers law is amended by adding a new article 5-A to read as follows:

ARTICLE 5-A
POSTING OF FEES IMPOSED
BY GOVERNMENTAL ENTITIES

SECTION 81. DEFINITIONS.

81-A. INTERNET POSTING OF FEES.

81-B. CONSPICUOUS POSTING OF FEES.

S 81. DEFINITIONS. AS USED IN THIS ARTICLE, UNLESS THE CONTEXT REQUIRES OTHERWISE:

1. "FEE" MEANS ANY FEE, CHARGE, TAX, FINE, PENALTY OR SURCHARGE IMPOSED BY A STATE AGENCY OR MUNICIPAL AGENCY PURSUANT TO STATE LAW, RULE OR REGULATION, OR PURSUANT TO ANY LOCAL LAW, ORDINANCE, RESOLUTION, RULE OR REGULATION.

2. "MUNICIPAL AGENCY" MEANS ANY DEPARTMENT, BOARD, BUREAU, DIVISION, COMMISSION, COMMITTEE, PUBLIC AUTHORITY, PUBLIC CORPORATION, COUNCIL, OFFICE OR OTHER GOVERNMENTAL ENTITY PERFORMING A GOVERNMENTAL OR PROPRIETARY FUNCTION FOR A MUNICIPALITY, EXCEPT THE JUDICIARY.

3. "STATE AGENCY" MEANS ANY DEPARTMENT, BOARD, BUREAU, DIVISION, COMMISSION, COMMITTEE, PUBLIC AUTHORITY, PUBLIC CORPORATION, COUNCIL,

3 S 81-A. INTERNET POSTING OF FEES. 1. WITHIN NINETY DAYS OF THE EFFEC-
4 TIVE DATE OF THIS ARTICLE, THE SECRETARY OF STATE SHALL PROVIDE AND
5 POST, ON THE INTERNET WEBSITE MAINTAINED BY THE STATE OF NEW YORK, A
6 LIST OF THE AMOUNT OR RANGE OF AMOUNTS OF EACH FEE IMPOSED OR COLLECTED
7 BY EACH STATE AGENCY, AND THE PURPOSE OF SUCH FEE.

8 2. WITHIN NINETY DAYS OF THE EFFECTIVE DATE OF THIS ARTICLE, EACH
9 STATE AGENCY SHALL PROVIDE AND POST, ON SUCH AGENCY'S INTERNET WEBSITE,
10 A LIST OF THE AMOUNT OR THE RANGE OF AMOUNTS OF EACH FEE IMPOSED OR
11 COLLECTED BY SUCH AGENCY, AND THE PURPOSE OF SUCH FEE.

12 3. WITHIN NINETY DAYS OF THE EFFECTIVE DATE OF THIS ARTICLE, EACH
13 MUNICIPALITY SHALL PROVIDE AND POST, ON SUCH MUNICIPALITY'S INTERNET
14 WEBSITE, A LIST OF THE AMOUNT OR RANGE OF AMOUNTS OF EACH FEE IMPOSED OR
15 COLLECTED BY ANY MUNICIPAL AGENCY OF SUCH MUNICIPALITY, AND THE PURPOSE
16 OF SUCH FEE.

17 S 81-B. CONSPICUOUS POSTING OF FEES. 1. WITHIN SIXTY DAYS OF THE
18 EFFECTIVE DATE OF THIS ARTICLE, EVERY STATE AGENCY WHICH IMPOSES OR
19 COLLECTS FEES SHALL, AT EACH AND EVERY OFFICE OF SUCH AGENCY, CONSPICU-
20 OUSLY POST OR PROVIDE A WRITTEN LIST OF THE AMOUNT OR THE RANGE OF
21 AMOUNTS OF EACH FEE IMPOSED OR COLLECTED AT SUCH OFFICE, AND THE PURPOSE
22 OF SUCH FEE.

23 2. WITHIN SIXTY DAYS OF THE EFFECTIVE DATE OF THIS ARTICLE, EVERY
24 MUNICIPAL AGENCY WHICH IMPOSES OR COLLECTS FEES SHALL, AT EACH AND EVERY
25 OFFICE OF SUCH AGENCY, CONSPICUOUSLY POST OR PROVIDE A WRITTEN LIST OF
26 THE AMOUNT OR THE RANGE OF AMOUNTS OF EACH FEE IMPOSED OR COLLECTED AT
27 SUCH OFFICE, AND THE PURPOSE OF SUCH FEE.

28 S 2. This act shall take effect on the sixtieth day after it shall
29 have become a law.
