AN ACT to amend chapters 53, 54 and 55 of the laws of 2009, enacting the education, labor and family assistance budget, the health and mental hygiene budget, and the transportation, economic development and environmental conservation budget, in relation to making appropriations for the support of government

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 1 of chapter 53 of the laws of 2009, as amended by

8 The moneys hereby appropriated shall be
9 available for expenses already accrued or
10 to accrue and shall include refunds,
11 reimbursements, credits and moneys
12 received by the higher education services
13 corporation as repayments of past tuition
14 assistance program disbursements in
15 accordance with audit allowances, upon
16 approval of the director of the budget,
17 for transfer to the federal department of
