AN ACT to authorize the dormitory authority of the state of New York to sell certain land in the county of Queens to the Indian Cultural and Community Center, Inc.

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Notwithstanding the provisions of any other law to the
 2 contrary, the dormitory authority of the state of New York is authorized
 3 to sell and convey to the Indian Cultural and Community Center, Inc. the
 4 parcel of land situated in the City of New York, Borough of Queens,
 5 State of New York, constituting a portion of the Creedmoor Psychiatric
 6 Center, specifically described as follows:
 7 Beginning at a point on the southerly side of Union Turnpike, which is
 8 at a distance of 233.41 feet measured along the line S84°17'40"W from
 9 the intersection of the southerly side of Union Turnpike and the wester-
 10 ly side of 243rd St
 11 Thence on a westerly direction along the line S84°17'40" for a
 12 distance of 50 Feet to a point
 13 Thence on a southerly direction along the line S05°42'20"E for a
 14 distance of 91.71 feet to a point
 15 Thence south easterly along a curve to the left of radius of 90.0 feet
 16 (the chord of the above arc being S39°41'25"E C=100.61') an arc distance
 17 of 106.77 feet to a point
 18 Thence on a southeasterly direction along line S73°40'30"E for a
 19 distance of 52.04 feet to a point
 20 Thence on a northeasterly direction along line N16°19'30" for a
 21 distance of 50 feet to a point
 22 Thence on a northwesterly direction along line N73°40'30" for a
 23 distance of 52.04 feet to a point

1 Thence on a northwesterly direction along a curve to the left of radi-
2 us of 40.0 feet (the chord of the arc being N39°41'25"W C=44.72') an arc
3 distance of 47.45 feet

4 Thence on a northwesterly direction along line N05°42'20"W 91.15' to
5 the point of beginning.

6 S 2. The dormitory authority of the state of New York is authorized to
7 fix and determine the terms and conditions of the conveyance authorized
8 by section one of this act, provided, however, that the sales price
9 shall be not less than the fair market value of such parcel, as deter-
10 mined by two or more independent appraisals. Such conveyance shall take
11 place within one year from the effective date of this act; and the
12 proceeds of such sale shall be deposited in the mental hygiene facili-
13 ties improvement fund income account established pursuant to section 9
14 of the facilities development corporation act, as added by chapter 359
15 of the laws of 1968.

16 S 3. This act shall take effect immediately.
