AN ACT to amend the insurance law, in relation to providing for health insurance coverage for diagnostic screening for ovarian/primary peritoneal cancer

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subsection (i) of section 3216 of the insurance law is 2 amended by adding a new paragraph 11-b to read as follows:

- (11-B) (A) EVERY POLICY DELIVERED OR ISSUED FOR DELIVERY IN THIS STATE WHICH PROVIDES MEDICAL COVERAGE THAT INCLUDES COVERAGE FOR PHYSICIAN SERVICES IN A PHYSICIAN'S OFFICE AND EVERY POLICY WHICH PROVIDES MAJOR MEDICAL OR SIMILAR COMPREHENSIVE-TYPE COVERAGE SHALL PROVIDE, UPON THE PRESCRIPTION OF A HEALTH CARE PROVIDER LEGALLY AUTHORIZED TO PRESCRIBE UNDER TITLE EIGHT OF THE EDUCATION LAW, THE FOLLOWING COVERAGE FOR DIAGNOSTIC SCREENING FOR OVARIAN/PRIMARY PERITONEAL CANCER: AN ANNUAL STANDARD DIAGNOSTIC EXAM INCLUDING, BUT NOT LIMITED TO, A PELVIC EXAMINATION AND A CA 125 BLOOD TEST FOR WOMEN AGE TWENTY AND OVER.

- S 2. Subsection (1) of section 3221 of the insurance law is amended by adding a new paragraph 11-b to read as follows:
 - (11-B) (A) EVERY POLICY DELIVERED OR ISSUED FOR DELIVERY IN THIS STATE WHICH PROVIDES MEDICAL COVERAGE THAT INCLUDES COVERAGE FOR PHYSICIAN SERVICES IN A PHYSICIAN'S OFFICE AND EVERY POLICY WHICH PROVIDES MAJOR MEDICAL OR SIMILAR COMPREHENSIVE-TYPE COVERAGE SHALL PROVIDE, UPON THE PRESCRIPTION OF A HEALTH CARE PROVIDER LEGALLY AUTHORIZED TO PRESCRIBE UNDER TITLE EIGHT OF THE EDUCATION LAW, THE FOLLOWING COVERAGE FOR DIAGNOSTIC SCREENING FOR OVARIAN/PRIMARY PERITONEAL CANCER: AN ANNUAL STAND-

- (Z-2)(1) EVERY POLICY DELIVERED OR ISSUED FOR DELIVERY IN THIS STATE WHICH PROVIDES MEDICAL COVERAGE THAT INCLUDES COVERAGE FOR PHYSICIAN SERVICES IN A PHYSICIAN'S OFFICE AND EVERY POLICY WHICH PROVIDES MAJOR MEDICAL OR SIMILAR COMPREHENSIVE-TYPE COVERAGE SHALL PROVIDE, UPON THE PRESCRIPTION OR A HEALTH CARE PROVIDER LEGALLY AUTHORIZED TO PRESCRIBE UNDER TITLE EIGHT OF THE EDUCATION LAW, THE FOLLOWING COVERAGE FOR DIAGNOSTIC SCREENING FOR OVARIAN/PRIMARY PERITONEAL CANCER: AN ANNUAL STANDARD DIAGNOSTIC EXAM INCLUDING, BUT NOT LIMITED TO, A PELVIC EXAMINATION AND A CA 125 BLOOD TEST FOR WOMEN AGE TWENTY AND OVER.
- 17 (2) SUCH COVERAGE MAY BE SUBJECT TO ANNUAL DEDUCTIBLES AND COINSURANCE 18 AS MAY BE DEEMED APPROPRIATE BY THE SUPERINTENDENT AND AS ARE CONSISTENT 19 WITH THOSE ESTABLISHED FOR OTHER BENEFITS WITHIN A GIVEN POLICY.
- 20 S 4. This act shall take effect on the first of January next succeed-21 ing the date on which it shall have become a law.
