AN ACT to amend the correction law, in relation to establishing a general equivalency program and a higher education program for inmates

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. The correction law is amended by adding a new section 136-a to read as follows:

- 136-A. GENERAL EOUIVALENCY PROGRAM AND HIGHER EDUCATION OF PERSONS IN CORRECTIONAL FACILITIES. 1. ALL INMATES ADMITTED TO THEDEPARTMENT SERVING A DETERMINATE TERM OF IMPRISONMENT, OR AN INDETERMINATE SENTENCE IMPRISONMENT OTHER THAN SENTENCE OF LIFE IMPRISONMENT WITHOUT Α PAROLE, WHO HAVE BEEN EVALUATED UPON ADMISSION PURSUANT TO SUBDIVISION SECTION ONE HUNDRED THIRTY-SEVEN OF THIS ARTICLE AND ARE DETER-MINED TO BE CAPABLE OF SUCCESSFULLY COMPLETING THE ACADEMIC COURSE REQUIRED FOR A GENERAL EQUIVALENCY DIPLOMA OR COLLEGE CREDIT COURSES, SHALL BE PROVIDED WITH THE OPPORTUNITY TO COMPLETE SUCH COURSE WORK. THE DEPARTMENT, SUCH INMATES WILL BE PROVIDED WITH ADMISSION TO WRITTEN NOTICE THAT GENERAL EOUIVALENCY PROGRAMS AND COLLEGE PROGRAMS ARE AVAILABLE FOR ALL INMATES WHO SO APPLY.
- 15 THE DEPARTMENT SHALL ENSURE THAT ACADEMIC EDUCATION PROGRAMS WHICH 16 PROVIDE THE APPROPRIATE CURRICULUM AND CERTIFIED ACADEMIC GENERAL EQUIVALENCY AND COLLEGE CREDIT INSTRUCTION ARE AVAILABLE AT ALL 17 18 CORRECTIONAL FACILITIES HOUSING INMATES WHO ARE ELIGIBLE. THE DEPARTMENT SHALL PROVIDE ACADEMIC STAFF WHO ARE OUALIFIED TO PROVIDE SUCH 19 TION AND WHO ARE MEMBERS OF THE COMPETITIVE CLASS OF THE CIVIL SERVICE 20 OF NEW YORK STATE. THE DEPARTMENT SHALL PROVIDE SUFFICIENT STAFF AT EACH 21 22 CORRECTIONAL FACILITY WHERE ELIGIBLE INMATES ARE CONFINED TO ENSURE 23 CLASSROOM RATIO OF TWENTY INMATES FOR EACH INSTRUCTOR. THE COMMISSIONER, 24 IN COOPERATION WITH THE COMMISSIONER OF EDUCATION, SHALL SET UP THE

EDUCATIONAL REQUIREMENTS FOR THE CERTIFICATION OF TEACHERS IN ALL SUCH CORRECTIONAL FACILITIES. THE COMMISSIONER, IN CONSULTATION WITH THE COMMISSIONER OF EDUCATION, SHALL DEVELOP A CURRICULA AND A PLAN FOR IMPLEMENTATION OF THE GENERAL EQUIVALENCY AND COLLEGE CREDIT PROGRAMS AND SHALL ISSUE A REPORT WITHIN TWELVE MONTHS AFTER THE EFFECTIVE DATE OF THIS SUBDIVISION.

7 S 2. This act shall take effect on the one hundred twentieth day after 8 it shall have become a law.
