AN ACT to amend the retirement and social security law, in relation to the performance of duty disability retirement of certain peace officers and police officers in the state department of taxation and finance

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The retirement and social security law is amended by adding
2 a new section 63-g to read as follows:
3 S 63-G. PERFORMANCE OF DUTY DISABILITY RETIREMENT; CERTAIN EMPLOYEES.
4 A. ANY MEMBER EMPLOYED BY THE DEPARTMENT OF TAXATION AND FINANCE WHO IS
5 A PEACE OFFICER, AS DEFINED IN SUBDIVISION FOUR OF SECTION 2.10 OF THE
6 CRIMINAL PROCEDURE LAW OR IS A POLICE OFFICER AS DEFINED IN PARAGRAPH
7 (Q) OF SUBDIVISION THIRTY-FOUR OF SECTION 1.20 OF THE CRIMINAL PROCEDURE
8 LAW, WHO BECOMES PHYSICALLY OR MENTALLY INCAPACITATED FOR THE PERFORM-
9 ANCE OF DUTIES AS THE NATURAL AND PROXIMATE RESULT OF AN INJURY,
10 SUSTAINED IN THE PERFORMANCE OR DISCHARGE OF HIS OR HER DUTIES SHALL BE
11 PAID A PERFORMANCE OF DUTY DISABILITY RETIREMENT ALLOWANCE EQUAL TO THAT
12 WHICH IS PROVIDED IN SECTION SIXTY-THREE OF THIS TITLE, SUBJECT TO THE
13 PROVISIONS OF SECTION SIXTY-FOUR OF THIS TITLE.

21 WILL BE PRESUMED TO BE DISABLED FROM THE PERFORMANCE OF HIS OR HER

28 S 4. This act shall take effect immediately provided that the amend-
29 ments to articles 14 and 15 of the retirement and social security law
30 made by sections two and three of this act shall expire on the same date
31 as such articles expire pursuant to section 615 of such law.

FISCAL NOTE.--Pursuant to Legislative Law, Section 50:

This bill would allow certain peace officers and police officers employed by the Department of Tax and Finance to be eligible for a performance of duty disability retirement allowance which would be 75% of final average salary less any Workers' Compensation payments received. Further, this bill would grant a presumption that certain infectious diseases and heart related disabilities have been sustained in the performance of duty, unless the contrary be proven by competent evidence.

If this bill is enacted, we anticipate that there will be an increase of approximately \$63,000 in the annual contributions of the State of New York for the fiscal year ending March 31, 2010.

In addition to the annual contributions discussed above, we estimate that there will be a past service cost of approximately \$183,000 which would be borne by the State of New York as a one-time payment. This estimate is based on the assumption that payment will be made on March 1, 2010.

These estimated costs are based on eighty (80) officers employed by the Department of Tax and Finance with a total salary of approximately \$4.7 million for the fiscal year ending March 31, 2008.

This estimate, dated December 1, 2008, and intended for use only during the 2009 Legislative Session, is Fiscal Note No. 2009-70, prepared by the Actuary for the New York State and Local Employees' Retirement System.
