CONCURRENT RESOLUTION OF THE SENATE AND ASSEMBLY

proposing an amendment to section 8 of article 4 of the constitution, in relation to legislative review of rules and regulations

Section 1. Resolved (if the Assembly concur), That section 8 of article 4 of the constitution be amended to read as follows:

3 S 8. No rule or regulation made by any state department, board, bureau, officer, authority or commission, except such as relates to the 5 organization or internal management of a state department, board, bureau, authority or commission shall be effective until it is filed in 7 the office of the department of state. The legislature shall provide for 8 the speedy publication of such rules and regulations by appropriate THE LEGISLATURE MAY REVIEW ANY RULE OR REGULATION TO DETERMINE IF 9 THE RULE OR REGULATION IS CONSISTENT WITH THE INTENT OF THE LEGISLATURE 10 AS EXPRESSED IN THE LANGUAGE OF THE STATUTE WHICH THE RULE OR REGULATION 11 12 IS INTENDED TO IMPLEMENT AND/OR TO DETERMINE WHETHER THE RULE 13 LIKELY TO HAVE A SUBSTANTIAL FISCAL IMPACT ON THE STATE OR LOCAL GOVERNMENTS WHICH WAS NOT ANTICIPATED BY THE LEGISLATURE 14 ΑT THE TIME OF THE PASSAGE OF THE LEGISLATION. UPON A FINDING THAT AN EXISTING 15 OR PROPOSED RULE OR REGULATION IS NOT CONSISTENT WITH LEGISLATIVE INTENT 16 17 AND/OR A FINDING OF A SUBSTANTIAL UNANTICIPATED FISCAL IMPACT STATE OR LOCAL GOVERNMENTS, THE LEGISLATURE SHALL TRANSMIT THIS FINDING 18 19 IN THE FORM OF A CONCURRENT RESOLUTION TO THE GOVERNOR AND THE 20 STATE DEPARTMENT, BOARD, BUREAU, AUTHORITY OR COMMISSION WHICH PROMULGATED, OR PLANS TO PROMULGATE, THE RULE OR REGULATION. 21 THE 22 DEPARTMENT, BOARD, BUREAU, AUTHORITY OR COMMISSION SHALL HAVE THIRTY 23 DAYS TO AMEND OR WITHDRAW THE EXISTING OR PROPOSED RULE OR REGULATION. IF THE STATE DEPARTMENT, BOARD, BUREAU, AUTHORITY OR COMMISSION DOES NOT 24

AMEND OR WITHDRAW THE EXISTING OR PROPOSED RULE OR REGULATION, THE LEGISLATURE MAY INVALIDATE THAT RULE OR REGULATION, IN WHOLE OR IN PART,

OR MAY PROHIBIT THAT PROPOSED RULE OR REGULATION, IN WHOLE OR IN PART, FROM TAKING EFFECT BY A VOTE OF A MAJORITY OF THE AUTHORIZED MEMBERSHIP OF EACH HOUSE IN FAVOR OF A CONCURRENT RESOLUTION PROVIDING FOR INVALIDATION OR PROHIBITION, AS THE CASE MAY BE, OF THE RULE OR REGULATION.

S 2. Resolved (if the Assembly concur), That the foregoing amendment be referred to the first regular legislative session convening after the next succeeding general election of members of the assembly, and, in conformity with section 1 of article 19 of the constitution, be published for 3 months previous to the time of such election.
