AN ACT to legalize, validate, ratify and confirm certain transportation contracts of the Garden City union free school district

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. All the acts done and proceedings heretofore had and taken
2 or caused to be had and taken by the Garden City union free school
3 district and by all officers, employees or agents of such school
4 district relating to or in connection with certain transportation

11 E411071, E800497, E800510, E800516, E800518, E800521 for the 2004-2005,
12 2005-2006, and 2006-2007 school years, contract numbers C411283,
13 C411284, C411285, C411286, C411287, C411288, C411289, C411292, C411293F
14 for the 2005-2006 school year, and contract numbers C411290, C411291,
15 C411294, C411295, C411296, C411297, C411298, C411299, C411300F, C411314F
16 for the 2006-2007 school year with various contractors, and all acts
17 incidental thereto are hereby legalized, validated, ratified and
18 confirmed, notwithstanding any failure to comply with the contract
19 award, approvals and filing provisions of the education law, the general
20 municipal law or any other law or any other statutory authority, rule or
21 regulation, other than those filing provisions defined in paragraph a of
22 subdivision 5 of section 3604 of the education law, in relation to any

3 S 2. The education department is hereby directed to consider the
4 aforementioned contracts for transportation aid as valid and proper
5 obligations of the Garden City union free school district.

6 S 3. This act shall take effect immediately.
