AN ACT to amend the public health law, the mental hygiene law and the surrogate's court procedure act, in relation to establishing procedures for making medical treatment decisions on behalf of persons who lack the capacity to decide about treatment for themselves; directing the New York state task force on life and law to form a special advisory committee to consider the procedures and practices for withholding or withdrawal of life sustaining treatment for patients with mental illness or mental retardation and developmental disabilities; and to repeal certain provisions of the public health law and the mental hygiene law relating thereto

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Legislative intent. Under article 29-C of the public health
2 law, competent adults have a powerful way to control their medical
3 treatment even after they lose decision-making capacity, by appointing
4 someone they trust to decide on their behalf. This legislation fills a
5 gap that remains in New York law. It adds, inter alia, a new article
6 29-CC to the public health law, which establishes a decision-making
7 process, applicable to decisions in general hospitals and nursing homes,
8 whereby a surrogate is selected and empowered to make health care deci-
9 sions for patients who lack capacity to make their own health care deci-

sions and who have not otherwise appointed an agent to make health care decisions pursuant to article 29-C of the public health law or provided clear and convincing evidence of their treatment wishes.

The legislature does not intend to encourage or discourage any particular health care decision or treatment, or to create or expand a substantive right of competent adults to decide about treatment for themselves, or to impair the right of patients to object to treatment under applicable law including court decisions. Further, the legislature does not intend to authorize a surrogate to deny to the patient personal services that every patient would generally receive, such as appropriate food, water, bed rest, room temperature and hygiene. This legislation establishes a procedure to facilitate responsible decision-making by surrogates on behalf of patients who do not have capacity to make their own health care decisions.

This legislation affirms existing laws and policies that limit individual conduct of patients with or without capacity, including those laws and policies against homicide, suicide, assisted suicide and mercy killing.

S 2. The public health law is amended by adding two new articles 29-CC and 29-CCC to read as follows:

S 2994-A. DEFINITIONS. THE FOLLOWING WORDS OR PHRASES, USED IN THIS ARTICLE, SHALL HAVE THE FOLLOWING MEANINGS, UNLESS THE CONTEXT OTHERWISE REQUIRES:

1. "ADULT" MEANS ANY PERSON WHO IS EIGHTEEN YEARS OF AGE OR OLDER OR HAS MARRIED.

2. "ATTENDING PHYSICIAN" MEANS A PHYSICIAN, SELECTED BY OR ASSIGNED TO A PATIENT PURSUANT TO HOSPITAL POLICY, WHO HAS PRIMARY RESPONSIBILITY FOR THE TREATMENT AND CARE OF THE PATIENT. WHERE MORE THAN ONE PHYSICIAN SHARES SUCH RESPONSIBILITY, OR WHERE A PHYSICIAN IS ACTING ON THE

1 ATTENDING PHYSICIAN'S BEHALF, ANY SUCH PHYSICIAN MAY ACT AS AN ATTENDING
2 PHYSICIAN PURSUANT TO THIS ARTICLE.

3 3. "CARDIOPULMONARY RESUSCITATION" MEANS MEASURES, AS SPECIFIED IN
4 REGULATIONS PROMULGATED BY THE COMMISSIONER, TO RESTORE CARDIAC FUNCTION
5 OR TO SUPPORT VENTILATION IN THE EVENT OF A CARDIAC OR RESPIRATORY
6 ARREST. CARDIOPULMONARY RESUSCITATION SHALL NOT INCLUDE MEASURES TO
7 IMPROVE VENTILATION AND CARDIAC FUNCTION IN THE ABSENCE OF AN ARREST.

8 4. "CLOSE FRIEND" MEANS ANY PERSON, EIGHTEEN YEARS OF AGE OR OLDER,
9 WHO IS A CLOSE FRIEND OF THE PATIENT, OR A RELATIVE OF THE PATIENT
10 (OTHER THAN A SPOUSE, ADULT CHILD, PARENT, BROTHER OR SISTER), WHO HAS
11 MAINTAINED SUCH REGULAR CONTACT WITH THE PATIENT AS TO BE FAMILIAR WITH
12 THE PATIENT'S ACTIVITIES, HEALTH, AND RELIGIOUS OR MORAL BELIEFS, AND
13 WHO PRESENTS A SIGNED STATEMENT TO THAT EFFECT TO THE ATTENDING PHYSI-
14 CIAN.

15 5. "DECISION-MAKING CAPACITY" MEANS THE ABILITY TO UNDERSTAND AND
16 APPRECIATE THE NATURE AND CONSEQUENCES OF PROPOSED HEALTH CARE, INCLUD-
17 ING THE BENEFITS AND RISKS OF AND ALTERNATIVES TO PROPOSED HEALTH CARE,
18 AND TO REACH AN INFORMED DECISION.

19 6. "DEVELOPMENTAL DISABILITY" MEANS A DEVELOPMENTAL DISABILITY AS
20 DEFINED IN SUBDIVISION TWENTY-TWO OF SECTION 1.03 OF THE MENTAL HYGIENE
21 LAW.

22 7. "DOMESTIC PARTNER" MEANS A PERSON WHO, WITH RESPECT TO ANOTHER
23 PERSON:

24 (A) IS FORMALLY A PARTY IN A DOMESTIC PARTNERSHIP OR SIMILAR RELATION-
25 SHIP WITH THE OTHER PERSON, ENTERED INTO PURSUANT TO THE LAWS OF THE
26 UNITED STATES OR OF ANY STATE, LOCAL OR FOREIGN JURISDICTION, OR REGIS-
27 TERED AS THE DOMESTIC PARTNER OF THE OTHER PERSON WITH ANY REGISTRY
28 MAINTAINED BY THE EMPLOYER OF EITHER PARTY OR ANY STATE, MUNICIPALITY,
29 OR FOREIGN JURISDICTION; OR

30 (B) IS FORMALLY RECOGNIZED AS A BENEFICIARY OR COVERED PERSON UNDER
31 THE OTHER PERSON'S EMPLOYMENT BENEFITS OR HEALTH INSURANCE; OR

32 (C) IS DEPENDENT OR MUTUALLY INTERDEPENDENT ON THE OTHER PERSON FOR
33 SUPPORT, AS EVIDENCED BY THE TOTALITY OF THE CIRCUMSTANCES INDICATING A
34 MUTUAL INTENT TO BE DOMESTIC PARTNERS INCLUDING BUT NOT LIMITED TO:
35 COMMON OWNERSHIP OR JOINT LEASING OF REAL OR PERSONAL PROPERTY; COMMON
36 HOUSEHOLDING, SHARED INCOME OR SHARED EXPENSES; CHILDREN IN COMMON;
37 SIGNS OF INTENT TO MARRY OR BECOME DOMESTIC PARTNERS UNDER PARAGRAPH (A)
38 OR (B) OF THIS SUBDIVISION; OR THE LENGTH OF THE PERSONAL RELATIONSHIP
39 OF THE PERSONS.

40 EACH PARTY TO A DOMESTIC PARTNERSHIP SHALL BE CONSIDERED TO BE THE
41 DOMESTIC PARTNER OF THE OTHER PARTY. "DOMESTIC PARTNER" SHALL NOT
42 INCLUDE A PERSON WHO IS RELATED TO THE OTHER PERSON BY BLOOD IN A MANNER
43 THAT WOULD BAR MARRIAGE TO THE OTHER PERSON IN NEW YORK STATE. "DOMES-
44 TIC PARTNER" ALSO SHALL NOT INCLUDE ANY PERSON WHO IS LESS THAN EIGHTEEN
45 YEARS OF AGE OR WHO IS THE ADOPTED CHILD OF THE OTHER PERSON OR WHO IS
46 RELATED BY BLOOD IN A MANNER THAT WOULD BAR MARRIAGE IN NEW YORK STATE
47 TO A PERSON WHO IS THE LAWFUL SPOUSE OF THE OTHER PERSON.

48 8. "EMANCIPATED MINOR PATIENT" MEANS A MINOR PATIENT WHO IS THE PARENT
49 OF A CHILD, OR WHO IS SIXTEEN YEARS OF AGE OR OLDER AND LIVING INDEPEND-
50 ENTLY FROM HIS OR HER PARENTS OR GUARDIAN.

51 9. "ETHICS REVIEW COMMITTEE" MEANS THE INTERDISCIPLINARY COMMITTEE
52 ESTABLISHED IN ACCORDANCE WITH THE REQUIREMENTS OF SECTION TWENTY-NINE
53 HUNDRED NINETY-FOUR-M OF THIS ARTICLE.

54 10. "GENERAL HOSPITAL" MEANS A GENERAL HOSPITAL AS DEFINED IN SUBDIVI-
55 SION TEN OF SECTION TWENTY-EIGHT HUNDRED ONE OF THIS CHAPTER EXCLUDING A
56 WARD, WING, UNIT OR OTHER PART OF A GENERAL HOSPITAL OPERATED FOR THE

PURPOSE OF PROVIDING SERVICES FOR PERSONS WITH MENTAL ILLNESS PURSUANT TO AN OPERATING CERTIFICATE ISSUED BY THE COMMISSIONER OF MENTAL HEALTH.

11. "GUARDIAN OF A MINOR" OR "GUARDIAN" MEANS A HEALTH CARE GUARDIAN OR A LEGAL GUARDIAN OF THE PERSON OF A MINOR.

12. "HEALTH CARE" MEANS ANY TREATMENT, SERVICE, OR PROCEDURE TO DIAGNOSE OR TREAT AN INDIVIDUAL'S PHYSICAL OR MENTAL CONDITION. PROVIDING NUTRITION OR HYDRATION ORALLY, WITHOUT RELIANCE ON MEDICAL TREATMENT, IS NOT HEALTH CARE UNDER THIS ARTICLE AND IS NOT SUBJECT TO THIS ARTICLE.

13. "HEALTH CARE AGENT" MEANS A HEALTH CARE AGENT DESIGNATED BY AN ADULT PURSUANT TO ARTICLE TWENTY-NINE-C OF THIS CHAPTER.

14. "HEALTH CARE DECISION" MEANS ANY DECISION TO CONSENT OR REFUSE TO CONSENT TO HEALTH CARE.

15. "HEALTH CARE GUARDIAN" MEANS AN INDIVIDUAL APPOINTED BY A COURT, PURSUANT TO SUBDIVISION FOUR OF SECTION TWENTY-NINE HUNDRED NINETY-FOUR-R OF THIS ARTICLE, AS THE GUARDIAN OF A MINOR PATIENT SOLELY FOR THE PURPOSE OF DECIDING ABOUT LIFE-SUSTAINING TREATMENT PURSUANT TO THIS ARTICLE.

16. "HEALTH CARE PROVIDER" MEANS AN INDIVIDUAL OR FACILITY LICENSED, CERTIFIED, OR OTHERWISE AUTHORIZED OR PERMITTED BY LAW TO ADMINISTER HEALTH CARE IN THE ORDINARY COURSE OF BUSINESS OR PROFESSIONAL PRACTICE.

17. "HEALTH OR SOCIAL SERVICE PRACTITIONER" MEANS A REGISTERED PROFESSIONAL NURSE, NURSE PRACTITIONER, PHYSICIAN, PHYSICIAN ASSISTANT, PSYCHOLOGIST OR LICENSED CLINICAL SOCIAL WORKER, LICENSED OR CERTIFIED PURSUANT TO THE EDUCATION LAW ACTING WITHIN HIS OR HER SCOPE OF PRACTICE.

18. "HOSPITAL" MEANS A GENERAL HOSPITAL OR A RESIDENTIAL HEALTH CARE FACILITY.

19. "LIFE-SUSTAINING TREATMENT" MEANS ANY MEDICAL TREATMENT OR PROCEDURE WITHOUT WHICH THE PATIENT WILL DIE WITHIN A RELATIVELY SHORT TIME, AS DETERMINED BY AN ATTENDING PHYSICIAN TO A REASONABLE DEGREE OF MEDICAL CERTAINTY. FOR THE PURPOSE OF THIS ARTICLE, CARDIOPULMONARY RESUSCITATION IS PRESUMED TO BE LIFE-SUSTAINING TREATMENT WITHOUT THE NECESSITY OF A DETERMINATION BY AN ATTENDING PHYSICIAN.

20. "MENTAL HYGIENE FACILITY" MEANS A FACILITY OPERATED OR LICENSED BY THE OFFICE OF MENTAL HEALTH OR THE OFFICE OF MENTAL RETARDATION AND DEVELOPMENTAL DISABILITIES AS DEFINED IN SUBDIVISION SIX OF SECTION 1.03 OF THE MENTAL HYGIENE LAW.

21. "MENTAL ILLNESS" MEANS A MENTAL ILLNESS AS DEFINED IN SUBDIVISION TWENTY OF SECTION 1.03 OF THE MENTAL HYGIENE LAW, AND DOES NOT INCLUDE DEMENTIA, SUCH AS ALZHEIMER'S DISEASE, OR OTHER DISORDERS RELATED TO DEMENTIA.

22. "MINOR" MEANS ANY PERSON WHO IS NOT AN ADULT.

23. "ORDER NOT TO RESUSCITATE" MEANS AN ORDER NOT TO ATTEMPT CARDIOPULMONARY RESUSCITATION IN THE EVENT A PATIENT SUFFERS CARDIAC OR RESPIRATORY ARREST.

24. "PARENT", FOR THE PURPOSE OF A HEALTH CARE DECISION ABOUT A MINOR PATIENT, MEANS A PARENT WHO HAS CUSTODY OF, OR WHO HAS MAINTAINED SUBSTANTIAL AND CONTINUOUS CONTACT WITH, THE MINOR PATIENT.

25. "PATIENT" MEANS A PERSON ADMITTED TO A HOSPITAL.

26. "PERSON CONNECTED WITH THE CASE" MEANS THE PATIENT, ANY PERSON ON THE SURROGATE LIST, A PARENT OR GUARDIAN OF A MINOR PATIENT, THE HOSPITAL ADMINISTRATOR, AN ATTENDING PHYSICIAN, ANY OTHER HEALTH OR SOCIAL SERVICES PRACTITIONER WHO IS OR HAS BEEN DIRECTLY INVOLVED IN THE PATIENT'S CARE, AND ANY DULY AUTHORIZED STATE AGENCY, INCLUDING THE FACILITY DIRECTOR OR REGIONAL DIRECTOR FOR A PATIENT TRANSFERRED FROM A

1 MENTAL HYGIENE FACILITY AND THE FACILITY DIRECTOR FOR A PATIENT TRANS-
2 FERRED FROM A CORRECTIONAL FACILITY.

3 27. "REASONABLY AVAILABLE" MEANS THAT A PERSON TO BE CONTACTED CAN BE
4 CONTACTED WITH DILIGENT EFFORTS BY AN ATTENDING PHYSICIAN, ANOTHER
5 PERSON ACTING ON BEHALF OF AN ATTENDING PHYSICIAN, OR THE HOSPITAL.

6 28. "RESIDENTIAL HEALTH CARE FACILITY" MEANS A RESIDENTIAL HEALTH CARE
7 FACILITY AS DEFINED IN SUBDIVISION THREE OF SECTION TWENTY-EIGHT HUNDRED
8 ONE OF THIS CHAPTER.

9 29. "SURROGATE" MEANS THE PERSON SELECTED TO MAKE A HEALTH CARE DECI-
10 SION ON BEHALF OF A PATIENT PURSUANT TO SECTION TWENTY-NINE HUNDRED
11 NINETY-FOUR-D OF THIS ARTICLE.

12 30. "SURROGATE LIST" MEANS THE LIST SET FORTH IN SUBDIVISION ONE OF
13 SECTION TWENTY-NINE HUNDRED NINETY-FOUR-D OF THIS ARTICLE.

14 S 2994-B. APPLICABILITY; PRIORITY OF CERTAIN OTHER SURROGATE DECI-
15 SION-MAKING LAWS AND REGULATIONS. 1. THIS ARTICLE SHALL APPLY TO HEALTH
16 CARE DECISIONS REGARDING HEALTH CARE PROVIDED IN A HOSPITAL TO A PATIENT
17 WHO LACKS DECISION-MAKING CAPACITY, EXCEPT AS LIMITED BY THIS SECTION.

18 2. PRIOR TO SEEKING OR RELYING UPON A HEALTH CARE DECISION BY A SURRO-
19 GATE FOR A PATIENT UNDER THIS ARTICLE, THE ATTENDING PHYSICIAN SHALL
20 MAKE REASONABLE EFFORTS TO DETERMINE WHETHER THE PATIENT HAS A HEALTH
21 CARE AGENT APPOINTED PURSUANT TO ARTICLE TWENTY-NINE-C OF THIS CHAPTER.
22 IF SO, HEALTH CARE DECISIONS FOR THE PATIENT SHALL BE GOVERNED BY SUCH
23 ARTICLE, AND SHALL HAVE PRIORITY OVER DECISIONS BY ANY OTHER PERSON
24 EXCEPT THE PATIENT OR AS OTHERWISE PROVIDED IN THE HEALTH CARE PROXY.

25 3. PRIOR TO SEEKING OR RELYING UPON A HEALTH CARE DECISION BY A SURRO-
26 GATE FOR A PATIENT UNDER THIS ARTICLE, IF THE ATTENDING PHYSICIAN HAS
27 REASON TO BELIEVE THAT THE PATIENT HAS A HISTORY OF RECEIVING SERVICES
28 FOR MENTAL RETARDATION OR A DEVELOPMENTAL DISABILITY; IT REASONABLY
29 APPEARS TO THE ATTENDING PHYSICIAN THAT THE PATIENT HAS MENTAL RETARDA-
30 TION OR A DEVELOPMENTAL DISABILITY; OR THE ATTENDING PHYSICIAN HAS
31 REASON TO BELIEVE THAT THE PATIENT HAS BEEN TRANSFERRED FROM A MENTAL
32 HYGIENE FACILITY OPERATED OR LICENSED BY THE OFFICE OF MENTAL HEALTH,
33 THEN SUCH PHYSICIAN SHALL MAKE REASONABLE EFFORTS TO DETERMINE WHETHER
34 PARAGRAPHS (A), (B) OR (C) OF THIS SUBDIVISION ARE APPLICABLE:

35 (A) IF THE PATIENT HAS A GUARDIAN APPOINTED BY A COURT PURSUANT TO
36 ARTICLE SEVENTEEN-A OF THE SURROGATE'S COURT PROCEDURE ACT, HEALTH CARE
37 DECISIONS FOR THE PATIENT SHALL BE GOVERNED BY SECTION SEVENTEEN HUNDRED
38 FIFTY-B OF THE SURROGATE'S COURT PROCEEDURE ACT AND NOT BY THIS ARTICLE.

39 (B) IF A PATIENT DOES NOT HAVE A GUARDIAN APPOINTED BY A COURT PURSU-
40 ANT TO ARTICLE SEVENTEEN-A OF THE SURROGATE'S COURT PROCEDURE ACT BUT
41 FALLS WITHIN THE CLASS OF PERSONS DESCRIBED IN PARAGRAPH (A) OF SUBDIVI-
42 SION ONE OF SECTION SEVENTEEN HUNDRED FIFTY-B OF SUCH ACT, DECISIONS TO
43 WITHDRAW OR WITHHOLD LIFE-SUSTAINING TREATMENT FOR THE PATIENT SHALL BE
44 GOVERNED BY SECTION SEVENTEEN HUNDRED FIFTY-B OF THE SURROGATE'S COURT
45 PROCEDURE ACT AND NOT BY THIS ARTICLE.

46 (C) IF A HEALTH CARE DECISION FOR A PATIENT CANNOT BE MADE UNDER PARA-
47 GRAPHS (A) OR (B) OF THIS SUBDIVISION, BUT CONSENT FOR THE DECISION MAY
48 BE PROVIDED PURSUANT TO THE MENTAL HYGIENE LAW OR REGULATIONS OF THE
49 OFFICE OF MENTAL HEALTH OR THE OFFICE OF MENTAL RETARDATION AND DEVELOP-
50 MENTAL DISABILITIES, THEN THE DECISION SHALL BE GOVERNED BY SUCH STATUTE
51 OR REGULATIONS AND NOT BY THIS ARTICLE.

52 4. IF, AFTER REASONABLE EFFORTS, IT IS DETERMINED THAT A HEALTH CARE
53 DECISION FOR THE PATIENT CANNOT BE MADE PURSUANT TO SUBDIVISION TWO OR
54 THREE OF THIS SECTION, THEN THE HEALTH CARE DECISION SHALL BE MADE
55 PURSUANT TO THIS ARTICLE.

1 S 2994-C. DETERMINATION OF INCAPACITY. 1. PRESUMPTION OF CAPACITY. FOR
2 PURPOSES OF THIS ARTICLE, EVERY ADULT SHALL BE PRESUMED TO HAVE DECI-
3 SION-MAKING CAPACITY UNLESS DETERMINED OTHERWISE PURSUANT TO THIS
4 SECTION OR PURSUANT TO COURT ORDER, OR UNLESS A GUARDIAN IS AUTHORIZED
5 TO DECIDE ABOUT HEALTH CARE FOR THE ADULT PURSUANT TO ARTICLE EIGHTY-ONE
6 OF THE MENTAL HYGIENE LAW.

7 2. INITIAL DETERMINATION BY ATTENDING PHYSICIAN. AN ATTENDING PHYSI-
8 CIAN SHALL MAKE AN INITIAL DETERMINATION THAT AN ADULT PATIENT LACKS
9 DECISION-MAKING CAPACITY TO A REASONABLE DEGREE OF MEDICAL CERTAINTY.
10 SUCH DETERMINATION SHALL INCLUDE AN ASSESSMENT OF THE CAUSE AND EXTENT
11 OF THE PATIENT'S INCAPACITY AND THE LIKELIHOOD THAT THE PATIENT WILL
12 REGAIN DECISION-MAKING CAPACITY.

13 3. CONCURRING DETERMINATIONS. (A) AN INITIAL DETERMINATION THAT A
14 PATIENT LACKS DECISION-MAKING CAPACITY SHALL BE SUBJECT TO A CONCURRING
15 DETERMINATION, INDEPENDENTLY MADE, WHERE REQUIRED BY THIS SUBDIVISION. A
16 CONCURRING DETERMINATION SHALL INCLUDE AN ASSESSMENT OF THE CAUSE AND
17 EXTENT OF THE PATIENT'S INCAPACITY AND THE LIKELIHOOD THAT THE PATIENT
18 WILL REGAIN DECISION-MAKING CAPACITY, AND SHALL BE INCLUDED IN THE
19 PATIENT'S MEDICAL RECORD. HOSPITALS SHALL ADOPT WRITTEN POLICIES IDENTI-
20 FYING THE TRAINING AND CREDENTIALS OF HEALTH OR SOCIAL SERVICES PRACTI-
21 TIONERS QUALIFIED TO PROVIDE CONCURRING DETERMINATIONS OF INCAPACITY.

22 (B) (I) IN A RESIDENTIAL HEALTH CARE FACILITY, A HEALTH OR SOCIAL
23 SERVICES PRACTITIONER EMPLOYED BY OR OTHERWISE FORMALLY AFFILIATED WITH
24 THE FACILITY MUST INDEPENDENTLY DETERMINE WHETHER AN ADULT PATIENT LACKS
25 DECISION-MAKING CAPACITY.

26 (II) IN A GENERAL HOSPITAL A HEALTH OR SOCIAL SERVICES PRACTITIONER
27 EMPLOYED BY OR OTHERWISE FORMALLY AFFILIATED WITH THE FACILITY MUST
28 INDEPENDENTLY DETERMINE WHETHER AN ADULT PATIENT LACKS DECISION-MAKING
29 CAPACITY IF THE SURROGATE'S DECISION CONCERNS THE WITHDRAWAL OR WITH-
30 HOLDING OF LIFE-SUSTAINING TREATMENT.

31 (C) (I) IF THE ATTENDING PHYSICIAN MAKES AN INITIAL DETERMINATION THAT
32 A PATIENT LACKS DECISION-MAKING CAPACITY BECAUSE OF MENTAL ILLNESS,
33 EITHER SUCH PHYSICIAN MUST HAVE THE FOLLOWING QUALIFICATIONS, OR ANOTHER
34 PHYSICIAN WITH THE FOLLOWING QUALIFICATIONS MUST INDEPENDENTLY DETERMINE
35 WHETHER THE PATIENT LACKS DECISION-MAKING CAPACITY: A PHYSICIAN LICENSED
36 TO PRACTICE MEDICINE IN NEW YORK STATE, WHO IS A DIPLOMATE OR ELIGIBLE
37 TO BE CERTIFIED BY THE AMERICAN BOARD OF PSYCHIATRY AND NEUROLOGY OR WHO
38 IS CERTIFIED BY THE AMERICAN OSTEOPATHIC BOARD OF NEUROLOGY AND PSYCHIA-
39 TRY OR IS ELIGIBLE TO BE CERTIFIED BY THAT BOARD. A RECORD OF SUCH
40 CONSULTATION SHALL BE INCLUDED IN THE PATIENT'S MEDICAL RECORD.

41 (II) IF THE ATTENDING PHYSICIAN MAKES AN INITIAL DETERMINATION THAT A
42 PATIENT LACKS DECISION-MAKING CAPACITY BECAUSE OF MENTAL RETARDATION OR
43 A DEVELOPMENTAL DISABILITY, EITHER SUCH PHYSICIAN MUST HAVE THE FOLLOW-
44 ING QUALIFICATIONS, OR ANOTHER PROFESSIONAL WITH THE FOLLOWING QUALI-
45 FICATIONS MUST INDEPENDENTLY DETERMINE WHETHER THE PATIENT LACKS DECI-
46 SION-MAKING CAPACITY: A PHYSICIAN OR CLINICAL PSYCHOLOGIST WHO EITHER IS
47 EMPLOYED BY A SCHOOL NAMED IN SECTION 13.17 OF THE MENTAL HYGIENE LAW,
48 OR WHO HAS BEEN EMPLOYED FOR A MINIMUM OF TWO YEARS TO RENDER CARE AND
49 SERVICE IN A FACILITY OPERATED OR LICENSED BY THE OFFICE OF MENTAL
50 RETARDATION AND DEVELOPMENTAL DISABILITIES, OR WHO HAS BEEN APPROVED BY
51 THE COMMISSIONER OF MENTAL RETARDATION AND DEVELOPMENTAL DISABILITIES IN
52 ACCORDANCE WITH REGULATIONS PROMULGATED BY SUCH COMMISSIONER. SUCH REGU-
53 LATIONS SHALL REQUIRE THAT A PHYSICIAN OR CLINICAL PSYCHOLOGIST POSSESS

(D) IF AN ATTENDING PHYSICIAN HAS DETERMINED THAT THE PATIENT LACKS DECISION-MAKING CAPACITY AND IF THE HEALTH OR SOCIAL SERVICES PRACTITIONER CONSULTED FOR A CONCURRING DETERMINATION DISAGREES WITH THE ATTENDING PHYSICIAN'S DETERMINATION, THE MATTER SHALL BE REFERRED TO THE ETHICS REVIEW COMMITTEE IF IT CANNOT OTHERWISE BE RESOLVED.

4. INFORMING THE PATIENT AND SURROGATE. NOTICE OF A DETERMINATION THAT A SURROGATE WILL MAKE HEALTH CARE DECISIONS BECAUSE THE ADULT PATIENT HAS BEEN DETERMINED TO LACK DECISION-MAKING CAPACITY SHALL PROMPTLY BE GIVEN:

(A) TO THE PATIENT, WHERE THERE IS ANY INDICATION OF THE PATIENT'S ABILITY TO COMPREHEND THE INFORMATION;

(B) TO AT LEAST ONE PERSON ON THE SURROGATE LIST HIGHEST IN ORDER OF PRIORITY LISTED WHEN PERSONS IN PRIOR CLASSES ARE NOT REASONABLY AVAILABLE PURSUANT TO SUBDIVISION ONE OF SECTION TWENTY-NINE HUNDRED NINETY-FOUR-D OF THIS ARTICLE;

(C) IF THE PATIENT WAS TRANSFERRED FROM A MENTAL HYGIENE FACILITY, TO THE DIRECTOR OF THE MENTAL HYGIENE FACILITY AND TO THE MENTAL HYGIENE LEGAL SERVICE UNDER ARTICLE FORTY-SEVEN OF THE MENTAL HYGIENE LAW.

5. LIMITED PURPOSE OF DETERMINATION. A DETERMINATION MADE PURSUANT TO THIS SECTION THAT AN ADULT PATIENT LACKS DECISION-MAKING CAPACITY SHALL NOT BE CONSTRUED AS A FINDING THAT THE PATIENT LACKS CAPACITY FOR ANY OTHER PURPOSE.

6. PRIORITY OF PATIENT'S DECISION. NOTWITHSTANDING A DETERMINATION PURSUANT TO THIS SECTION THAT AN ADULT PATIENT LACKS DECISION-MAKING CAPACITY, IF THE PATIENT OBJECTS TO THE DETERMINATION OF INCAPACITY, OR TO THE CHOICE OF A SURROGATE OR TO A HEALTH CARE DECISION MADE BY A SURROGATE OR MADE PURSUANT TO SECTION TWENTY-NINE HUNDRED NINETY-FOUR-G OF THIS ARTICLE, THE PATIENT'S OBJECTION OR DECISION SHALL PREVAIL UNLESS: (A) A COURT OF COMPETENT JURISDICTION HAS DETERMINED THAT THE PATIENT LACKS DECISION-MAKING CAPACITY OR THE PATIENT IS OR HAS BEEN ADJUDGED INCOMPETENT FOR ALL PURPOSES AND, IN THE CASE OF A PATIENT'S OBJECTION TO TREATMENT, MAKES ANY OTHER FINDING REQUIRED BY LAW TO AUTHORIZE THE TREATMENT, OR (B) ANOTHER LEGAL BASIS EXISTS FOR OVERRIDING THE PATIENT'S DECISION.

7. CONFIRMATION OF CONTINUED LACK OF DECISION-MAKING CAPACITY. AN ATTENDING PHYSICIAN SHALL CONFIRM THE ADULT PATIENT'S CONTINUED LACK OF DECISION-MAKING CAPACITY BEFORE COMPLYING WITH HEALTH CARE DECISIONS MADE PURSUANT TO THIS ARTICLE, OTHER THAN THOSE DECISIONS MADE AT OR ABOUT THE TIME OF THE INITIAL DETERMINATION. A CONCURRING DETERMINATION OF THE PATIENT'S CONTINUED LACK OF DECISION-MAKING CAPACITY SHALL BE REQUIRED IF THE SUBSEQUENT HEALTH CARE DECISION CONCERNS THE WITHHOLDING OR WITHDRAWAL OF LIFE-SUSTAINING TREATMENT. HEALTH CARE PROVIDERS SHALL NOT BE REQUIRED TO INFORM THE PATIENT OR SURROGATE OF THE CONFIRMATION.

S 2994-D. HEALTH CARE DECISIONS FOR ADULT PATIENTS BY SURROGATES. 1. IDENTIFYING THE SURROGATE. ONE PERSON FROM THE FOLLOWING LIST FROM THE CLASS HIGHEST IN PRIORITY WHEN PERSONS IN PRIOR CLASSES ARE NOT REASONABLY AVAILABLE, WILLING, AND COMPETENT TO ACT, SHALL BE THE SURROGATE FOR AN ADULT PATIENT WHO LACKS DECISION-MAKING CAPACITY. (A) A GUARDIAN AUTHORIZED TO DECIDE ABOUT HEALTH CARE PURSUANT TO ARTICLE EIGHTY-ONE OF THE MENTAL HYGIENE LAW;

(B) THE SPOUSE, IF NOT LEGALLY SEPARATED FROM THE PATIENT, OR THE DOMESTIC PARTNER;

(C) A SON OR DAUGHTER EIGHTEEN YEARS OF AGE OR OLDER;

- 1 (D) A PARENT;
2 (E) A BROTHER OR SISTER EIGHTEEN YEARS OF AGE OR OLDER;
3 (F) A CLOSE FRIEND.

4 2. RESTRICTIONS ON WHO MAY BE A SURROGATE. AN OPERATOR, ADMINISTRATOR,
5 OR EMPLOYEE OF A HOSPITAL OR A MENTAL HYGIENE FACILITY FROM WHICH THE
6 PATIENT WAS TRANSFERRED, OR A PHYSICIAN WHO HAS PRIVILEGES AT THE HOSPI-
7 TAL OR A HEALTH CARE PROVIDER UNDER CONTRACT WITH THE HOSPITAL MAY NOT
8 SERVE AS THE SURROGATE FOR ANY ADULT WHO IS A PATIENT OF SUCH HOSPITAL,

18 SURROGATE SHALL HAVE THE AUTHORITY TO MAKE ANY AND ALL HEALTH CARE DECIS-

54 ATTENDING PHYSICIAN OR IN WRITING.

IF A PHYSICIAN CONSULTED FOR A CONCURRING OPINION OBJECTS TO AN ATTENDING PHYSICIAN'S RECOMMENDATION OR DETERMINATION MADE PURSUANT TO THIS SECTION, OR A MEMBER OF THE HOSPITAL STAFF DIRECTLY RESPONSIBLE FOR THE PATIENT'S CARE OBJECTS TO AN ATTENDING PHYSICIAN'S RECOMMENDATION ABOUT MAJOR MEDICAL TREATMENT OR TREATMENT WITHOUT MEDICAL BENEFIT, THE MATTER SHALL BE REFERRED TO THE ETHICS REVIEW COMMITTEE IF IT CANNOT BE OTHERWISE RESOLVED.

S 2994-J. REVOCATION OF CONSENT. 1. A PATIENT, SURROGATE, OR PARENT OR GUARDIAN OF A MINOR PATIENT MAY AT ANY TIME REVOKE HIS OR HER CONSENT TO WITHHOLD OR WITHDRAW LIFE-SUSTAINING TREATMENT BY INFORMING AN ATTENDING PHYSICIAN OR A MEMBER OF THE MEDICAL OR NURSING STAFF OF THE REVOCATION.

2. AN ATTENDING PHYSICIAN INFORMED OF A REVOCATION OF CONSENT MADE PURSUANT TO THIS SECTION SHALL IMMEDIATELY:

(A) RECORD THE REVOCATION IN THE PATIENT'S MEDICAL RECORD;
(B) CANCEL ANY ORDERS IMPLEMENTING THE DECISION TO WITHHOLD OR WITHDRAW TREATMENT; AND

(C) NOTIFY THE HOSPITAL STAFF DIRECTLY RESPONSIBLE FOR THE PATIENT'S CARE OF THE REVOCATION AND ANY CANCELLATIONS.

3. ANY MEMBER OF THE MEDICAL OR NURSING STAFF INFORMED OF A REVOCATION MADE PURSUANT TO THIS SECTION SHALL IMMEDIATELY NOTIFY AN ATTENDING PHYSICIAN OF THE REVOCATION.

S 2994-K. IMPLEMENTATION AND REVIEW OF DECISIONS. 1. HOSPITALS SHALL ADOPT WRITTEN POLICIES REQUIRING IMPLEMENTATION AND REGULAR REVIEW OF DECISIONS TO WITHHOLD OR WITHDREW LIFE-SUSTAINING TREATMENT IN ACCORDANCE WITH ACCEPTED MEDICAL STANDARDS. IF A DECISION TO WITHHOLD OR WITHDRAW LIFE-SUSTAINING TREATMENT HAS BEEN MADE PURSUANT TO THIS ARTICLE, AND AN ATTENDING PHYSICIAN DETERMINES AT ANY TIME THAT THE DECISION IS NO LONGER APPROPRIATE OR AUTHORIZED BECAUSE THE PATIENT HAS REGAINED DECISION-MAKING CAPACITY OR BECAUSE THE PATIENT'S CONDITION HAS OTHERWISE IMPROVED, THE PHYSICIAN SHALL IMMEDIATELY:

(A) INCLUDE SUCH DETERMINATION IN THE PATIENT'S MEDICAL RECORD;
(B) CANCEL ANY ORDERS OR PLANS OF CARE IMPLEMENTING THE DECISION TO WITHHOLD OR WITHDRAW LIFE-SUSTAINING TREATMENT;

(C) NOTIFY THE PERSON WHO MADE THE DECISION TO WITHHOLD OR WITHDRAW TREATMENT, OR, IF THAT PERSON IS NOT REASONABLY AVAILABLE, TO AT LEAST ONE PERSON ON THE SURROGATE LIST HIGHEST IN ORDER OF PRIORITY LISTED WHEN PERSONS IN PRIOR CLASSES ARE NOT REASONABLY AVAILABLE PURSUANT TO SUBDIVISION ONE OF SECTION TWENTY-NINE HUNDRED NINETY-FOUR-D OF THIS ARTICLE; AND

(D) NOTIFY THE HOSPITAL STAFF DIRECTLY RESPONSIBLE FOR THE PATIENT'S CARE OF ANY CANCELLED ORDERS OR PLANS OF CARE.

S 2994-L. INTERINSTITUTIONAL TRANSFERS. IF A PATIENT WITH AN ORDER TO WITHHOLD OR WITHDRAW LIFE-SUSTAINING TREATMENT IS TRANSFERRED FROM A MENTAL HYGIENE FACILITY TO A HOSPITAL OR FROM A HOSPITAL TO A DIFFERENT HOSPITAL, ANY SUCH ORDER OR PLAN SHALL REMAIN EFFECTIVE UNTIL AN ATTEND-

1 ING PHYSICIAN FIRST EXAMINES THE TRANSFERRED PATIENT, WHEREUPON AN
2 ATTENDING PHYSICIAN MUST EITHER:

3 1. ISSUE APPROPRIATE ORDERS TO CONTINUE THE PRIOR ORDER OR PLAN. SUCH
4 ORDERS MAY BE ISSUED WITHOUT OBTAINING ANOTHER CONSENT TO WITHHOLD OR
5 WITHDRAW LIFE-SUSTAINING TREATMENT PURSUANT TO THIS ARTICLE; OR

26 (B) THE ETHICS REVIEW COMMITTEE RESPONSE TO A HEALTH CARE MATTER MAY
27 INCLUDE:

28 (I) PROVIDING ADVICE ON THE ETHICAL ASPECTS OF PROPOSED HEALTH CARE;

29 (II) MAKING A RECOMMENDATION ABOUT PROPOSED HEALTH CARE; OR

30 (III) PROVIDING ASSISTANCE IN RESOLVING DISPUTES ABOUT PROPOSED HEALTH
31 CARE.

32 (C) RECOMMENDATIONS AND ADVICE BY THE ETHICS REVIEW COMMITTEE SHALL BE
33 ADVISORY AND NONBINDING, EXCEPT AS SPECIFIED IN SUBDIVISION FIVE OF
34 SECTION TWENTY-NINE HUNDRED NINETY-FOUR-D OF THIS ARTICLE AND SUBDIVI-
35 SION THREE OF SECTION TWENTY-NINE HUNDRED NINETY-FOUR-E OF THIS ARTICLE.

36 3. COMMITTEE MEMBERSHIP. THE MEMBERSHIP OF ETHICS REVIEW COMMITTEES
37 MUST BE INTERDISCIPLINARY AND MUST INCLUDE AT LEAST FIVE MEMBERS WHO
38 HAVE DEMONSTRATED AN INTEREST IN OR COMMITMENT TO PATIENT'S RIGHTS OR TO

4 HUNDRED NINETY-FOUR-D OF THIS ARTICLE; OR (C) AN EMANCIPATED MINOR
5 PATIENT PURSUANT TO SUBDIVISION THREE OF SECTION TWENTY-NINE HUNDRED
6 NINETY-FOUR-E OF THIS ARTICLE; OR (II) WHEN A PERSON CONNECTED WITH THE

14 (II) THE ETHICS REVIEW COMMITTEE SHALL RESPOND PROMPTLY, AS REQUIRED
15 BY THE CIRCUMSTANCES, TO ANY REQUEST FOR ASSISTANCE IN RESOLVING A
16 DISPUTE OR CONSIDERATION OF A DECISION TO WITHHOLD OR WITHDRAW LIFE-SUS-

43 be denied any rights of visitation of his or her domestic partner OR OF

8 any such physician may act as the attending physician pursuant to this

46 (C) IS DEPENDENT OR MUTUALLY INTERDEPENDENT ON THE OTHER PERSON FOR

48 MUTUAL INTENT TO BE DOMESTIC PARTNERS INCLUDING BUT NOT LIMITED TO:

1 PURPOSES OF THIS SECTION, "LIFE-SUSTAINING TREATMENT" MEANS MEDICAL
2 TREATMENT, INCLUDING CARDIOPULMONARY RESUSCITATION AND NUTRITION AND
3 HYDRATION PROVIDED BY MEANS OF MEDICAL TREATMENT, WHICH IS SUSTAINING
4 LIFE FUNCTIONS AND WITHOUT WHICH, ACCORDING TO REASONABLE MEDICAL JUDG-
5 MENT, THE PATIENT WILL DIE WITHIN A RELATIVELY SHORT TIME PERIOD.
6 CARDIOPULMONARY RESUSCITATION IS PRESUMED TO BE LIFE-SUSTAINING TREAT-
7 MENT WITHOUT THE NECESSITY OF A MEDICAL JUDGMENT BY AN ATTENDING PHYSI-
8 CIAN. The provisions of this article are not intended to permit or
9 promote suicide, assisted suicide or euthanasia; accordingly, nothing in
10 this section shall be construed to permit a guardian to consent to any
11 act or omission to which the mentally retarded person could not consent
12 if such person had capacity.

13 (a) For the purposes of making a decision to withhold or withdraw
14 life-sustaining treatment pursuant to this section, in the case of a
15 person for whom no guardian has been appointed pursuant to section
16 seventeen hundred fifty or seventeen hundred fifty-a of this article, a
17 "guardian" shall also mean a family member of a person who (i) has
18 mental retardation, or (ii) has a developmental disability, as defined
19 in section 1.03 of the mental hygiene law, which (A) includes mental
20 retardation, or (B) results in a similar impairment of general intellec-
21 tual functioning or adaptive behavior so that such person is incapable
22 of managing himself or herself, and/or his or her affairs by reason of
23 such developmental disability. Qualified family members shall be
24 included in a prioritized list OF SAID FAMILY MEMBERS pursuant to regu-
25 lations established by the commissioner of mental retardation and devel-
26 opmental disabilities. Such family members must have a significant and
27 ongoing involvement in a person's life so as to have sufficient knowl-
28 edge of their needs and, when reasonably known or ascertainable, the
29 person's wishes, including moral and religious beliefs. IN THE CASE OF
30 A PERSON WHO WAS A RESIDENT OF THE FORMER WILLOWBROOK STATE SCHOOL ON
31 MARCH SEVENTEENTH, NINETEEN HUNDRED SEVENTY-TWO AND THOSE INDIVIDUALS
32 WHO WERE IN COMMUNITY CARE STATUS ON THAT DATE AND SUBSEQUENTLY RETURNED
33 TO WILLOWBROOK OR A RELATED FACILITY, WHO ARE FULLY REPRESENTED BY THE
34 CONSUMER ADVISORY BOARD AND WHO HAVE NO GUARDIANS APPOINTED PURSUANT TO
35 THIS ARTICLE OR HAVE NO QUALIFIED FAMILY MEMBERS TO MAKE SUCH A DECI-
36 SION, THEN A "GUARDIAN" SHALL ALSO MEAN THE WILLOWBROOK CONSUMER ADVI-
37 SORY BOARD. A decision of such family member OR THE WILLOWBROOK CONSUMER
38 ADVISORY BOARD to withhold or withdraw life-sustaining treatment shall
39 be subject to all of the protections, procedures and safeguards which
40 apply to the decision of a guardian to withhold or withdraw life-sus-
41 taining treatment pursuant to this section.

42 In the case of a person for whom no guardian has been appointed pursu-
43 ant to this article or for whom there is no qualified family member OR
44 THE WILLOWBROOK CONSUMER ADVISORY BOARD available to make such a deci-
45 sion, a "guardian" shall also mean, notwithstanding the definitions in
46 section 80.03 of the mental hygiene law, a surrogate decision-making
47 committee, as defined in article eighty of the mental hygiene law. All
48 declarations and procedures, including expedited procedures, to comply
49 with this section shall be established by regulations promulgated by the
50 commission on quality of care and advocacy for persons with disabili-
51 ties.

52 (b) Regulations establishing the prioritized list OF QUALIFIED FAMILY
53 MEMBERS required by paragraph (a) of this subdivision shall be developed
54 by the commissioner of mental retardation and developmental disabilities
55 in conjunction with parents, advocates and family members of persons who
56 are mentally retarded. REGULATIONS TO IMPLEMENT THE AUTHORITY OF THE

1 WILLOWBROOK CONSUMER ADVISORY BOARD PURSUANT TO PARAGRAPH (A) OF THIS
2 SUBDIVISION MAY BE PROMULGATED BY THE COMMISSIONER OF THE OFFICE OF
3 MENTAL RETARDATION AND DEVELOPMENTAL DISABILITIES WITH ADVICE FROM THE
4 WILLOWBROOK CONSUMER ADVISORY BOARD.

5 The guardian shall have the affirmative obligation to advocate for the
6 full and efficacious provision of health care, including life-sustaining
7 treatment [as defined in subdivision (e) of section 81.29 of the mental
8 hygiene law]. In the event that a guardian makes a decision to withdraw
9 or withhold life-sustaining treatment from a mentally retarded person:

10 S 28. Issues to be considered by the task force on life and the law;
11 special advisory committee. The New York state task force on life and
12 the law (referred to in this section as the "task force"), a body
13 created by executive order number 56 (issued December 20, 1984), shall
14 consider and make regulatory and statutory recommendations relating to
15 the family health care decisions act (article 29-CC of the public health
16 law, referred to in this section as the "FHCD"), including the follow-
17 ing:

18 1. The task force shall consider whether the FHCD should be amended
19 to incorporate procedures, standards and practices for decisions about
20 the withdrawal or withholding of life-sustaining treatment from patients
21 with mental illness or mental retardation or developmental disabilities,
22 and from patients residing in mental health facilities. The task force
23 shall form a special advisory committee to advise the task force in its
24 work under this subdivision. The special advisory committee shall
25 consist of six task force members, selected by the chair of the task
26 force, three persons selected by the commissioner of the office of
27 mental health, and three persons selected by the commissioner of the
28 office of mental retardation and developmental disabilities. The special
29 advisory committee shall solicit comments from a broader range of inter-
30 ested persons.

31 2. The task force shall consider whether the FHCD should be amended
32 to apply to health care decisions in settings other than general hospi-
33 tals and residential health care facilities.

34 S 29. This act shall take effect immediately; provided that sections
35 one through twenty-six of this act shall take effect on the first of
36 June next succeeding the date on which this act shall have become a law;
37 and provided further that effective immediately it shall be lawful for a
38 hospital, as defined in subdivision 18 of section 2994-a of the public
39 health law, as added by this act to adopt a policy that is consistent
40 with the requirements of article 29-CC of the public health law as added
41 by section two of this act or the mental hygiene law as amended by
42 sections twenty-five and twenty-six of this act and for a health care
43 provider to accept and carry out a health care decision in accordance
44 with such requirements for a patient in a hospital that has adopted such
45 policy.
