AN ACT to amend the education law, in relation to requiring tax levy information and percentage increase to be sent to all voters

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Paragraph a of subdivision 2-a of section 2022 the education law, as added by section 3 of part A of chapter 60 of the laws of 2000, is amended to read as follows:

- Commencing with the proposed budget for the two thousand one--two thousand two school year, such notice shall also include a description how total spending and the tax levy, AND, COMMENCING WITH THE PROPOSED BUDGET FOR THE TWO THOUSAND NINE--TWO THOUSAND TEN SCHOOL YEAR, THE PERCENTAGE INCREASE OR DECREASE IN THE TAX LEVY resulting proposed budget would compare with a projected contingency budget adopted pursuant to section two thousand twenty-three of this article, assuming that such contingency budget is adopted on the same day as the vote on the proposed budget. Such comparison shall be in total and by component (program, capital and administrative), and shall include a statement of the assumptions made in estimating the projected contingency budget.
- S 2. Section 1716 of the education law is amended by adding subdivisions 8 and 9 to read as follows:
- 8. COMMENCING WITH THE PROPOSED BUDGET FOR THE TWO THOUSAND NINE--TWO THOUSAND TEN SCHOOL YEAR, THE PROPERTY TAX REPORT CARD SHALL BE MAILED ALL OUALIFIED VOTERS OF THE SCHOOL DISTRICT AFTER THE DATE OF THE BUDGET HEARING, BUT NO LATER THAN SIX DAYS PRIOR TO THE ANNUAL MEETING ELECTION OR SPECIAL DISTRICT MEETING AT WHICH A SCHOOL BUDGET VOTE WILL OCCUR.

- S 3. Section 1608 of the education law is amended by adding two new subdivisions 8 and 9 to read as follows:
- 8. COMMENCING WITH THE PROPOSED BUDGET FOR THE TWO THOUSAND NINE--TWO THOUSAND TEN SCHOOL YEAR, THE PROPERTY TAX REPORT CARD SHALL BE MAILED TO ALL QUALIFIED VOTERS OF THE SCHOOL DISTRICT AFTER THE DATE OF THE BUDGET HEARING, BUT NO LATER THAN SIX DAYS PRIOR TO THE ANNUAL MEETING AND ELECTION OR SPECIAL DISTRICT MEETING AT WHICH A SCHOOL BUDGET VOTE WILL OCCUR.
- 9. COMMENCING WITH THE PROPOSED BUDGET FOR THE TWO THOUSAND NINE--TWO THOUSAND TEN SCHOOL YEAR, ALL DOCUMENTS PREPARED BY THE BOARD OF EDUCATION AND/OR SCHOOL DISTRICT THAT INFORM THE PUBLIC, WHETHER BY ELECTRONIC, HARDCOPY, OR OTHER MEANS, ABOUT PROPOSED TAX RATE INCREASES OR DECREASES, AND/OR PERCENTAGE INCREASES OR DECREASES, RESULTING FROM A PROPOSED BUDGET, SHALL INCLUDE THE PROPOSED BUDGET INCREASE OR DECREASE, AND PERCENTAGE INCREASE, AND THE PROPOSED TAX LEVY INCREASE OR DECREASE, AND PERCENTAGE INCREASE OR DECREASE, ON THE SAME PAGE, AND IN THE SAME FONT STYLE AND SIZE, AS THE PROPOSED TAX RATE CHANGE.
- S 4. This act shall take effect on the first of July next succeeding the date on which it shall have become a law; provided, however, that effective immediately, the addition, amendment and/or repeal of any rule or regulation necessary for the implementation of this act on its effective date are authorized and directed to be made and completed on or before such effective date.
