AN ACT to amend the penal law and the vehicle and traffic law, in relation to bias-related graffiti

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 240.31 of the penal law is amended by adding a new 2 subdivision 1-a to read as follows:

3 1-A. ETCHES, PAINTS, COVERS, DRAWS UPON OR OTHERWISE PLACES A MARK 4 UPON PUBLIC OR PRIVATE PROPERTY; OR

5 S 2. The penal law is amended by adding a new section 60.31 to read as 6 follows:

7 S 60.31 AUTHORIZED DISPOSITION; AGGRAVATED HARASSMENT IN THE FIRST 8 DEGREE.

9 WHEN A PERSON IS CONVICTED OF AN OFFENSE DEFINED IN SUBDIVISION ONE-A OF SECTION 240.31 OF THIS CHAPTER, OR OF AN ATTEMPT TO COMMIT 10 SUCH AN OFFENSE, OR OF A LESSER INCLUDED OFFENSE, IN ADDITION TO ANY OTHER 11 SENTENCE IMPOSED OR AS A CONDITION OF PROBATION OR 12 CONDITIONAL DISCHARGE: (1) THE COURT MAY ORDER SUCH PERSON TO PARTICIPATE IN, AT HIS 13 EXPENSE, A DIVERSITY TRAINING PROGRAM THAT IS DESIGNED TO OVERCOME 14 OWN DISCRIMINATION, PREJUDICE AND INTOLERANCE, AND THAT PROMOTES 15 COMMUNI-UNDERSTANDING AND RESPECT AMONG DIVERSE RACIAL, RELIGIOUS AND 16 CATION, 17 ETHNIC GROUPS AND/OR (2) MAY SUSPEND SUCH INDIVIDUAL'S DRIVER'S LICENSE PRIVILEGE TO DRIVE IN THIS STATE FOR A PERIOD OF UP TO ONE YEAR, OR, 18 OR 19 IN THE EVENT SUCH INDIVIDUAL DOES NOT HAVE A DRIVER'S LICENSE, THE COURT 20 MAY DELAY THE GRANTING OF A DRIVER'S LICENSE FOR A PERIOD OF UP TO ONE 21 YEAR.

22 S 3. Section 502 of the vehicle and traffic law is amended by adding a 23 new subdivision 8 to read as follows:

24 8. EXCEPTIONS. NOTWITHSTANDING ANY OTHER PROVISION OF THIS SECTION, 25 THE COMMISSIONER SHALL NOT ISSUE A DRIVER'S LICENSE TO ANY PERSON

1 CONVICTED OF AN OFFENSE DEFINED IN SUBDIVISION ONE-A OF SECTION 240.31 2 OF THE PENAL LAW, OR OF AN ATTEMPT TO COMMIT SUCH AN OFFENSE, OR OF A 3 LESSER INCLUDED OFFENSE, UNTIL SUCH TIME AS IMPOSED BY THE SENTENCING 4 COURT HAS LAPSED.

5 S 4. Subdivision 3 of section 510 of the vehicle and traffic law is 6 amended by adding a new paragraph j-1 to read as follows:

J-1. FOR A PERIOD UP TO ONE YEAR WHERE THE HOLDER HAS BEEN CONVICTED 8 OF AN OFFENSE DEFINED IN SUBDIVISION ONE-A OF SECTION 240.31 OF THE 9 PENAL LAW;

10 S 5. This act shall take effect on the first of November next succeed-11 ing the date on which it shall have become a law.
