AN ACT to amend the education law, in relation to an exemption for behavior analysis

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The education law is amended by adding a new section 7601-b
2 to read as follows:
3 S 7601-B. DEFINITION OF BEHAVIOR ANALYSIS. BEHAVIOR ANALYSIS IS
4 DEFINED AS THE DESIGN, IMPLEMENTATION, AND EVALUATION OF SYSTEMATIC
5 ENVIRONMENTAL MODIFICATIONS FOR THE PURPOSE OF PRODUCING SOCIALLY
6 SIGNIFICANT IMPROVEMENTS IN THE UNDERSTANDING OF HUMAN BEHAVIOR IDENTI-
7 FIED THROUGH THE EXPERIMENTAL ANALYSIS OF BEHAVIOR. IT INCLUDES THE
8 IDENTIFICATION OF FUNCTIONAL RELATIONSHIPS BETWEEN BEHAVIOR AND ENVIRON-
9 MENTS. IT USES DIRECT OBSERVATION AND MEASUREMENT OF BEHAVIOR AND ENVI-
10 RONMENT. CONTEXTUAL FACTORS, ESTABLISHING OPERATIONS, ANTECEDENT STIMU-
11 LI, POSITIVE REINFORCERS, AND OTHER CONSEQUENCES ARE USED, BASED ON
12 IDENTIFIED FUNCTIONAL RELATIONSHIPS WITH THE ENVIRONMENT, IN ORDER TO
13 PRODUCE PRACTICAL BEHAVIOR CHANGE. BEHAVIOR ANALYSIS DOES NOT RELY ON
14 COGNITIVE THERAPIES AND EXPRESSLY EXCLUDES PSYCHOLOGICAL TESTING,
15 NEUROPSYCHOLOGY, PSYCHOTHERAPY, SEX THERAPY, PSYCHOANALYSIS, HYPNOTHERA-
16 PY AND LONG TERM COUNSELING AS TREATMENT MODALITIES.
17 S 2. Section 7605 of the education law is amended by adding a new
18 subdivision 9 to read as follows:
19 9. THE PRACTICE, CONDUCT, ACTIVITIES, OR SERVICES OF AN INDIVIDUAL WHO
20 SOLELY ENGAGES IN BEHAVIOR ANALYSIS, AS DEFINED BY THIS CHAPTER,
21 PROVIDED THE INDIVIDUAL IS A BOARD CERTIFIED BEHAVIOR ANALYST AND HE OR
22 SHE DOES NOT HOLD HIMSELF OR HERSELF OUT TO THE PUBLIC AS POSSESSING A
23 LICENSE ISSUED PURSUANT TO THIS ARTICLE OR ARTICLE ONE HUNDRED
24 SIXTY-THREE OF THIS TITLE OR USE A TITLE DESCRIPTION PROTECTED BY EITHER
25 THIS ARTICLE OR ARTICLE ONE HUNDRED SIXTY-THREE OF THIS TITLE.

1 S 3. Section 8410 of the education law is amended by adding a new
2 subdivision 7 to read as follows:

3 7. PROHIBIT OR LIMIT A BOARD CERTIFIED BEHAVIOR ANALYST FROM PERFORM-
4 ING WORK CONSISTENT WITH SECTION SEVENTY-SIX HUNDRED ONE-B OF THIS
5 TITLE, PROVIDED HE OR SHE DOES NOT HOLD HIMSELF OR HERSELF OUT TO THE
6 PUBLIC AS POSSESSING A LICENSE ISSUED PURSUANT TO THIS ARTICLE OR USE
7 THE TITLES "LICENSED MENTAL HEALTH COUNSELOR", "LICENSED MARRIAGE AND
8 FAMILY THERAPIST", "LICENSED CREATIVE ARTS THERAPIST", OR "LICENSED
9 PSYCHOANALYST", UNLESS LICENSED UNDER THIS ARTICLE.

10 S 4. This act shall take effect on the first of January next succeed-
11 ing the date on which it shall have become a law. Effective immediately
12 the department of education is authorized to promulgate any and all
13 rules and regulations to implement the requirements of this act.
