AN ACT to amend the personal property law, in relation to requiring a
visual inspection of a leased vehicle

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 1 of section 343 of the personal property law
2 is amended by adding a new paragraph (c) to read as follows:

3 (C) (I) UPON TERMINATION OF A RETAIL LEASE AGREEMENT AND UPON PHYSICAL
4 POSSESSION OF THE LEASED VEHICLE BY THE HOLDER OR ITS AGENTS, THE HOLDER
5 OR AN AGENT THEREOF SHALL COMPLETE A VISUAL INSPECTION OF THE VEHICLE'S
6 CONDITION WHILE IN THE LESSEE'S PRESENCE.

7 THE VISUAL INSPECTION SHALL COVER BUT NOT BE LIMITED TO THE EXTERIOR
8 BODY OF THE VEHICLE, THE INTERIOR OF THE VEHICLE AND THE VEHICLE'S
9 TIRES. THE VISUAL INSPECTION FORM SHALL BE SIGNED BY THE HOLDER OR AN
10 AGENT THEREOF AND A COPY SHALL BE IMMEDIATELY SUPPLIED TO THE LESSEE.

11 THE VISUAL INSPECTION SHALL NOT IMPAIR THE RIGHTS OF THE HOLDER TO
12 OBTAIN A WRITTEN ITEMIZED APPRAISAL OF EXCESSIVE WEAR AND DAMAGE TO THE
13 VEHICLE PURSUANT TO PARAGRAPH (C) OF SUBDIVISION TWO OF THIS SECTION.

14 (II) UPON COMMENCEMENT OF THE VISUAL INSPECTION A NOTICE CONSISTING OF
15 THE FOLLOWING STATEMENT WRITTEN OR PRINTED IN AT LEAST TEN-POINT BOLD
16 TYPE ON A SEPARATE DOCUMENT FROM THE VISUAL INSPECTION FORM SHALL BE
17 SUPPLIED TO THE LESSEE:

18 "THIS VISUAL INSPECTION OF THE VEHICLE'S CONDITION IS INTENDED TO MAKE
19 YOU AWARE OF ANY VISIBLE DAMAGE FOR WHICH A CHARGE FOR EXCESSIVE WEAR
20 AND DAMAGE MAY BE CLAIMED BY THE HOLDER AND TO PROTECT YOU FROM BEING
21 HELD RESPONSIBLE FOR ANY DAMAGE THAT MAY OCCUR WHILE THE HOLDER OR ITS
22 AGENT IS IN PHYSICAL POSSESSION OF THE VEHICLE. PLEASE NOTE THAT THE
23 HOLDER'S ITEMIZED APPRAISAL, WHICH IS PART OF A SEPARATE PROCESS FROM
24 THIS VISUAL INSPECTION, MAY UNCOVER WEAR AND DAMAGE THAT IS NOT DOCU-
